Name of work:

“Drilling, Construction of Approx. 138 Nos. Piezometers with Supply, Installation and Commissioning of 138 Nos. Digital Water Level Recorder (DWLR) along with Supply, Installation and Commissioning of 43 Nos. Digital Water Level Recorder (DWLR) in existing Piezometers under FMDA Area”

Under Clause No. 1.2 EQR Point 1.2.6 Similar Nature of Work Shall be Read as

The bidder must have experience of having successfully completed similar works for any Central Government/State Government/PSU/Other Government department during last seven (7) years ending last day of month previous to the one in which applications are invited should be either of the following:

- (a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost each.
or,
- (b) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost each.
or,
- (c) One similar completed work costing not less than the amount equal to 80% of the estimated cost each.

The value of the executed work shall be brought to the current costing level by enhancing the actual value of works at simple rate of 7% per annum, calculated from the date of completion to the date of Bid opening.

“Certificate for ‘substantial completion’ of project/work/asset should contain two parts. Part-I shall contain ‘financial value of work done’ and part-II shall contain ‘certificate of functional completion of project/work/asset’.”

Equipment and Managerial Capability:

- a) Ownership/ Proposals for the timely acquisition (own, lease, hire, etc.) of the essential equipment listed in the BDS;
- b) A Contract Manager with five years’ experience in Services of an equivalent nature and volume, including no less than three years as Manager;

Defination of Similar Work

For Construction of Piezometers:

Similar Nature of Work: “Drilling & Construction of Wells for Groundwater Development/ Monitoring”.

For Digital Water Level Recorder (DWLR):

For component of supply, installation and commissioning of Digital Water Level Recorder, Bidder may associate with original manufacturer or authorized agent of original manufacturer. In case of authorized agent, an authorization letter from original manufacturer shall be submitted along with bid.

Under Clause No. 56 GCC Point II in Payment Terms for Supply, Installation, Commissioning & Maintenance of DWLR Shall Be Read As

- ii) 60% of the Contract Price excluding cost for item Sr. No. 6 and excluding GST Price and Completion Schedule - Related Services but including replacement of parts if any and seamless data communication, here onwards referred as maintenance charges over the balance 05(five) years (5 years of warranty period) shall be paid as per follows;
 - 12% per Year to be paid on Half Yearly basis (6% at every six month) inclusive of GST payable on Supply of related services. The Conditions (applicable for this payment) shall be governed by Annexure I: Service Level Conditions.
