## **2. INSTRUCTIONS TO BIDDER**

2.1 The tender shall be submitted in two parts:

Part I : Technical Proposal **(To be submitted Online and Offline)**  
Part II : Financial Proposal **(To be submitted online only)**

2.2 Submission of a tender by a tenderer implies that the tenderer has read this notice and all other Tender Documents and has made himself aware of the scope, the specifications, conditions of contract, local conditions and other factors having bearings on the execution of the work.

2.3 WAPCOS Limited desires that the bidders, suppliers, and Sub-contractors under the Project, observe the highest standard of ethics during the performance, procurement and execution of such contracts. In pursuance of this requirement, WAPCOS Limited defines, for the purposes of this provision, the terms set forth below:

- i. "Corrupt Practice" means the offering, giving, receiving, or soliciting, directly or indirectly, anything of value to influence improperly the actions of another party;
- ii. "Fraudulent Practice" means any act of submission of forged documentation, or omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain a financial or other benefit or to avoid an obligation, or to succeed in a competitive bidding process;
- iii. "Coercive Practice" means impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;
- iv. "Collusive Practice" means an arrangement between two or more parties designed to achieve an improper purpose, including influencing improperly the actions of another party.

Will reject the award of Contract, even at a later stage, if it determines that the bidder recommended/ selected for award/awarded has, directly or through an agent, engaged in Corrupt, Fraudulent, Collusive, Or Coercive Practices in competing for the Contract;

## SELECTION AND QUALIFYING CRITERIA

### 1. QUALIFYING CRITERIA

1.1 The bidder should be an Indian Registered Company under Companies Act 1956/ 2013/Registered Proprietorship Firm/ Registered Partnership Firm.

### 1.2 Technical Capacity:

- (i) **Similar works means carrying out Hydrographic/Bathymetry and Topographic survey.**
- (ii) The bidder should have satisfactorily completed the following works in the last 7 years ending previous day of the last day of submission of the bids:
- a) Three similar\* completed works costing not less than the **40%** of estimated cost during last 7 years.
- or**
- b) Two similar\* completed works costing not less than **50%** of estimated cost during last 7 years.
- or**
- c) One similar\* completed work costing not less than **80%** of estimated cost during last 7 years.
- (iii) The past experience in similar nature of work should be supported by Completion Certificate(s) and LOI(s)/ Work Order(s) from respective Owner(s)/ Client(s).

### 1.3 Financial Capacity:

- (i) **Turnover:** Average annual financial turnover of the firm should be at least **50% of the estimated cost of work** during the immediate last 3 consecutive financial years ending 2024-25. This should be duly audited by the Chartered Accountant.

**UDIN OF THE CERTIFICATE FROM THE CHARTERED ACCOUNTANT SHOULD BE MENTIONED.**

Annual turnover certificate without UDIN will not be considered and the bid of the bidder may be rejected.

- (ii) **Solvency:** The bidder should not be insolvent, in receivership, bankrupt or being wound up, not have had their business activities suspended. **GENERAL CONDITIONS OF CONTRACT**

## GENERAL CONDITIONS OF CONTRACT

1. The bidder shall make their own arrangement for boarding, lodging, travel, transportation equipment, labourers, local transport, insurance etc. required for this work and shall include cost in their offer till the completion of project in all respect.
2. WAPCOS at its discretion may alter the quantum of work specified in the BOQ.
3. Time is the essence of the contract.
4. **Liquidated Damages:** If the Firm fail to complete the work under contract by the stipulated date/ extended date, the Firms shall pay penalty at the rate of 0.1 percentage of the contract value per calendar day for the respective project, from the date of delaying the said work up to the date of completion and handing over to the Government. The penalty shall be maximum 10% of the contract value for the work. This clause will not be applicable to the consultant for delays caused by reasons beyond the control of the firm.
5. The tender will be awarded to the bidder whose price will be the lowest overall **i.e. L1 Bidder.**
6. The successful bidder has to commence the work (including mobilization) within 3 days from the LOA by WAPCOS Limited.
7. **Permission/ Authorization:** It shall be the responsibility of the consultant to seek and obtain, well in time, necessary permission of authorization from concerned local or other offices and/ or individual property owners etc. to approach, enter, measure, level, place instruments and equipment etc. as may be required to carry out the assignment. However, necessary authorization and assistance in getting permission may be extended by WAPCOS at its discretion.
8. **Supervision:** The consultant shall provide at all times access to and facilitate inspection and supervision of the works and records for the authorized personnel of WAPCOS.
9. **Responsibilities of the Consultant:** The consultant shall be solely responsible for following sound technical and other methods and practices, accuracy of the equipment, and field work. The contractor will be held responsible for any defect/ delay in the project.
10. **Data Collection:** Data required for carrying out the scope of work shall be collected by the consultant.
11. Incomplete tender or tender received after the last date shall not be considered under any circumstances.
12. WAPCOS shall possess all rights to terminate the work order of the firm if the job/ work carried out by the firm is found unsatisfactory.
13. **Insurance:** The Bidder shall insure himself against any liability under any workmen compensation ordinance or equivalent prevailing legislation and any modifications thereof, which may be put in force by the government during the continuance of the contract.

In the event of any loss or damage suffered in consequence of any accident or injury or disease resulting from his work to any workman or other person in the employment of the Bidder, the Bidder shall pay compensation to the victims.

14. **Performance Security:** The Bidder, whose tender is accepted, will be required to furnish performance guarantee of **3% (Three Percent) of the Contract amount / Work order**. This guarantee shall either be in the form of Banker's Cheque/ Demand Draft/ Bank Guarantee/ Fixed Deposit Receipt from a scheduled commercial bank/ Nationalized Bank payable at New Delhi/ Gurugram. This shall be returned after successful completion of the project.
15. **Security Deposit:** The security deposit shall be collected from the running bills of the bidder at the rate of 2.0% of the gross amount of each running and final bill.
16. **Variation:** It may be noted that while the estimated quantities of work given in the schedule has been estimated as realistically as possible, but any variation in the quantities arising may be incorporated, upon approval of Engineer in charge of WAPCOS Limited, at the same rate quoted by the bidder in the Price Schedule during tendering process.
18. **Financial Conditions**
  - 18.1 The payment shall be made as per actual Milestones at the rates accepted by WAPCOS.
  - 18.2 **TERMS OF PAYMENT :**

As per Section V.
  - 18.3 **Payment will be made to the successful firm on back to back basis i.e. after receipt of payment to WAPCOS Limited from the client. Consultant will have no right for interest on payment if delayed.**
  - 18.4 The bidder acknowledges that under the current contract WAPCOS is only working as intermediately between the Client and the Bidder. Thus, the Bidder unconditionally acknowledges that the payments under the present contract shall be made proportionately by WAPCOS only on back to back basis upon invoice, as per the actual work done by the agency, within 21 days subject to the receipt of the payment installments by WAPCOS from respective Client of the Project. Further, Bidder shall unconditionally agree that in the event of payment or part thereof, under the respective project is not received from the Client, then WAPCOS or any of its Employee/Official shall not be responsible to pay any amount Bidder. The said condition shall supersede any and all other conditions of Contract/ Agreement/ Work Order/ Arrangement between the parties.
19. In no case subletting of the full or part of the work shall be allowed after submitting the bid. However in special cases subletting may be permitted by EIC at his discretion, for which the consultant shall inform him well in advance for approval. If any such case of subletting without approval comes to the notice of WAPCOS, NO PAYMENT FOR THAT PART OF THE WORK SHALL BE MADE.
20. The Consultant shall be solely responsible for safety of his workmen and to provide them adequate necessary equipment etc. and shall ensure to have all his workmen properly covered under the Standard and Registered Insurance company policies for any injuries, losses etc. to his workmen. WAPCOS shall not be liable for any injury or loss

of life of the Contractor's personnel. The Contractor shall ensure to provide required transport uniform, safety shoes and safety gadgets facilities to his workmen. If the Contractor fails to supply any safety equipment etc. to his workmen he shall be solely responsible and liable at all times.

21. **Blacklisting:** The blacklisting policy of the company is available on official website of WAPCOS Limited. The bidder/ tenderer/ consultant/ contractors have to mandatorily furnish an undertaking addressing the same to Engineer-in-Charge in the form of certificate to abide the contents of blacklisting policy. The format of undertaking is provided at **Form XI**. Any action in violation of the Blacklisting policy or to the certificate furnished shall result in cancellation of tender at the stage before or after the award of work.

22. **Arbitration:**

## **1. GOVERNING LAW, JURISDICTION & WAIVER OF ALTERNATIVE REMEDIES - CLAUSE 1**

1.1. **Governing Law:** This Contract shall be governed and interpreted strictly in accordance with the laws of India. No foreign law, conflict-of-laws principle, or external rule shall apply, unless expressly mandated by a funding agency and separately approved in writing by the Competent Authority.

1.2. **Exclusive Jurisdiction:** Subject to prior exhaustion of the internal dispute-resolution tiers stipulated in this Contract, the Parties agree that all suits, actions, or proceedings arising out of or in connection with this Contract, including its formation, validity, performance, breach, or termination, shall be instituted exclusively before the competent civil courts at Delhi, being the place where the Company's Registered Office is situated, to the exclusion of all other courts. The Parties irrevocably waive any objection relating to forum non conveniens, place of suing, or inconvenience.

1.3. **Exclusion of arbitration & consensual ADR:** The Parties unequivocally agree that no dispute shall be referred to arbitration, conciliation, expert determination, Dispute Review Board, or any other form of consensual alternative dispute resolution, except where statutorily mandated (e.g., MSMED Act). This exclusion is without prejudice to the mandatory pre-litigation mediation process stipulated in Clause 2.3 below.

1.4. **The parties expressly agree** that there is no arbitration agreement between them and they irrevocably waive any right to invoke arbitration under the Arbitration and Conciliation Act, 1996 or to constitute an arbitral tribunal in any manner whatsoever.

## **2. STRUCTURED INTERNAL DISPUTE RESOLUTION MECHANISM (SIDRM)**

### **2.1. Tier-I: Dispute resolution by Engineer-in-Charge (EIC)**

2.1.1. **Notice of Dispute:** Any Dispute must be notified in writing to the EIC within 21 days from the date on which the aggrieved Party became, or ought reasonably to have become, aware of the event giving rise to the Dispute.

2.1.2. **Contents of Notice:** The notice shall contain (i) complete facts and chronology; (ii) precise contractual clauses invoked; (iii) a quantified claim with calculations; and (iv) full supporting records such as drawings, DPRs, MBs, photographs, test results,

correspondence, and site registers. Vague, omnibus, or un-particularised notices shall be summarily rejected without prejudice to W APCOS.

2.1.3. EIC's Decision: The EIC shall examine the matter, including through joint site verification or expert inputs as needed, and shall issue a speaking order within 30 days of receiving a complete notice.

2.1.4. Binding Effect: The EIC's decision shall bind both Parties unless a written request seeking escalation to Tier-II is filed within 15 days from the date of issuance of EIC's decision. Absence of a timely request shall render the EIC decision final.

## **2.2. Tier-II: Departmental Review Committee (DRC)**

2.2.1. Constitution: A standing Departmental Review Committee, consisting of three senior officers including two Technical and one Finance/ Account officer, shall independently review disputes escalated from Tier-I.

2.2.2. Review Process: The DRC shall conduct a record-based administrative review of the Tier-I file, supplemented by written submissions from the Contractor. The committee may permit oral hearings if it deems them necessary for a fair decision.

2.2.3. Decision & Finality: The DRC shall deliver reasoned determination within 30 days of referral, extendable once by 30 days for, if resolution takes time, with reasons recorded. This determination shall constitute the final administrative decision of WAPCOS.

## **2.3. MANDATORY PRE-LITIGATION MEDIATION**

2.3.1. Obligation to Mediate: Following the DRC decision (or deemed decision), either Party may initiate pre-litigation mediation. Where the dispute qualifies as a 'commercial dispute' under the Commercial Courts Act, 2015, this mediation shall satisfy the mandatory pre-litigation requirement under Section 12A of the said Act.

2.3.2. Mediation Parameters: Mediation shall be conducted by a mediator empanelled with the High Court or a Government-notified mediation service provider in accordance with the Mediation Act, 2023. The timelines and extension provisions stipulated in the Act shall apply.

2.3.3. Approval of Settlement: Any mediated settlement agreement shall be subject to final written approval and execution by the Competent Authority of WAPCOS. The mediator shall be informed at the outset that the authorized representative of WAPCOS does not have the inherent power to bind WAPCOS to a settlement without such approval. If such approval is not granted within 30 days of the settlement terms being presented, the settlement shall be deemed not concluded, and the mediation shall be treated as unsuccessful.

## **3. CIVIL COURT JURISDICTION & CONSEQUENCES OF BREACH**

3.1. **Exhaustion of Remedies:** A Party may file a civil suit only after (a) obtaining a DRC decision or deemed decision, and (b) participating in the mandatory mediation process and obtaining a failure report.

- 3.2. **Mandatory Pleadings:** Every plaint shall specifically demonstrate compliance with Tier-I, Tier-II, and Tier-III requirements. Failure to do so shall render the plaint liable to rejection.
- 3.3. Any attempt to initiate arbitration or file a civil suit without first exhausting the mandatory tiers stipulated above shall constitute a material breach of contract. WAPCOS shall be entitled to seek appropriate relief from the court, including but not limited to an injunction to restrain such proceedings, and to recover all associated costs and expenses

#### 4. GENERAL PROVISIONS

- 4.1. **Severability:** If any portion of this Clause is invalidated by a court, the remaining parts shall remain in force.
- 4.2. **Amendment:** This Clause may be amended only by a written instrument signed by the CMD or an expressly authorized officer of WAPCOS.
- 4.3. Failure to continue performance shall constitute a material breach entitling WAPCOS to terminate the Contract without prejudice to its other right.

23. WAPCOS reserves the right to reject/ cancel the tender without assigning any reason thereof.

#### 24. Force Majeure

For the purpose of and within the scope of the contract by way of indication and not of limitation the terms 'Force Majeure' as employed herein shall mean acts of God, strikes, lockups or other industrial disturbances, acts of the public enemy, war, blockades, insurrection, riots, epidemics, landslides, earthquakes, storms, lighting, floods, washouts, civil disturbances, explosions and any other similar events, not within the control of either party and which by exercises of due care and diligence neither party is able to prevent or overcome. Should the occurrence of Force Majeure last more than 45 days, both parties have the right to cancel the contract. In such a case, the Consultant will be paid for all the work completed or which has been carried out or performed to the time.

#### 25. PREFERENCE TO MAKE IN INDIA

(i) The provisions of revised 'Public Procurement (Preference to Make in India) Order 2017 - Revision' issued by Department of Industrial Policy and Promotion under Ministry of Commerce and Industry vide letter no.-P45021/2/2017-PP (BE-II) as amended on 16.09.2020 shall be applicable to the bidding process and award of the contract shall be done accordingly. In this connection, the minimum local content shall be 50% and the margin of purchase preference shall be 20%.

#### (ii) Verification of Local Content

- a. The bidder at the time of tender, bidding or solicitation shall be required to indicate percentage of local content and provide self-certification that the item offered meets the local content requirement of the tender. They shall also give details of the location(s) at which the local value addition is made.
- b. In cases of procurement for a value in excess of Rs 10 Crores, the bidder shall be required to provide a certificate from the statutory auditor or cost auditor

of the company (in the case of companies) or from a practicing cost accountant or practicing chartered accountant (in respect of suppliers other than companies) giving the percentage of local content

**26. RULE 144 (xi) IN GENERAL FINANCIAL RULES (GFRs) 2017**

- (i) Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
- (ii) "Bidder "(including the term 'tenderer', 'consultant' or 'service provider' in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or office controlled by such person, participating in a procurement process.
- (iii) "Bidder from a country which shares a land border with India" for the purpose of this Order means:
  - a. An entity incorporated, established or registered in such a country; or
  - b. A subsidiary of an entity incorporated, established or registered in such a country; or
  - c. An entity substantially controlled through entities incorporated, established or registered in such a country; or
  - d. An entity whose beneficial owner is situated in such a country; or
  - e. An Indian (or other) agent of such an entity; or
  - f. A natural person who is a citizen of such a country; or
  - g. A consortium or joint venture where any member of the consortium or joint venture falls under any of the above.
- (iv) The beneficial owner for the purpose of 1.4.2.(iii) above will be as under:
  - a. In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercise control through other means;

**Explanation:**

- "Controlling ownership interest" means ownership of or entitlement to more than twenty- five per cent of shares or capital or profits of the company;
- "Control" shall include the right to appoint majority of the directors or to control the management or policy decisions including by virtue of their shareholding or management rights or shareholders agreements or voting agreements;
- b. In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership;
- c. In case of an unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profit of such association or body of individuals;
- d. Where no natural person is identified under (1) or (2) or (3) above, the beneficial owner is the relevant natural person who holds the position of senior managing official;
- e. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with

fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.

- (v) An Agent is a person employed to do any act for another, or to represent another in dealings with third person.

The successful bidder shall not be allowed to sub-contract works to any contractor from a country which shares a land border with India unless such contractor is registered with the Competent Authority

**SECTION – V**  
**SCOPE OF WORK**

## 1. OBJECTIVE OF INVESTIGATION

The objective of present Hydrographic / Bathymetry Survey is to determine bed terrain of **Indravati Reservoir**. The survey shall be carried out as per relevant BIS codes and CWC guideline. The survey will help in estimating the water depth, excavation requirement for underground structures and help in development of contour map of Reservoir bed. The scope of work shall include the following:

- A. Bathymetry/Hydrographic Survey inside the Reservoir
- B. Topographic Survey in the vicinity of the Reservoir
- C. Collection & analysis of Water Samples

## 2. PROJECT LOCATION

The project location is near Khatiguda in Nabarangpur District of Odisha . The survey area shall be on the northern side of the Reservoir. Tentative project area for bathy survey is as below:



**Note:** Bidders may do assessment of the survey locations by own before bidding.

## 3. SCOPE OF WORK

The Contractor shall establish horizontal and vertical control at the survey area site.

### Horizontal Control

- All survey data must be referenced to the **WGS-84** (World Geodetic System 1984) ellipsoid and projected onto the **UTM (Universal Transverse Mercator)** grid
- The contractor must use a Differential GPS (DGPS) or Real-Time Kinematic (RTK) system.

- Accuracy: Horizontal positional accuracy must be better than  $\pm 0.5$  meters for Reservoir mapping
- **Ground Control Points (GCPs):** The contractor shall establish permanent or semi-permanent GCPs around the Reservoir perimeter. These must be tied to the nearest **Survey of India (SOI) GTS Station** or established using long-duration (24hr+) static GPS observations

### **Vertical Control**

- Establish Benchmarks (BMs) linked to Survey of India (SOI) GTS Benchmarks using DGPS.
- Benchmark accuracy:  $\pm 0.005$  m (verification) and  $\pm 0.10$  m (transfer)
- All BMs must be shown on maps with coordinates, elevations, and descriptions.

### **A) Bathymetry/Hydrographic Survey inside the Reservoir**

Hydrographic Survey under this tender includes

- All the necessary pre-liaising with water resource departments for completion of the assignment (WAPCOS will provide assistance for the same, if required)
- Hiring/Mobilization of boat for conducting the survey in Reservoir as required.
- Indravati Reservoir and Indravati River bed survey using recording type echosounder along with integrated/isolated positioning system like GPS.
- The levels shall be on the basis of GTS bench marks in the vicinity
- Hydrographic survey inside Indravati Reservoir covering approximately 8 km<sup>2</sup> of area.
- Preparation of contour lines of 0.5m interval based on Hydrographic Survey processed data.

### **Data Acquisition**

- Approved echo sounder with dual frequency (as required).
- Positioning using DGPS integrated with survey equipment.
- Data Collection of Gauge-Discharge data from State/CWC

### **B) Topographic Survey**

#### **i) Brief Scope of Work**

- Establishing Bench Mark
- Establishing horizontal and vertical controls
- Carrying out leveling/ traversing and mapping of around 14 Km of route
- Reporting and charting
- Furnishing any clarifications required by client during the process of acceptance of the reports

ii) The plan should clearly show dry weather channels with shoals and channels, embankments, spurs, revetments, ghats, etc. Plan should also show all important structures like existing intake well, locations and size of shoals, bards, deep channel, joining of streams, nallahs, alignments and length of survey cross sections, GTS and other bench mark locations, important structures such as intake/bridges along bank and island configurations, bridges, culverts, weirs, etc. Important towns/ villages located in the area covered in the plan may also be marked in the same plan.

iii) The Contractor shall accurately delineate the various existing physical features such as high water and low water line creeks, drains, existing structures and road, hillock, houses, important town, villages en-route, roads, railways, embankments, bridges,

tributaries, landmarks, location of intake, location of gauge discharge stations, rain gauge stations, critical locations to be protected, location of bed/suspended sampling points etc. within the survey area and also mark important physical features which are adjacent to the survey area; important for orientation at the site as per directions of Engineer-in-charge. An index map covering all these features shall be included in the report.

iv) **Reporting**

- The Contractor shall submit survey reports as per specification laid down. However, the contour shall be marked at an interval 0.5 m on the survey charts.
- Survey maps shall be plotted at 1:1000 scale. An Index Map (Single Chart) showing entire area of survey and the physical features mentioned above shall also be prepared and submitted in triplicate along with soft copy as specified.

  - c) The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s)/Contractor(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal/Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
  - d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the names and addresses of agents/representatives in India, if any. Similarly Bidder(s)/Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.
  - e) The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.
3. The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
4. The Bidder(s)/Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practice means a wilful misrepresentation or omission of facts or submission of fake/forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to

justified interest of others and/or to influence the procurement process to the detriment of the WAPCOS interests.

5. The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/her reputation or property to influence their participation in the tendering process).

### **Article 3: Consequences of Breach**

Without prejudice to any rights that may be available to the Principal/Owner under law or the Contract or its established policies and laid down procedures, the Principal/Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/Contractor(s) and the Bidder/ Contractor accepts and undertakes to respect and uphold the Principal/Owner's absolute right:

1. If the Bidder(s)/Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days' notice to the contractor shall have powers to disqualify the Bidder(s)/Contractor(s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. Such exclusion may be forever or for a limited period as decided by the Principal/Owner.
2. Forfeiture of EMD/Performance Guarantee/Security Deposit: If the Principal/Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated/determined the Contract or has accrued the right to terminate/determine the Contract according to Article 3(1), the Principal/Owner apart from exercising any legal rights that may have accrued to the Principal/Owner, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder/Contractor.
3. Criminal Liability: If the Principal/Owner obtains knowledge of conduct of a Bidder or Contractor, or of an employee or a representative or an associate of a Bidder or Contractor which constitutes corruption within the meaning of IPC Act, or if the Principal/Owner has substantive suspicion in this regard, the Principal/Owner will inform the same to law enforcing agencies for further investigation.

### **Article 4: Previous Transgression**

1. The Bidder declares that no previous transgressions occurred in the last 5 years with any other Company in any country confirming to the anticorruption approach or with Central Government or State Government or any other Central/State Public Sector Enterprises in India that could justify his exclusion from the Tender process.
2. If the Bidder makes incorrect statement on this subject, he can be disqualified from the Tender process or action can be taken for banning of business dealings/ holiday listing of the Bidder/Contractor as deemed fit by the Principal/ Owner.

3. If the Bidder/Contractor can prove that he has resorted / recouped the damage caused by him and has installed a suitable corruption prevention system, the Principal/Owner may, at its own discretion, revoke the exclusion prematurely.

#### **Article 5: Equal Treatment of all Bidders/Contractors/Subcontractors**

1. The Bidder(s)/ Contractor(s) undertake(s) to demand from all subcontractors a commitment in conformity with this Integrity Pact. The Bidder/Contractor shall be responsible for any violation(s) of the principles laid down in this agreement/Pact by any of its Subcontractors/sub-vendors.
2. The Principal/Owner will enter into Pacts on identical terms as this one with all Bidders and Contractors.
3. The Principal/Owner will disqualify Bidders, who do not submit, the duly signed Pact between the Principal/Owner and the bidder, along with the Tender or violate its provisions at any stage of the Tender process, from the Tender process.

#### **Article 6- Duration of the Pact**

This Pact begins when both the parties have legally signed it. It expires for the Contractor/Vendor 12 months after the completion of work under the contract or till the continuation of defect liability period, whichever is more and for all other bidders, till the Contract has been awarded.

If any claim is made/ lodged during the time, the same shall be binding and continue to be valid despite the lapse of this pact as specified above, unless it is discharged/ determined by the competent authority, WAPCOS Limited.

#### **Article 7- Other Provisions**

1. This Pact is subject to Indian Law, place of performance and jurisdiction is the Headquarters of the Principal/Owner, who has floated the Tender.
2. Changes and supplements need to be made in writing. Side agreements have not been made.
3. If the Contractor is a partnership or a consortium, this Pact must be signed by all the partners or by one or more partner holding power of attorney signed by all partners and consortium members. In case of a Company, the Pact must be signed by a representative duly authorized by board resolution.
4. Should one or several provisions of this Pact turn out to be invalid; the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original intentions.
5. It is agreed term and condition that any dispute or difference arising between the parties with regard to the terms of this Integrity Agreement / Pact, any action taken by the Owner/Principal in accordance with this Integrity Agreement/ Pact or interpretation thereof shall not be subject to arbitration.

**Article 8 – LEGAL AND PRIOR RIGHTS**

All rights and remedies of the parties hereto shall be in addition to all the other legal rights and remedies belonging to such parties under the Contract and/or law and the same shall be deemed to be cumulative and not alternative to such legal rights and remedies aforesaid. For the sake of brevity, both the Parties agree that this Integrity Pact will have precedence over the Tender/Contact documents with regard any of the provisions covered under this Integrity Pact.
