If any such case of subletting without approval comes to the notice of WAPCOS, NO PAYMENT FOR THAT PART OF THE WORK SHALL BE MADE.
- 20. The Consultant shall be solely responsible for safety of his workmen and to provide them adequate necessary equipment etc. and shall ensure to have all his workmen properly covered under the Standard and Registered Insurance company policies for any injuries, losses etc. to his workmen. WAPCOS shall not be liable for any injury or loss of life of the Contractor's personnel. The Contractor shall ensure to provide required transport uniform, safety shoes and safety gadgets facilities to his workmen. If the Contractor fails to supply any safety equipment etc. to his workmen he shall be solely responsible and liable at all times.
- 21. Blacklisting: The blacklisting policy of the company is available on official website of WAPCOS Limited. The bidder/ tenderer/ consultant/ contractors have to mandatorily furnish an undertaking addressing the same to Engineer—in—Charge in the form of certificate to abide the contents of blacklisting policy. The format of undertaking is provided at Form XI. Any action in violation of the Blacklisting policy or to the certificate furnished shall result in cancellation of tender at the stage before or after the award of work.
- 22. **Arbitration:** In the event of any dispute, the decision of the CMD, WAPCOS shall be final & binding. The venue of the arbitration shall be at New Delhi.
 - "Any dispute, controversy or claims arising out of or relating to this Agreement or the breach, termination or invalidity thereof, shall be settled through following mechanism:
 - a) Firstly, the aggrieved party shall write a letter to the other party detailing its grievances and calling upon the other party to amicably resolve the dispute by convening a joint meeting. Accordingly, the parties as per their convenience shall jointly convene the said meeting(s), wherein minutes of the said meeting(s) shall be prepared and countersigned by all the parties. It is mandatory to prepare minutes of meeting(s) and to be countersigned by all the parties, irrespective of the outcome of the said meeting(s).
 - b) In the event the parties are unable to reach on any settlement in the said meeting(s), then the aggrieved party shall mandatory resort to pre-litigation mediation mechanism with Delhi High Court Mediation Cell, New Delhi.

- c) It is only upon failure of the pre-litigation mediation mechanism with Delhi High Court Mediation Cell, then the aggrieved party shall resort to resolution of disputes through arbitration of a Sole Arbitrator. The appointing authority of Sole Arbitrator is CMD, WAPCOS Limited, to which neither of the parties have any objection nor they shall ever object.
- d) Subject to the parties agreeing otherwise, the Arbitration proceedings shall be conducted in accordance with the provisions of the Indian Arbitration and Conciliation Act, 1996 (amended as on date).
- e) It is also acknowledged and accepted that WAPCOS is only working as Intermediary between the Associate/ Sub-Consultant/ Sub-Contractor and the Principal Employer/ Client, thus in the event, any dispute arises under the present agreement and referred to Arbitration for adjudication, then subject to corresponding clause in the Contract/ Agreement/ Work Order/ Arrangement between Principal Employer/ Client & WAPCOS, Principal Employer/ Client shall also be made party to the said Arbitration proceedings. Also, the award including costs if any passed against WAPCOS and costs incurred in the proceedings shall be the sole responsibility of Principal Employer/ Client. The said clause if found inapplicable, even then the other terms of the Arbitration Clause shall survive and shall be acted upon.
- f) The place/ seat of arbitration shall be Delhi and any award whether interim or final, shall be made, and shall be deemed for all purposes between the parties to be made, in Delhi. The arbitral procedure shall be conducted in English language and any award or awards shall be rendered in English. The procedural law of the arbitration shall be Indian Law. The award of the arbitrator shall be final and conclusive and binding upon the Parties.
- g) The Contract and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the laws of India and the Parties submit to sole & exclusive jurisdiction of courts at Delhi."
- 23. WAPCOS reserves the right to reject/ cancel the tender without assigning any reason thereof.

24. Force Majeure

For the purpose of and within the scope of the contract by way of indication and not of limitation the terms 'Force Majeure' as employed herein shall mean acts of God, strikes, lockups or other industrial disturbances, acts of the public enemy, war, blockades, insurrection, riots, epidemics, landslides, earthquakes, storms, lighting, floods, washouts, civil disturbances, explosions and any other similar events, not within the control of either party and which by exercises of due care and diligence neither party is able to prevent or overcome. Should the occurrence of Force Majeure last more than 45 days, both parties have the right to cancel the contract. In such a case, the Consultant will be paid for all the work completed or which has been carried out or performed to the time.

25. PREFERENCE TO MAKE IN INDIA

(i) The provisions of revised 'Public Procurement (Preference to Make in India) Order 2017 - Revision' issued by Department of Industrial Policy and Promotion under Ministry of Commerce and Industry vide letter no.-P45021/2/2017-PP (BE-II) as amended on 16.09.2020 shall be applicable to the bidding process and award of the contract shall be done accordingly. In this connection, the minimum local content shall be 50% and the margin of purchase preference shall be 20%.


Background

IWAI has appointed WAPCOS as a consultant for **Updation of Detailed Project Report (DPR) of National Waterway (NW) – 5 for developing the Brahmani River stretch from Talcher to Dhamra and Paradip in the State of Odisha.** The main objective is Carry out Hydrographic and Topogaphic Survey as per the scope of work in National Waterway 5 (NW5). The stretch location and approximate lengths of each stretches are given below:

Stretch Details of NW5

Pankapal to Mangalgadi - 117 km
 Mangalgadi to Dhamra - 28 km
 Mangalgadi to Paradip - 67 km
 Total - 212 Km

Note: Bidders may do assessment of the lengths of River Stretches by own before bidding



SCOPE OF WORK

The scope of work for the survey work is given below. It will include but may not be limited to the following Scope of Work/ Terms of Reference (TOR):

Collection of Data

Collection of Gauge Discharge data for past 30 years from the concerned department of all gauging stations falling in the River Stretches.

Establishment of Benchmark

The Benchmarks shall be established at every 10 Km internal along the entire stretch of survey and shall be linked with Survey of India (SOI) benchmarks using DGPS survey. Detailed description of Benchmark, position and value shall be given in Survey Report.

1.0 Hydrographic Survey

The Survey Party shall undertake fresh cross section surveys from bank to bank up to +1m above High Flood Level at every 200m interval. Also, the detailed hydrographic survey upto 1 km u/s and 1 km d/s at each terminal location would be carried out at 50m x 50m grid. The deepest section channel shall be marked on the survey chart.

- (i) The vertical control is to be established with respect to the chart datum / sounding datum from the following methods: -
 - (a) Chart datum/ sounding datum already established by Port Authorities (Chart Datum), Central Water Commission (Average of last six years minimum Water Level) / State Irrigation Department (Full Supply Level (FSL)) and at their gauge stations along the river/canal.
 - (b) Standard method shall be adopted for transfer of datum in rivers/canals.
- (ii) Establishing vertical control (accuracy +0.1m) and
- (iii) Verifying established bench marks (accuracy + 5 millimetres). Transfer of Bench Mark/datum w.r.t. MSL.
- (iv) Establishing horizontal control and marking selected points on the shore at suitable intervals. (accuracy +1m).
- (v) Clarifications/justification required by client during the acceptance of report for the work carried out by the survey firm.
- (vi) Chanel marking on drawing should be at deepest section of the river
- (vii) A survey report in triplicate describing the conduct of the survey along with a soft copy and all observed data, along with original records viz. calculations field books, measurement books etc. shall be submitted to WAPCOS Ltd. The data furnished shall be adequate to re-plot the survey chart independently on the basis of these documents.
- (viii) The charts shall be plotted at 1:5000 scale or any other scale as directed by Engineer-in-Charge showing levels at 1.0m intervals.

U.T.M. grid and geographical grid shall be marked on the chart as per normal cartographic practice. On the chart the levels shall be marked duly showing High Flood Level and low water line, symbols and legends, Northline etc. As the area covered shall be in more than one chart, the survey firm shall provide a single chart (Index Map) in triplicate. All charts/maps should display reference to the ground station and datum based on which the controls are fixed and shall indicate date/time of surveys and name of person in-charge carrying out the surveys.

(ix) Master copy of the each chart/map shall be provided on stable film (RTM) along with three hard copies and one soft copy on Compact Disc in a format compatible with AUTOCAD.

Survey Chart Preparation

- Contours of 0m, 1m, 2m, 3 m, 5m and 10 m are to be indicated on the charts with respect to Chart Datum / Sounding Datum.
- Reduced spot levels w.r.to MSL to be indicted on the charts. Spot level values are to be given w.r.t. Mean Sea Level (MSL) & Soundings w.r.t. Chart Datum / Sounding Datum. A separate file (xyz) (soft copy only) is also to be created for spot levels w.r.t. Chart Datum / Sounding Datum for dredging calculation purpose.
- On completion of the cross-sections, dredge channel is to be identified/ established by linking deepest soundings on the cross-sections. Dredging quantity is to be estimated for developing a navigational channel of channel dimension of 50 m Width and 3 m Depth as well as all classes of waterways as classified by IWAI.
- Dredging quantity is to be indicated in the report for per km length of the waterway.
- Minimum & maximum reduced depth and length of shoal for per km length of the waterway is also to be indicated in the report.
- Current meter measurement values shall be indicated in the report along with position.
- The results/characteristics of the soil and the water are to be incorporated in the report.
- Shallow patches /shoal and submerged sand-chur having less than 1.0 m depth, rocky outcrops, rapids and other navigational impediments are to be indicated on the charts.
- A brief write up on condition of the locks, Sluice gates, Barrages, Dams etc. (if available) are also to be included in the report. Brief write up based on visual observation, photographs and information from State Irrigation Dept. and local sources.
- The chart shall also be suitably updated with prominent land features from the Topo- sheets/site. Available Survey of India (SOI) Topographic sheet will be shared with successful Consultant on receipt of Undertaking. Satellite imageries are not available with WAPCOS for the designated area. Route map

- and survey plan will be provided by WAPCOS to the successful Consultant.
- All raw data and processed data of Automatic Hydrographic Survey System are required to be submitted. Standard procedure is to be adopted for data processing. All RAW, EDIT, SORT and field data are required to be submitted by the Contractor.
- All surveyed field data including levelling data (csv file) are required to be submitted.
- All position data of ground features, waterway structures are to be submitted in both hard copies and soft copies.
- Both hard and softcopies of survey charts as well as raw data shall be submitted to the WAPCOS as per normal practice.

2. Collection of Topographical Features

- Photographs of the prominent features are to be taken and included in the report along with its position.
- Permanent structures located within this corridor are also required to be indicated on the report & charts.
- All prominent shore features (locks, bridges, aqueducts, survey pillars if available etc) and other conspicuous objects are to be fixed and indicated on the chart and included in the report.
- Identify cross structures which are obstructing navigation.
- Details (horizontal and vertical clearances above High Flood Level in non-tidal area and High Tide Level in tidal area) of bridges, aqueducts, electric lines, telephone lines, pipe lines, cables en-route are to be collected and indicated on the chart and also included in the report along with their co-ordinates and location.
- Details of water intake/ structures are to be collected and shown on the charts and include in the report.
- Availability of berthing place, existing jetty, ferry ghats, approach roads etc. are to be indicated on the charts and include in the report.
- During the survey, conditions of the banks are also required to be collected. It is to be noted that banks are pitched (protected) or not protected. Estimate the length of bank protection, where banks erosion is taking place.
- Positions and levels of corners of permanent structures within the corridor are to be physically surveyed and marked on survey charts.
- Approachable roads / rails / places outside the corridor may be incorporated from Toposheets/Google Map/Google Earth.

3.0 Topographic Surveys

The Survey Party shall undertake fresh topographic surveys of the new jetty locations and / or proposed Terminal sites etc. at 25m x 25m grid for preparation of layouts, General Arrangement (GA) drawings, sections and elevations etc. These surveys shall be

carried out up to the water line during the survey period as per standard norms and practices. Topographic survey shall be extended from proposed terminal location to connectivity with road and rail, if feasible, shall also be undertaken:

Apart from the main jetty area, the Topographic Survey will also be carried out in approximately 500m downstream and 500m upstream areas between the HFL line and the water line during the survey period

The Topographic Survey charts shall be prepared in the scale of 1:1000 and these will include spot levels in a grid of 25 m as well as other physical features (such as structures / houses, trees, natural drains etc.) and contours.

Both hard and softcopies of survey charts as well as raw data shall be submitted to the WAPCOS as per normal practice.

4.0 Current Velocity and Discharge Measurement

- The current velocity and discharge at every 10 km interval shall be observed once in a day during the survey period. Current velocity and discharge at every 10 km interval are to be measured only once at different depths while carrying out survey in that region.

Article 1: Commitment of the Principal/ Owner
