- 1.2 Principal Employer/Owner/Client means of Director General of Police, UT OF LADAKH herein referred as "Police Chief, UT OF LADAKH".
- 1.3 Employer" shall mean "WAPCOS Limited", A Government of India undertaking- Ministry of Jal Shakti, for execution of the Work / Project and WAPCOS is working as Executing agency on behalf of Director General of Police, UT OF LADAKH.
- 1.4 All Bidders are hereby cautioned that Bids containing any deviation or reservation as described in Clauses of "Instructions to Bidders" shall be considered as non-responsive and shall be summarily rejected.
