 - 5. The site for work is available. The Bidder, at his own cost, responsibility and risk, is required to visit, examine and familiarize himself with the site of works. A Site Visit Certificate, duly issued by the Resident Engineer of PIU of WAPCOS, is required to submit by the bidder along with his bid, failing which, his bid shall not be considered to evaluation and shall be out rightly be rejected.
 - 6. **Bid Opening:** Only online submission of bids is permitted, therefore; bids must be submitted online on website www.pmgsytendersuk.gov.in. The technical qualification part of the bids will be opened online on 18-07-2024-03:00 PM by the authorized officers. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time.
 - 7. **Bid Validty:** The bids for the work shall remain valid for acceptance for a period not less than 90 Days after the deadline date for bid submission.
 - 8. All bidders are required to quote their item rates excluding Goods and Service Tax (GST) and all taxes falling within purview of GST-Act 2017 but including labour cess, royalty etc. Payment of GST and required deductions in this reference will be made as per prevailing rules.
 - 9. Payment shall be done on back to back basis on receiving the same from client Uttarakhand Rural Road Development Agency (URRDA).

SECTION-1: INSTRUCTIONS TO BIDDERS

1.0 Online Bids are hereby invited by Executive Director (Civil Design), WAPCOS Limited, Gurugram, Haryana on behalf of Uttarakhand Rural Road Development Agency (URRDA) referred to as "Employer") from reputed and experienced (hereinafter firms/contractor registered in Class-A or above with PWD/CPWD or equivalent department "Bidder") for Special Maintenance Work for Birtha to referred to as (hereinafter Taraswar Motor Road, Length-5.18 Km. Block-Tarikhet, Distt. Almora" as mentioned in the NIT. Any kind of JV / Consortium is not allowed for this work.

2.0 Bid Validity

The offer(s) shall be valid for a period of 90 (Ninety days) from the date of opening the tender. Conditional bids shall be rejected.

3.0 Scope of Work

This motor road was constructed under Pradhan Mantri Gram Sadak Yojna (PMGSY) Scheme. This road was damaged at several places during the heavy rain occured (Deviya Aapda) in the project area. The Scope of work includes Construction of Protection Works (Breast wall and Retailing Wall) as specified in the drawing and estimate and instructed by PIU In-charge suitable as per site conditions. Rates shall be quoted by the interested bidder in the prescribed format of BOQ only including all construction and labour charges for execution of the work at site. Payment shall be made to the contractor only on the basis of actual execution/measurements of work at site. Running bill shall be made as per actual progress of work at site. All Payments shall be made to contractor on Back-to-Back basis only on availability of funds/Receiving from the client.

4.0 Site Visit

The Bidder, at his own cost, responsibility and risk, is required to visit, examine and familiarize himself with the site of works. The bidder acknowledges that prior to the submission of the bid, the Bidder has, after a complete and careful examination, made an independent evaluation and understanding of the scope of the work, specifications and standards of design, site local conditions, availability of approaches to the site etc.

A Site Visit Certificate, duly issued by the Resident Engineer of PIU of WAPCOS, is required to submit by the bidder along with his bid, failing which, his bid shall not be considered to evaluation and shall be out rightly be rejected.

5.0 Estimated Cost of Work

Sanctioned Cost of the work is **Rs. 22.88 Lacs** excluding GST. Quantities have been assessed on the basis of damages caused at site and sanctioned from project authority Uttarakhand Rural Road Development Authority (URRDA).

6.0 Essential Qualification Criteria

a. Bidders must be registered in Class A or above with PWD/CPWD or equivalent department. Registration Certificate shall be provided by the bidder along with his Bid.

b. Bidder must have experience of Construction of Road / Protection Works with-in last 7 Years in the following manner:

One (01) Similar executed work costing not less than 80% of the estimated cost of work.

or

Two (02) Similar executed works of order value each not less than 50% of the estimated cost of work.

or

Three (03) similar executed works of order value not less than 40% of the estimated cost of work.

As a proof, Work Order and Completion Certificate shall be submitted by the bidder in his bid.

- c. Bidder must have valid PAN and GST registration number.
- d. Average Annual Financial Turnover should be at least 50% of the estimated cost of work during the last 3consecutive Financial Years.
- e. The bidder should not have incurred any loss in more than 2 years in last five financial years, attested by the independent Charted Accountant with UDIN number.

7.0 Bid Document Fee and Earnest Money Deposit

Bid Document is available online on the website https://www.pmgsytendersuk.gov.in. However Bid Fee of Rs. 2,000/- shall be deposited by the bidder in the form of Demand Draft issued by any scheduled commercial bank in favour of WAPCOS Limited and payable at New Delhi/Gurgaon.

The bidders are requested to submit the **Bid Security** / **Earnest Money Deposit** of **Rs. 45,760**/- with his Bid, failing which his bid shall out rightly be rejected. EMD shall be submitted in the form of Fixed Deposit Receipt (FDR) only of a scheduled commercial bank in favor of/duly pledged to **WAPCOS Limited**, Sector-18, Gurgaon, Haryana payable at Delhi/Gurgaon. EMD shall be valid for minimum 90 Days beyond the validity of bid.

8.0 Submission of Bid

Bids shall be submitted online and all tendering process will be completed on the Uttarakhand PMGSY online tendering portal https://www.pmgsytendersuk.gov.in.

Technical and Financial Bids shall be submitted online upto the specified last date and time of bid submission.

The bidder shall submit as Part-I, marked as Technical Bid and Part-II, marked as Financial Bid. All the documents are required to be counter signed by the bidder.

Hard copy of the bid along with following documents shall be submitted to the office address as mentioned in the NOTICE INVITING TENDER (NIT).

- Affidavit for correctness of information provided in the bid document on a non-judicial stamp paper of Rs.10/- and shall be attested by Magistrate/ Sub-Judge/ Notary Public
- Bid Fee in Original

- Bid Validity on Rs. 100/- Non-Judicial Stamp Paper with Rs. 1/- revenue stamp
- Bid Security / Earnest Money Deposit in Original (FDR)
- Bank Solvency Certificate

Aforementioned documents are required to be submitted in original up to specified date and time mentioned in the NIT either by registered post/ courier service or by hand, failing which the bid will be declared as non- responsive. WAPCOS shall not be responsible for any postal delay on any account. In case date of submission happens to be holiday, then documents may be submitted on next working day.

9.0 Technical Bid

The Technical Bid submission forms are enclosed as Schedule-A respectively.

- 9.1 Bidders shall submit the bid in the formats provided in the Bid Document. Bid shall includes the following documents/reports:
 - 1. Contractor's Registration Certificates
 - 2. Bidder must have valid PAN and GST Number. Copy of PAN Card copy and GST Registration shall be provided by the bidder.
 - 3. Affidavit for correctness of information provided in the bid on a non-judicial stamp paper of Rs.10/- and shall be attested by Magistrate/ Sub-Judge/ Notary Public)
 - 4. Bid Validity on Rs. 100/- non judicial stamp paper with Rs. 1.00 Revenue ticket.
 - 5. Bid Fee & EMD Copy
 - 6. Bidder must have experience of construction of Road/Protection Works with-in last 7 Years. In proof, Work Order and Completion Certificate shall be submitted by the bidder in his bid.
 - 7. Bank Solvency Certificate 40% to the estimated cost (**Rs. 9.16 Lacs**) of work and duly addressed to the Employer and having work name is to be submitted by the bidder along with his Technical Bid. Solvency Certificate must have been issued after the date of publication of NIT & be addressed to the tendering authority quoting the name of work.

- 9. Average Annual Financial Turnover should be at least 50% of the estimated cost of work during the last 3 consecutive Financial Years. In this regard, Charted Accountant Certificate with UDIN shall be submitted by the bidder.
- 10. Turnover, Profit, Net Worth certificates must be certified by the statutory auditor of the

- firm/company. Any such certificates must carry the UDIN (Unique Document Identification Number)
- 11. The bidder should not have incurred any loss in more than 2 years in last five financial years, attested by the independent Charted Accountant.
- 12. Counter Signed copy of this document as a token of acceptance of the Terms & Conditions
- 9.2 WAPCOS reserves the right to verify all statements, information and documents, submitted by the Agency in the Bid. Any such verification or the lack of such verification by the WAPCOS to undertake such verification shall not relieve the Agency of its obligations or liabilities hereunder nor will it affect any rights of WAPCOS there under.

10.0 Financial Bid

- 10.1 The Agency should quote considering all the items as listed in the **Scope of Works**. The quoted amount shall be inclusive of all prevalent taxes in the country. Rates shall be quoted by the interested bidder in the prescribed format of Bill of Quantities provided along with Bid Document only.
- 10.2 The quoted rates/amounts shall cover the costs of executing all activities defined in scope of work. The quoted rates/amounts shall cover costs of remuneration, accommodation, lodging, boarding, transportation, insurance, equipment, material, and other expenses related to the Agency's staff/manpower and the works to be executed. The Agency shall not require or demand any other reward or compensation, either in the form of currency or in other forms, from WAPCOS. All the taxes/statutory duties etc. except GST required in the place of work shall be borne by the Agency.
- 10.3 The quoted rates/amounts shall be deemed to be firm throughout the project till the completion of work and shall not be subject to any adjustment due to increase in price of materials, utilities, taxes, duties etc. or any other input for performance of work and the contract.
- 10.4 The Financial Bid submission forms are enclosed as Schedule-B respectively that shall be filled and submitted by the bidder in separate section Part-II: Financial Bid along with his bid within the specified date and time as mentioned in the NIQ.

11.0 Time of Completion

The time period for the work is 4 months from the Date of Start of the work. Payment shall be made on the basis of actual progress at site and after receiving the funds/approval from the client Uttarakhand Rural Roads Development Agency (URRDA).

12.0 Performance Security, Additional Performance Security & Security Deposit

Performance Security at the rate of 5% of the Contract Price shall be provided by the contractor to the employer at the time of signing of contract in the form of FDR/Performance Bank Guarantee from the nationalized or scheduled commercial banks acceptable to the employer. No Performance shall be deducted from the running bill.

Security Deposit shall remain at the rate of 5% of the Contract Price that shall be deducted from the running bill of the contractor, as per the applicable GCC GPW FORM-9 of PWD

Uttarakhand. All other Terms and Conditions regarding release shall be followed as per GPW FORM-9.

13.0 Payment Terms

Payment to the contractor is totally based on the actual execution of the work at site. Payment shall be made to the contractor only after completion of work at site on back-to-back basis on receiving the same from the client Uttarakhand Rural Roads Development Agency (URRDA) depending on availability of funds and authorization thereof.

Associate/Sub-Contractor/Sub Consultant acknowledges that under Contract/Agreement/Work Order/Arrangement, WAPCOS is only working as intermediary between client Uttarakhand Rural Road Development Agency (URRDA) being Principal Employer/Client and Associate/Sub-Contractor/Sub-Consultant. Thus the Associate/Sub-Contractor/Sub-Consultant unconditionally acknowledges that the payments under the present Contract/Agreement/Work Order/Arrangement shall be made proportionately by WAPCOS only on back-to-back basis i.e. after 21 days subject to receipt of payments from client URRDA being Principal Employer/Client. The Associate/Sub-Contractor/Sub-Consultant also unconditionally agree that in the event the payment or part thereof, under the present Contract/Agreement/Work Order/Arrangement is not received from client URRDA (Principal Employer/Client), then WAPCOS &/or any of its Employee/Officer shall not be responsible to pay any amount to Associate/Sub-Contractor/Sub-Consultant. The said condition shall supersede any and all other conditions of Contract/Agreement/Work Order/Arrangement between the parties.

14.0 Price Escalation & Variation

No Price Escalation shall be allowed for the quoted rates of the bidder throughout the period of completion of the work. As the client URRDA has sanctioned the cost for the Special Maintenance work, no variation in quantities shall be allowed exceeding the sanctioned cost of the work.

15.0 Penalty / Liquidated Damages

If the contractor fails to maintain the required progress to complete the work and clear the site on or before the project completion period or extended date of completion, he shall pay or allow WAPCOS to deduct penalty as per Clause 4: Compensation of Delay of GCC pg. 3 GPW FORM-9, Government of Uttarakhand.

16.0 Arbitration

16.1 Resolution of Disputes

Except where otherwise provided in the contract, all questions and disputes relating to the work or the execution or failure to execute the same whether arising during the progress of the work or after the cancellation, termination, completion or abandonment thereof shall be dealt with as mentioned hereinafter:

If the Selected Agency considers any work or any matter in connection with or arising out of the contract or carrying out of the work, to be unacceptable and is resulting in a dispute, it shall be referred to the Nodal Officer from WAPCOS who shall, within a period of thirty days after being requested by the Selected Agency to do so, give written decision to the Selected Agency. Upon receipt of the written decision of the Nodal Officer, the Selected Agency shall promptly proceed without delay to comply with such decision.

16.2 Adjudication of Disputes

Any dispute, controversy or claims arising out of or relating to this Agreement or the breach, termination or invalidity thereof, shall be settled though following mechanism:-

- a. Firstly, the aggrieved party shall write a letter to the other party detailing its grievances and calling upon the other party to amicably resolve the dispute by convening a joint meeting. Accordingly, the parties as per their convenience shall jointly convene the said meeting(s), wherein minutes of the said meeting(s) shall be prepared and countersigned by all the parties. It is mandatory to prepare minutes of meeting(s) and to be countersigned by all the parties, irrespective of the outcome of the said meeting(s).
- b. In the event the parties are unable to reach on any settlement in the said meeting(s), then the aggrieved party shall mandatory resort to pre-litigation mediation mechanism with Delhi High Court Mediation Cell, New Delhi.
- c. It is only upon failure of the pre-litigation mediation mechanism with Delhi High Court Mediation Cell, then the aggrieved party shall resort to resolution of disputes through arbitration of a Sole Arbitrator. The appointing authority of Sole Arbitrator is CMD, WAPCOS Limited, to which neither of the parties have any objection nor they shall ever objected.
- d. Subject to the parties agreeing otherwise, the Arbitration proceedings shall be conducted in accordance with the provisions of the Indian Arbitration and Conciliation Act, 1996 (amended as on date).
- e. It is also acknowledged and accepted that WAPCOS is only working as Intermediary between the Associate/Sub-Consultant/ Sub-Contractor and the Client, thus in the event, any dispute arises under the present agreement and referred to Arbitration for adjudication, then subject to corresponding clause in the Contract/ Agreement/ Work Order/ Arrangement between Client & WAPCOS, Client shall also be made party to the said Arbitration proceedings. Also, the award including costs if any passed against WAPCOS and costs incurred in the proceedings shall be the sole responsibility of Principle Employer/ Client. The said clause if found inapplicable, even then the other terms of the Arbitration Clause shall survive and shall be acted upon.
- f. The place/seat of arbitration shall be Delhi and award whether interim or final, shall be made, and shall be deemed for all purpose between the parties to be made, in Delhi. The arbitral procedure shall be conducted in English language and any award or awards shall be rendered in English. The procedural law of the arbitration shall be Indian Law. The award of the arbitrator shall be final and conclusive and binding upon the Parties.
- g. The contract and any dispute or claim arising out of or in connection with it or its subject matter of formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the laws of India and the Parties submit to sole & exclusive jurisdiction of courts at Delhi.
- 17.0 Incomplete tenders, conditional tenders, tenders received after the stipulated time shall be summarily rejected.
- **18.0** Employer reserves the right to reject any or all bids without assigning any reason.

reputable local banks including scheduled banks or nationalized banks acceptable to the Employer. The performance security shall be valid until the date of issuance of Completion certificate. The Employer may increase the Performance Security to a level sufficient to protect it against the possibility of Financial loss, if the lowest evaluated bid is unbalanced.

(3.1.2.3) Additional performance security:-

The amount of Additional Performance security shall be worked out as follows:-

- (a) No Additional Performance Security for item rates up to 5% below the estimated item rate,
- (b) An Additional Performance Security of 10% of the estimated cost of items, for item Rates form 5% to 15% below the estimated rate,
- (c) An Additional Performance Security of 15% of the estimated cost of items, for item Rates more than 15% below the estimated rate,

Note: The Performance Security and Additional Performance Security as applicable shall be refunded to the contractors after satisfactory completion of the works and after the payment of the final bill.

(3.2) Security Deposit :-

The Employer shall retain from each Payment due to the Contractor an amount of 5% of the bill Amount, subject to a maximum of 5% of the Contract Price until the Defects liability period has passed and the Engineer has certified that all Defects notified by the Engineer to the Contractor before the end of this period have been corrected. The defect liability period shall be 12 months from the date of completion of the contract for non bituminous works and shall be 24 months from the date of completion of the contract for bituminous works.

Clause No. 4

Compensation for Delay:-

If the contractor fails to maintain the required progress as per Annexure-A or to complete the work and clear the site on or before the Date of completion or extended date of completion, he shall, without prejudice to any right or remedy available under the law to the government on account of such breach pay as agreed compensation the amount calculated at the rates stipulated below if that the progress remains below that specified in Schedule-A or that the work remains incomplete.

Conditions to withheld the amount in case of non- achievement of milestone:-

- (4.1) If the work is not started by the end of the time given for the first milestone, the agreement shall be immediately finalized and the performance security shall be forfeited.
- (4.2) If the work is started just before the lapse of the first milestone, but not completed by the time given for the grace period, 2.50% of the contract value shall be withheld and it shall only be refundable incase of compensating the target of the first milestone along with the second milestone within the scheduled time of second milestone.
- (4.3) In the event of non achieving the necessary progress as per the second milestone additional 3.50% of the contract value shall be withheld and the total 6.0% withheld money shall only be refundable if the required progress upto second milestone is achieved alongwith the third milestone within the scheduled time of third milestone.

accepting the contract on behalf of the Government or Engineer-in-charge by Clause 5 here of, shall have become exercisable and the same are not exercised, the non exercised there of shall not constitute a waiver of any of the condition here of and such power shall not with standing be exercisable in the event of any future case of the default by the contractor for which by any clause or clauses hereof he is declared liable to pay compensation and the liability of the contractor for past and future compensation shall remain unaffected. In the event of the Engineer-in-charge putting in force all or any of the powers vested in him under the preceding Clause, the Engineer-in-charge may if he so desires, take possessions of all or any tools, plant, materials or any stores, in or upon the works or the site thereof or belonging to the contractor or procured by him and intended to be used for the execution of the work or any part thereof, paying or allowing for the same in account at the contract rates or in the case of these not being applicable at current market, rates to be certified by the Engineer-in-charge whose certificate there of shall be final other wise the Engineer-in-Charge may give notice in writing to the contractor or his clerk of the work, foremen or other authorized agent require him to remove, such tools, plant, materials of stores from the premises (within a time to be specified in such notice) and in the event of the Contractor failing to comply with any such requisition, the Engineer-incharge may remove at the Contractor expenses or sell them by auction or private sale on the account of Contractor and at his risk in all respect and the certificate of the Engineer-in-Charge as to the expenses of any such removal and the amount of the proceeds and expenses of any sale shall be final and conclusive against the contractor.

Clause No. 7

Extension of time:

The time allowed for execution of work as specified in the schedule "A" or the extended time in accordance with these condition shall be the essence of the contract. The execution of the work shall commence form such time period mentioned in schedule .If the contractor shall desire an extension of the time for completion of the work on the ground of his having been unavoidably hindered in its execution, or any other ground he shall apply in writing to the officer accepting the contract on behalf of the Government through the Engineer-in-Charge and a copy thereof is sent to Engineer-in-Charge within 30 days of the hindrance on account of which he desires such extension as aforesaid, The cases of the extension of the time beyond the time schedule as per milestone shall be submitted to the authority next higher to the officer accepting the contract on behalf of the Government provided that the extension of time should be limited to 50% of the total period of that particular miles stone. In case this period exceeds more than- 50%, it shall be submitted to authority next to next higher to the office accepting the contract as the case may be. Provided always that if the Contractor continues to perform the work obtaining approval for extension as aforesaid the right of the Government to claim compensation under Clause 5 shall not be deemed to have been waived.

Clause No.8

Final Certificate:-

On completion of the work the contractor shall send a registered notice to the Engineer-in-Charge giving the date of completion and sending a copy of it



to the officer accepting the contract on behalf of the Government and shall request the Engineer-in-Charge to give him a certificate of completion but no such certificate shall be given nor shall the work be considered to be complete until the contractor shall have removed from the site, on which the work shall be executed all scaffolding, surplus materials and rubbish and cleared off the dirt from all wood work doors, windows, walls, floors, or other parts of any building in, upon or about which the work is to be executed or of which he may have had possession for the purpose of execution thereof, and he has filled up the pits. If the Contractor fails to comply with the requirements of this clause as to removal of scaffolding surplus materials and rubbish and cleaning of dirt and filling of pits on or before the date fixed for completion of the work, the Engineer-in-Charge may at the expense of the Contractor remove such scaffolding, surplus materials and rubbish and disposal of the same as he think fit and clean off such dirt and fill the pits as aforesaid, and the Contractor shall forth with pay the amount of all expenses so incurred and shall have no claim in respect of any scaffolding or surplus materials as aforesaid except for any sum actually realized by the sale thereof. On completion, the work shall be measured by the Engineer-in-Charge himself or through his subordinate, whose measurements shall be binding and conclusive against the contractor, provided that, in subsequent to the measurements taken by the subordinates as aforesaid the Engineer-in-Charge had reason to believe that the measurements by his subordinates are not correct, Engineer-in-charge shall have the power to cancel the measurements already taken by his subordinates and acknowledged by the Contractors and to take measurements again after giving notice to the contractor and remeasurements shall be binding on the contractors.

Within fifteen days of the receipt of the notice, the Engineer-in-Charge shall inspect the work and if there is no visible defect on the face of the work, shall give the contractor a certificate of completion. If the Engineer-in-Charge finds that the work has been fully completed, it shall be mentioned in the certificate to be granted. On the other hand, if it is found that there are certain visible defects to be removed, the certificate to be granted by Engineer-in-charge shall specifically mention the details of the visible defects along with the estimate of the cost for removing these defects. The final certificate of completion of work shall be given after the visible defects pointed out as above have been removed.

Clause No.9

Intermediate Payments:-

No Running payments shall be made for work estimated to cost less than Fifty thousand till after the work shall have been completed and a certificate of completion given. But in the case of works estimated to cost more than Rupees Fifty thousand, the contractor shall, on submitting the bill, thereof be entitled to receive a payment passed by the Engineer-in-charge whose certificate of such approval and passing of the sum so payable shall be final and conclusive against the contractor. The maximum amount of intermediate payment shall be limited upto 75 percent of the contract amount. All such intermediate payments shall be regarded as payments for works actually done and completed and shall not preclude bad, unsound and imperfect or unskilled work to be removed and take away and re-constructed or re-corrected, or it shall not be considered as an admission of the due performance of the contractor or any part thereof in any



respect of the acquiring of any claim nor shall it conclude, determine or affect in any way the powers of the Engineer-in-Charge under these conditions or any of them as to the final settlement and adjustment of the accounts and otherwise or in any other way vary or affect the contract.

The final bill shall be submitted by the contractor within one month of the date fixed for completion of the work or of the date of the certificate of completion furnished by the Engineer-in-Charge and payments shall be made within 3 months of submission of such bill. If there shall be any dispute about any items of the work then the undisputed item or items only shall be paid within the said period. The contractor shall submit a list of the disputed items within 30 days from the disallowances thereof and if he fails to do so his claim shall be deemed to have been fully waived and absolutely extinguished.

Clause No.10

Contractors to be given a week to file objection to the measurement recorded by the department:-

Before taking any measurement of any work as has been referred to in clause 8,9 thereof, the Engineer-in-Charge or subordinate deputed by him shall give reasonable notice to the contractor. If the contractor fails to attend at the time of measurement after such notice or fails to countersign or to record the difference within a week from the date of measurement in the manner required by the Engineer-in-charge then in any such event the measurements taken by the Engineer-in-Charge or by the subordinate deputed by him as the case may be, shall be final and binding on the contractor and the contractor shall have no right to dispute the same.

Clause No.11

Stores supplied by the Government:-

If the specification or schedule of the items provides for the use of any special description of material to be supplied from the Engineer-in-charge's store or if it is required that the contractor shall use certain stores to be provided by the Engineer-in-charge (such materials and stores and the prices to be charged thereof as here-in-after mentioned being so far as practicable for convenience of the contractor, but not so as in any way to control the meaning or effect of this contract, specified in the Schedule or memorandum here to annexed) the contractor shall be supplied with such materials and stores as are required from time to time to be used by him for the purpose of the contract only and the value of the full quantity of materials and stores so supplied at the Rates specified in the said scheduled or memorandum may be set off or deducted from any sums then due, or there after to become due to the contractor under the contract or otherwise or against or from the security deposit, or the proceeds of sale thereof, if the same is held in Government securities, the same or a sufficient portion thereof being in the case sold for the purpose. It shall be the responsibility of the contractor to ascertain from time to time, from the Engineer-in-Charge about the position of availability of the materials as afore mentioned and any delay on the part of the Engineer-in-charge to arrange supplies of the same shall not entitle the contractor to any compensation but in the event of all such delays the contractors shall be granted reasonable extension of time. All materials supplied to the contractor are the property of the contractor, but shall not on any account be removed from the site of the work, except with written permission of the Engineer-in-Charge or



under his orders and shall at all times be open to inspection by the Engineer-incharge. Any such materials unused and in-perfectly good condition at the time of completion or determination of the Contract may, by special arrangement be taken over by the Government at the prevailing market rates, if required for use on other works in progress provided that the price allowed shall not exceed the amount charged to the Contractor.

Clause No.12

Works to be executed in accordance with specification, drawing etc:-

The contractor shall execute the whole and every part of the work in the most substantial and work-man like manner and both as regards materials and otherwise in every respect in strict accordance with the specification. The contractor shall also confirm exactly, fully and faithfully to the designs, drawings and instructions in writing relating to the work signed by the Engineer-in-Charge and lodged in his office, and to which the contractor shall be entitled to have access to such office, for the purpose of inspecting during office hours and the contractor shall be furnished free of charge one copy of the specification and of all such designs, drawings, and instructions not included in the detailed specifications for buildings and roads enforced from time to time or any other printed publications on general specifications referred to elsewhere in the contract.

Clause No.13

Alteration in specification and design do not invalidate contract:-

The Engineer-in-charge shall have the authourity to make any alteration or omission from, additions to or substitution for the original specification, drawings, designs, and instructions that may appear to him to be necessary during the progress of the work and the contractor shall carry out the work in accordance with any instructions that may be given to him in writing singed by the Engineer-in-charge and such alterations, omission, addition, or substitutions shall not, invalidate the Contract any altered additions, or substituted work which the contractor may be directed to do in the manner as above specified as part of the work shall be carried out by the Contractor on the same conditions in all respect on which he agreed to do the main work. The time for the completion of the work shall be extended in the proportion that the altered, additional or substituted work bears to the original contract work and the certificate of the Engineer-in-charge shall be conclusive as to such proportion. Over and above this, a further period to the extent of 25 percent of the time so extended may be allowed to the contractor. The rates for such additional, altered or substituted work under this clauses shall be worked out in accordance with the following provisions in their respective order:-

- 13.1 If the Rate for the additional, altered, or substituted work are specified in the contract for the work, the Contractor is bound to carry out the additional, altered or substituted work at the same rates as are specified in the contract of the work.
- 13.2 If the rates for the additional, altered or substituted work include any work for which no rates are specified in the contract for the work or can not be derived from the similar class of work in the contract then such work shall be carried out at the rates entered in the Schedule of rates minus/plus percentage



which the total tendered amount bears to the estimated cost of the entire work put to tender.

- 13.3 If the rates for the additional, altered or substituted work are not specifically provided in the contract for the work, the rate will be arrived from the rates for similar class of work, as are specified in the contract for the work.
- 13.4 If the rates for the additional, altered or substituted work can not be determined in the manner specified in sub clauses 13.1 to 13.3 above, the rates for such work shall be worked out on the basis of the Schedule of Rate minus/plus the percentage which the total tendered amount bears to the estimated cost of the entire work put to tender, provided always that if the rates for a particular part or parts of the item is not in the Schedule of rate, rate for such part or parts will be determined by the officer accepting the contract and approved by next higher to the officer accepting the contract on behalf of the Government on the basis of the prevailing market rates when the work was done.
- 13.5 If the rates of the additional, altered or substituted work can not be determined in the manner specified in sub clause 13.1 to 13.4 above, then the contractor shall within 7 days of the date of receipt of the order to carry out the work inform the officer accepting the contract on behalf of the Government of the rate which it is his intension to charge for such class of work, supported by analysis of the rates claimed and the Superintending Engineer shall determine the rate or rates on the basis of the prevailing market rates and pay the contractor accordingly. However the officer accepting, the contract on behalf of the Government by notice, in writing will be at liberty to cancel his order to carry out such class of the work and arrange to carry it out in such manner as he may consider advisable. But under no circumstances, the contractor, shall suspend the work on the plea of non settlement of rates of items, falling under this clauses:-

The quantities for the additional, altered or substituted work and the rates thereof under sub-clause (1) to (3) shall be worked out by the officer accepting the contract on behalf of the Government and shall be approved by the officer next higher to the officer accepting the contract.

Clause No.14

No compensation for alteration in or restriction of the work to be carried out:-

If at any time after the commencement of the work the Government of Uttarakhand or the Chief Engineer shall for reason whatsoever not require the whole work thereof as specified in the tender to be carried out, the Engineer-incharge shall give notice in writing of the fact to the contractor who shall have no claim to any payment or compensation whatsoever on account of any profit or advantage, which he might have derived from the execution of the work in full, but which he did not derive in consequence of the full amount of the work not having been carried out, neither shall have any claim for compensation by reason of any alteration having been made in the original specifications, drawings, designs, and instructions which shall involve any curtailment of the



work as originally contemplated nor shall have any claim to compensation by reason of his having purchased or procured materials with a view to the execution of the work or the performance of the contract. But the Engineer-in-charge shall have the option either to take over the materials at site, if of approved quality and not in excess of the requirements of the work and to pay to the contractor the actual cost thereof (of the amount of which cost, a certificate by the Engineer-in-charge shall be binding on the contractor). In the event of this option not being exercised, the contractor may submit to the Engineer-in-charge within one month of the date of the order closing down the work a detailed statement of the loss that estimate he will sustain by removing, selling or otherwise disposing of the materials. The estimate will be forwarded to the Chief Engineer who will decide what sum, if any, should as a matter of grace be paid to the contractor to compensate him for the loss suffered by him and the decision of Chief Engineer shall be final and binding on the contractor.

Clause No.15

Action and compensation payable in case of bad work:-

If it shall appear to the Engineer-in-charge or his subordinate-incharge of the work, that any work has been executed with unsound, imperfect, unskillful workmanship or with materials of any inferior description or that any materials or articles provided by him for the execution of the work are unsound or of a quality inferior to that contracted for or otherwise not in accordance with the contract, the contractor shall, on demand in writing from the Engineer-in-charge specifying the work material or articles complained of not- with- standing that the same may have been in advertantly passed, certified and paid for forth-with rectify or remove and reconstruct the work so specified in whole or in part as the case may require or as the case may be, remove the materials and articles so specified and provide other proper and suitable articles at his own proper charge and cost, and in the event of his failing to do so within a period to be specified by Engineer-in-charge in his demand aforesaid the Engineer-in-charge may rectify or remove and re-executed the work or remove and replace with others, the materials or articles complained of as the case may be at the risk and expenses of the contractor in all respects of the contract.

Clause No.16

Work to be open to inspection:-

All work under or in the course of execution or executed in pursuance of the contract shall at all times be open to the inspection and supervision of the Engineer-in-charge and his subordinates, and the contractor shall at all times during the usual working hours and at all other time, at which reasonable notice of the Engineer-in-charge or his subordinate to visit the works shall have been given to the contractor, either himself be present to receive orders and instructions, or have a responsible agent duly authorized in writing to be present for that purpose. Orders given to the contractor's agent shall be considered to have the same force as if they had been given to the contractor himself.

Clause No.17

Notice to be given before work is covered up:-

The contractor shall give not less than seven days notice in writing to the Engineer-in-charge or his subordinate in charge of the work before covering up or otherwise placing beyond the reach of measurement any work such as Earthwork, Base Concrete, Reinforcement in R.C.C work, or other hidden work etc in order that the same may be measured and correct dimension thereof be



taken before the same is so covered up or placed beyond the reach of measurement and shall not cover up or place beyond the reach of the measurement any work without the consent in writing of the Engineer-in-charge or his subordinate in charge of the work, and if any work shall be covered up or placed beyond the reach of measurement without such notice having been given or consent obtained the same be uncovered at the contractor's expenses, or in default hereof no payment or allowances shall be made for such work of the materials with which the same was executed.

Clause No.18

<u>Contractor liable for damage done and for imperfection during the defect liability period :-</u>

If the contractor or his work people or servants shall break, deface injure or destroy any part of a building in which they may be working, or any building, road, fence, enclosure, grass land or cultivated ground contiguous to the premises on which the work or any part of it being executed, or if any damage shall happen to the work while in progress from any cause whatever, or any defect shrinkage or other faults appears in it within the defect liability period starting after a certificate final or otherwise of its completion shall have been given by the Engineer-in-Charge as aforesaid, the contractor shall make the same good at his own expense, or in default, the Engineer-in-Charge may cause the same to be made good by other workmen and deduct the expenses (of which the certificate of the Engineer-in-Charge shall be final) from any sum that may then or at any time thereafter, becomes due to the contractor or form his performance guarantee, security deposit or the proceeds of the sale thereof or a sufficient portion thereof or in any other manner, legally permissible. The defect liability period shall be 12 months from the date of completion of the contract for non bituminous works and 24 months from the date of completion of the contract for bituminous works. Performance guarantee shall be refundable after the defect liability period after deducting amount if any as above.

Clause No.19

Contractors Supply, plant, ladders, scaffoldings etc:-

The contractor shall supply at his own cost all materials (except such special materials, if any as may in accordance with the contract, be supplied from the Engineer-in-charge's stores) plant, tools, appliances, implements, ladders, cordage, tackle, scaffolding and temporary works requisite or proper for the proper execution of the work whether original, altered or substituted and whether included in the specifications or other document forming part of the contract or referred to in these conditions or not, which may be necessary for the purpose of satisfying or complying with the requirements of the Engineer-in-charge as to any matter as to which under these conditions he is entitled to be satisfied or which he is entitled to require together with carriage there after to and from the work. The contractor shall also supply without charge the requisite number of persons with the means and materials necessary for the purpose of setting out work and counting weighting and assisting in the measurement or examination at any time and from time to time, of the work or material, Failing his so doing the same may be provided by the Engineer-in-charge at the expenses of the contractor and the expenses may be deducted from any money due to the contractor under the contract or from his security deposit or the proceeds of sale thereof, or of a sufficient portion thereof. The contractor shall also provide all



necessary fencing and lights required to protect the public from accident and shall be bound to bear the expenses of defense of every suit, action, or other proceedings at law that may be brought by any person for injury sustained owing to neglect of the above precautions and to pay any damages and costs which may be awarded in any such suit, action, or proceedings to any such person, or which may with the consent of the contractor be paid to compromise any claim by any such person. If any equipment is issued departmentally rent will be recovered form the contractor's bills at current rates fixed by the Chief Engineer the terms of such issue to be ascertained by the contractor form the Engineer-in-charge in writing in advance.

Clause No.20

Subletting Contract:-

The contractor shall not assign or sublet without written approval of the officer accepting the contract on behalf of the Government in two bid system of tendering. The contractor may assign or sublet up to 50% of the contract value to the person and firm already registered in the department or to the person or firm having the same technical competency as per the respective class of registered contractor with prior approval, from the officer accepting the contract on behalf of the Government. And if the contractor shall assign or sublet his contract, without prior approval or attempt to do so, the Engineer-in- charge on behalf of the Government of Uttarakhand shall have power to adopt any of the courses specified in Clause-5 he may deem best suited in the interest of the Government.

Clause No.21

Action on account of influence:-

If the contractor attempts to bribe or provide gratuity gift, loan, perquisite reward or any pecuniary advance or otherwise, shall either directly or indirectly, be given, promised or offered by the contractor, or any of his servant or agents to any Public Officer or person in the employment of Government in any way relating to his office or employment or if any such officer or person shall become in any way directly or indirectly interested in the contract the officer accepting the contract, on behalf of the Government may thereupon by notice in writing rescind the contract, and the security deposit of the contractor shall there upon stand forfeited and be absolutely at the disposal of Government and the same consequence shall ensue as if the contract had been rescinded under clause 5 hereof and in addition the contractor shall not be entitled to recover or be paid for any work thereto or for actually performed under the contract

Clause No.22

The Contractor shall not for the execution of the work employ any labor under 15 years of age and within the limits of any cantonment, any female labour. For every breach of this covenant the contractor shall be liable to pay by way of liquidated damages such sums minimum Rs. Two thousand but not exceeding Rs. Five thousand as the Engineer-in-charge may fix and recover such sum by deduction from any sums which may be due, or may at any time thereafter becomes due to the contractor. The provision of The child labour (Prohibition and Regulation) Act 1996 shall be applicable

Clause No.23

(d) For claims or amount in dispute aggregating more than Rs. 5,00,000,00 crore (Rs. Five crore).

Three persons One of the rank of Chief Engineer Level-II, Uttarakhand, P.W.D second will be of the rank of Superintending Engineer Uttarakhand P.W.D and third will be law officer of the Department if available otherwise another Superintending Engineer Uttarakhand P.W.D as nominated by Engineer in Chief.

All disputes between the parties to the contract arising out of and relating to the contract shall after written notice by either to the contract to the other party, be referred to arbitration as above. Unless the parties otherwise agree, such reference shall not take place until after the completion or abandonment of the works or the determination of the contract. The venue of arbitration shall be a place or places as may be fixed by the arbitrator in his/their sole discretion.
