



निविदा की शर्तें—

1. निविदायें केवल उन्हीं पंजीकृत ठेकेदारों की मान्य होंगी, जिनका लो0नि0वि0 में ठेकेदारी में श्रेणी “डी” अथवा “डी” से उच्चतर पंजीकरण होगा तथा उन्हीं के नाम पर जे0सी0बी0/एक्सकावेटर मशीन का पंजीकरण होगा। इसके लिये ठेकेदारों को निविदा के साथ अपना पंजीकरण प्रमाण—पत्र तथा जे0सी0बी0/एक्सकावेटर मशीन का पंजीकरण की छायाप्रति संलग्न करना अनिवार्य होगा, अन्यथा उनकी निविदा निरस्त कर दी जायेगी।



1. मार्ग खोलने हेतु जे०सी०बी० द्वारा किए गए कार्य की मात्राएं मानसून पर निर्भर हैं जिस का पूर्वानुमान नहीं लगाया जा सकता इन मात्राओं में कितनी भी भिन्नता हो सकती है। मात्रा कम होने पर कार्य पूर्ण नहीं माना जाएगा। विभिन्नता हेतु ठेकेदार का किसी भी प्रकार का कोई भी दावा मान्य नहीं होगा।
2. ठेकेदार को जे०सी०बी० मशीन मांग के अनुसार आवश्यकता वाले स्थानों पर 2 घंटे के अंदर उपलब्ध करानी होगी जिसके लिए अतिरिक्त धनराशि देय नहीं होगी।
3. भुगतान विभाग के सक्षम अधिकारी/कर्मचारी द्वारा भरी गई लॉग बुक के सत्यापन उपरांत अनुदान की उपलब्धता के आधार पर किया जाएगा।

SECTION-1: INSTRUCTIONS TO BIDDERS

1.0 Online Tenders are hereby invited by Chief Executive Director (Envt. & CM), WAPCOS Limited, Gurugram, Haryana on behalf of Uttarakhand Rural Road Development Agency (URRDA) (hereinafter referred to as “Employer”) from reputed and experienced firms/contractor registered in Class-D and above in PWD or equivalent department (hereinafter referred to as “Bidder”) for **Emergency Maintenance of Roads including Slip Clearance and Construction of Protection Works under PMGSY in Uttarakhand damaged during Monsoon Period (Jun-September) for Year 2025-26**” in Almora, Bagheshwar, Mori and Tehri Districts as mentioned in the NIT. Any kind of JV / Consortium is not allowed for this work.

2.0 Bid Validity

The offer(s) shall be valid for a period of 45 (Forty five days) from the date of opening the tender. Conditional bids shall be rejected.

3.0 Scope of Work

The Scope of work includes clearance and Removal of Slip on road as specified in the drawing and estimate and instructed by PIU In-charge suitable as per site conditions. Rates shall be quoted by the interested bidder in the prescribed format of BOQ only including all construction and labour charges for execution of the work at site. Quantities included in the BOQ are tentative and shall be executed as and when required in case of emergency only. Payment shall be made to the contractor only on the basis of actual execution/measurements of work at site. Running bill shall be made as per actual progress of work at site. All Payments shall be made to contractor on Back-to-Back basis only on availability of funds/Receiving from the client.

4.0 Essential Qualification Criteria

- a. Bidders must be registered in Class-D and above category with the PWD or equivalent department. Registration Certificate shall be provided by the bidder along with his Bid.
- b. Bidder must have the proof of ownership like RC etc. of the JCB Machine / Excavator (as per condition mentioned in NIT) to be engaged for the mentioned work. All relevant documents in support with shall be provided by the bidder in his Bid.
- c. Bidder must have experience of Construction of Road / Protection Works with-in last 7 Years in the following manner:

One (01) Similar executed work costing not less than 80% of the estimated cost of work.

or

Two (02) Similar executed works of order value each not less than 50% of the estimated cost of work.

or

Three (03) similar executed works of order value not less than 40% of the estimated cost of work.

As a proof, Work Order and Completion Certificate shall be submitted by the bidder in his bid.

- d. Bidder must have valid PAN and GST registration number.
- e. Average Annual Financial Turnover should be at least 50% of the estimated cost of work during the last 3 consecutive Financial Years.
- f. The bidder should not have incurred any loss in more than 2 years in last five financial years. Audited Balance Sheets shall be submitted in its support.

5.0 Bid Document Fee and Earnest Money Deposit

The bidders are requested to submit **Earnest Money Deposit (EMD) in the form of FDR** and **Bid Fee in the form of DD** issued from any nationalized / commercial bank with his bid for the amount mentioned in the NIT against the road work in the name of **WAPCOS Limited**. EMD must be submitted by the bidder along with his bid, failing which his bid shall out rightly be rejected.

6.0 Submission of Bid

Bids shall be submitted online on PMGSY Tendering Portal <https://www.pmgsytendersuk.gov.in>. Technical and Financial Bids shall be submitted online up to the specified last date and time of bid submission.

13.0 Arbitration

13.1 Resolution of Disputes

Except where otherwise provided in the contract, all questions and disputes relating to the work or the execution or failure to execute the same whether arising during the progress of the work or after the cancellation, termination, completion or abandonment thereof shall be dealt with as mentioned hereinafter:

If the Selected Agency considers any work or any matter in connection with or arising out of the contract or carrying out of the work, to be unacceptable and is resulting in a dispute, it shall be referred to the Nodal Officer from WAPCOS who shall, within a period of thirty days after being requested by the Selected Agency to do so, give written decision to the Selected Agency. Upon receipt of the written decision of the Nodal Officer, the Selected Agency shall promptly proceed without delay to comply with such decision.

13.2 Adjudication of Disputes

Any dispute, controversy or claims arising out of or relating to this Agreement or the breach, termination or invalidity thereof, shall be settled though following mechanism :-

- a. Firstly, the aggrieved party shall write a letter to the other party detailing its grievances and calling upon the other party to amicably resolve the dispute by convening a joint meeting. Accordingly, the parties as per their convenience shall jointly convene the said meeting(s), wherein minutes of the said meeting(s) shall be prepared and countersigned by all the parties. It is mandatory to prepare minutes of meeting(s) and to be countersigned by all the parties, irrespective of the outcome of the said meeting(s).
- b. In the event the parties are unable to reach on any settlement in the said meeting(s), then the aggrieved party shall mandatory resort to pre-litigation mediation mechanism with Delhi High Court Mediation Cell, New Delhi.
- c. It is only upon failure of the pre-litigation mediation mechanism with Delhi High Court Mediation Cell, and then the aggrieved party shall resort to resolution of disputes through arbitration of a Sole Arbitrator. The appointing authority of Sole Arbitrator is CMD, WAPCOS Limited, to which neither of the parties have any objection nor they shall ever objected.
- d. Subject to the parties agreeing otherwise, the Arbitration proceedings shall be conducted in accordance with the provisions of the Indian Arbitration and Conciliation Act, 1996 (amended as on date).
- e. It is also acknowledged and accepted that WAPCOS is only working as Intermediary between the Associate/Sub-Consultant/ Sub-Contractor and the Client, thus in the event, any dispute arises under the present agreement and referred to Arbitration for adjudication, then subject to

corresponding clause in the Contract/ Agreement/ Work Order/ Arrangement between Client & WAPCOS, Client shall also be made party to the said Arbitration proceedings. Also, the award including costs if any passed against WAPCOS and costs incurred in the proceedings shall be the sole responsibility of Principle Employer/ Client. The said clause if found inapplicable, even then the other terms of the Arbitration Clause shall survive and shall be acted upon.

- f. The place/seat of arbitration shall be Delhi and award whether interim or final, shall be made, and shall be deemed for all purpose between the parties to be made, in Delhi. The arbitral procedure shall be conducted in English language and any award or awards shall be rendered in English. The procedural law of the arbitration shall be Indian Law. The award of the arbitrator shall be final and conclusive and binding upon the Parties.
- g. The contract and any dispute or claim arising out of or in connection with it or its subject matter of formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the laws of India and the Parties submit to sole & exclusive jurisdiction of courts at Delhi.

14.0 Incomplete tenders, conditional tenders, tenders received after the stipulated time shall be summarily rejected.

15.0 Employer reserves the right to reject any or all bids without assigning any reason.

Conditions to withheld the amount in case of non- achievement of milestone:-

- (4.1) If the work is not started by the end of the time given for the first milestone, the agreement shall be immediately finalized and the performance security shall be forfeited.
- (4.2) If the work is started just before the lapse of the first milestone, but not completed by the time given for the grace period, 2.50% of the contract value shall be withheld and it shall only be refundable incase of compensating the target of the first milestone along with the second milestone within the scheduled time of second milestone.
- (4.3) In the event of non achieving the necessary progress as per the second milestone additional 3.50% of the contract value shall be withheld and the total 6.0% withheld money shall only be refundable if the required progress upto second milestone is achieved alongwith the third milestone within the scheduled time of third milestone.
