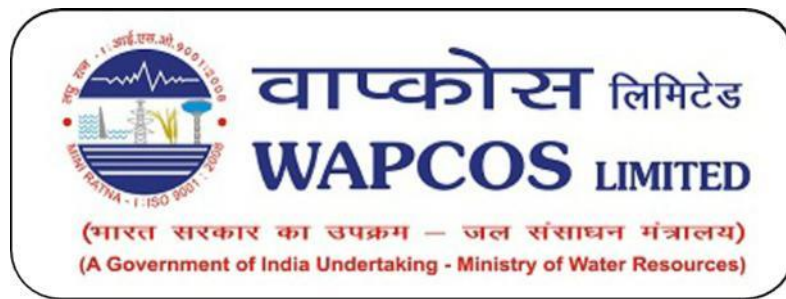

3. **Submission of Original Documents:** The bidders are required to submit documents e.g. Affidavits for correctness of information as mentioned in the quotation Document, Bid Fee, Bid Validity, Bid Security and Bank Solvency etc. in original by Post or by hand in the office of Resident Engineer, WAPCOS Limited, PIU-Kapkot, Distt. Bagehswar, Uttarakhand upto **date 05.07.2025 upto 1:00 PM**, failing which the bids will be declared as non- responsive.
4. **Last Date/ Time** for receipt of bids through Quotation **05.07.2025 upto 01:00 PM**.
5. The site for work is available. The Bidder, at his own cost, responsibility and risk, is required to visit, examine and familiarize himself with the site of works.
6. **Bid Opening:** Only online submission of bids is permitted, therefore; bids must be submitted online on website www.pmgsytendersuk.gov.in. The technical qualification part of the bids will be opened online on **05.07.2025 at 03:00 PM** by the authorized officers. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time.
7. **Bid Validity:** The bids for the work shall remain valid for acceptance for a period not less than **45 Days** after the deadline date for bid submission.
8. All bidders are required to quote their item rates excluding Goods and Service Tax (GST) and all taxes falling within purview of GST-Act 2017 but including labour cess, royalty etc. Payment of GST and required deductions in this reference will be made as per prevailing rules.
9. Payment shall be done on back to back basis on receiving the same from client.
10. Other details can be seen in the bidding documents. The Employer shall not be held liable for any delays due to system failure beyond its control. SECTION-1: INSTRUCTIONS TO BIDDERS

- 1.0** Online Bids are hereby invited by Chief Executive Director (Env. & CM), WAPCOS Limited, Gurugram, Haryana on behalf of State Administration from which the fund is allocated (hereinafter referred to as “Employer”) from reputed and experienced firms/contractor registered in Class-D or above with PWD/CPWD or equivalent department (hereinafter referred to as “Bidder”) for Reconstruction work of damaged wall from Km-1.00 to 3.00 and 4.00 to 7.00 of Bhanar Lethi to Namti Chetabagar Motor Road. Block-Kapkot, Distt. Bageshwar under Natural Disaster 2024-25.

2.0 Bid Validity

The offer(s) shall be valid for a period of 45 (Forty Five days) from the date of opening the tender. Conditional bids shall be rejected.

3.0 Scope of Work

This motor road was constructed under Pradhan Mantri Gram Sadak Yojna (PMGSY) Scheme. This road was damaged at several places during the heavy rain occurred (Deviya Aapda) in the project area in Monsoon year 2024-25. Fund has been allocated by the District Magistrate, Bageshwar for the Reconstruction work of damaged wall of the said road-

vide their letter no 471/ तेरह-डी०डी०एम०ए०/2024-25, दिनांक 30 मार्च, 2025. The Scope of work includes protection work as specified in the drawing and estimate and instructed by PIU In-charge suitable as per site conditions. Rates shall be quoted by the interested bidder in the prescribed format of BOQ only including all construction and labour charges for execution of the work at site. Payment shall be made to the contractor only on the basis of actual execution/measurements of work at site. Running bill shall be made as per actual progress of work at site. All Payments shall be made to contractor on Back-to-Back basis only on availability of funds/Receiving from the client.

4.0 Site Visit

The Bidder, at his own cost, responsibility and risk, is required to visit, examine and familiarize himself with the site of works. The bidder acknowledges that prior to the submission of the bid, the Bidder has, after a complete and careful examination, made an independent evaluation and understanding of the scope of the work, specifications and standards of design, site local conditions, availability of approaches to the site etc.

5.0 Estimated Cost of Work

Sanctioned Cost of the work is **Rs. 4.23 Lacs** excluding GST. Quantities have been assessed on the basis of damages caused at site and sanctioned under State Disaster Recovery Fund (SDRF). GST

shall be paid extra at prevailing rates.

6.0 Essential Qualification Criteria

- a. Bidders must be registered in **Class D or above** with PWD/CPWD or equivalent department. Registration Certificate shall be provided by the bidder along with his Bid.
- b. Bidder must have experience of Construction of Road / Protection Works with-in last 7 Years in the following manner:

One (01) Similar executed work costing not less than 80% of the estimated cost of work.

or

Two (02) Similar executed works of order value each not less than 50% of the estimated cost of work.

or

Three (03) similar executed works of order value not less than 40% of the estimated cost of work.

As a proof, Work Order and Completion Certificate shall be submitted by the bidder in his bid.
- c. Bidder must have valid PAN and GST registration number.
- d. Average Annual Financial Turnover should be at least 50% of the estimated cost of work during the last 3 consecutive Financial Years.
- e. The bidder should not have incurred any loss in more than 2 years in last five financial years. Audited Balance Sheets shall be submitted in its support.

7.0 Bid Document Fee and Earnest Money Deposit

The bidders are requested to submit the **Bid Security / Earnest Money Deposit of Rs. 8,500/-** with his Bid, failing which his bid shall out rightly be rejected. EMD shall be submitted in the form of Fixed Deposit Receipt (FDR) only of a scheduled commercial bank in favor of **WAPCOS Limited**, Sector-18, Gurgaon, Haryana payable at Delhi. EMD shall be valid for minimum 45 Days beyond the validity of bid.

8.0 Submission of Bid

Bids shall be submitted online and all tendering process will be completed on the Uttarakhand PMGSY online tendering portal <https://www.pmgsytendersuk.gov.in>.

Technical and Financial Bids shall be submitted online upto the specified last date and time of bid submission.

The bidder shall submit as Part-I, marked as Technical Bid and Part-II, marked as Financial Bid. All the documents are required to be counter signed by the bidder.

Hard copy of the bid along with following documents shall be submitted to the office address as mentioned in the SHORT NOTICE INVITING TENDER (SNIT).

- Affidavit for correctness of information provided in the bid document on a non-judicial stamp paper of Rs.10/- and shall be attested by Magistrate/ Sub-Judge/ Notary Public
- Bid Fee in Original in form of Demand Draft

- Bid Validity on Rs. 100/- Non-Judicial Stamp Paper with Rs. 1/- revenue stamp
- Bid Security / Earnest Money Deposit in Original (FDR)
- Bank Solvency Certificate

Aforementioned documents are required to be submitted in original up to specified date and time mentioned in the NIQ either by registered post/ courier service or by hand, failing which the bid will be declared as non- responsive. WAPCOS shall not be responsible for any postal delay on any account. In case date of submission happens to be holiday, then documents may be submitted on next working day.

9.0 Technical Bid

The Technical Bid submission forms are enclosed as Schedule-A respectively.

9.1 Bidders shall submit the bid in the formats provided in the Bid Document. Bid shall include the following documents/reports:

1. Contractor's Registration Certificates
2. Bidder must have valid PAN and GST Number. Copy of PAN Card copy and GST Registration shall be provided by the bidder.
3. Affidavit for correctness of information provided in the bid on a non-judicial stamp paper of Rs.10/- and shall be attested by Magistrate/ Sub-Judge/ Notary Public)
4. Bid Validity on Rs. 100/- non judicial stamp paper with Rs. 1.00 Revenue ticket.
5. Bid Fee and EMD as specified
6. Bidder must have experience of construction of Road/Protection Works with-in last 7 Years. In proof, Work Order and Completion Certificate shall be submitted by the bidder in his bid.
7. Bank Solvency Certificate 40% to the estimated cost of work and duly addressed to the Employer and having work name is to be submitted by the bidder along with his Technical Bid. Solvency Certificate must have been issued after the date of publication of NIT & be addressed to the tendering authority quoting the name of work.

9. Average Annual Financial Turnover should be at least 50% of the estimated cost of work during the last 3 consecutive Financial Years. In this regard, Chartered Accountant Certificate with UDIN shall be submitted by the bidder.
10. Turnover, Profit, Net Worth certificates must be certified by the statutory auditor of the

firm/company. Any such certificates must carry the UDIN (Unique Document Identification Number)

11. The bidder should not have incurred any loss in more than 2 years in last five financial years.
12. Counter Signed copy of this document as a token of acceptance of the Terms & Conditions
13. Firm should not be blacklisted from any government organization during last 3 years. An Undertaking shall be submitted by the bidder in this regard.

9.2 WAPCOS reserves the right to verify all statements, information and documents, submitted by the Agency in the Bid. Any such verification or the lack of such verification by the WAPCOS to undertake such verification shall not relieve the Agency of its obligations or liabilities hereunder nor will it affect any rights of WAPCOS there under.

10.0 Financial Bid

10.1 The Agency should quote considering all the items as listed in the **Scope of Works**. The quoted amount shall be inclusive of all prevalent taxes in the country such as GST etc. Rates shall be quoted by the interested bidder in the prescribed format of Bill of Quantities in excel file only provided online on PMGSY Tendering Portal..

10.2 The quoted rates/amounts shall cover the costs of executing all activities defined in scope of work. The quoted rates/amounts shall cover costs of remuneration, accommodation, lodging, boarding, transportation, insurance, equipment, material, and other expenses related to the Agency's staff/manpower and the works to be executed. The Agency shall not require or demand any other reward or compensation, either in the form of currency or in other forms, from WAPCOS. All the taxes/statutory duties etc. except GST required in the place of work shall be borne by the Agency.

10.3 The quoted rates/amounts shall be deemed to be firm throughout the project till the completion of work and shall not be subject to any adjustment due to increase in price of materials, utilities, taxes, duties etc. or any other input for performance of work and the contract.

10.4 Financial Bid shall be fill online on the prescribed tender portal only. No hardcopy of the financial bid shall be submitted by the bidder, if found so, shall be dis-qualified from the bidding process.

11.0 Time of Completion

The time period for the work is 01 months from the Date of Start of the work. Payment shall be made on the basis of actual progress at site and after receiving the funds/approval from the client.

12.0 Performance Security, Additional Performance Security & Security Deposit

Performance Security at the rate of 5% of the Contract Price shall be provided by the contractor to the employer at the time of signing of contract in the form of FDR/Performance Bank Guarantee from the nationalized or scheduled commercial banks acceptable to the

employer. This condition will prevail to the GCC GPW Form-9. No Performance shall be deducted from the running bill.

Security Deposit shall remain at the rate of 5% of the Contract Price that shall be deducted from the running bill of the contractor, as per the applicable GCC GPW FORM-9 of PWD Uttarakhand. All other Terms and Conditions regarding release shall be followed as per GPW FORM-9.

Additional Performance Security as mentioned at Cl. 3.1.1.3 GCC pg. 2 GPW FORM-9 is not applicable as per WAPCOS Circular dated 10.12.2020.

13.0 Payment Terms

Payment to the contractor is totally based on the actual execution of the work at site. Payment shall be made to the contractor only after completion of work at site on back-to-back basis on receiving the same from the client depending on availability of funds and authorization thereof.

The Associate/Sub-Contractor/Sub Consultant acknowledges that under the present Contract/Agreement/Work Order/Arrangement, WAPCOS is only working as intermediary between client Uttarakhand Rural Road Development Agency (URRDA) being Principal Employer/Client and Associate/Sub-Contractor/Sub-Consultant. Thus the Associate/Sub-Contractor/Sub-Consultant unconditionally acknowledges that the payments under the present Contract/Agreement/Work Order/Arrangement shall be made proportionately by WAPCOS only on back-to-back basis i.e. after 21 days subject to receipt of payments from client URRDA being Principal Employer/Client. The Associate/Sub-Contractor/Sub-Consultant also unconditionally agree that in the event the payment or part thereof, under the present Contract/Agreement/Work Order/Arrangement is not received from client URRDA (Principal Employer/Client), then WAPCOS &/or any of its Employee/Officer shall not be responsible to pay any amount to Associate/Sub-Contractor/Sub-Consultant. The said condition shall supersede any and all other conditions of Contract/Agreement/Work Order/Arrangement between the parties.

14.0 Price Escalation & Variation

No Price Escalation shall be allowed for the quoted rates of the bidder throughout the period of completion of the work. As the client has sanctioned the cost for the Emergency Maintenance work, no variation in quantities shall be allowed exceeding the sanctioned cost of the work.

15.0 Penalty / Liquidated Damages

If the contractor fails to maintain the required progress to complete the work and clear the site on or before the project completion period or extended date of completion, he shall pay or allow WAPCOS to deduct penalty as per Clause 4: Compensation of Delay of GCC pg. 3 GPW FORM-9, Government of Uttarakhand.

16.0 Arbitration

16.1 Resolution of Disputes

Except where otherwise provided in the contract, all questions and disputes relating to the work or the execution or failure to execute the same whether arising during the progress of the work or after the cancellation, termination, completion or abandonment thereof shall be dealt with as mentioned hereinafter:

If the Selected Agency considers any work or any matter in connection with or arising out of the contract or carrying out of the work, to be unacceptable and is resulting in a dispute, it shall be referred to the Nodal Officer from WAPCOS who shall, within a period of thirty days after being requested by the Selected Agency to do so, give written decision to the Selected Agency. Upon receipt of the written decision of the Nodal Officer, the Selected Agency shall promptly proceed without delay to comply with such decision.

16.2 Adjudication of Disputes

Any dispute, controversy or claims arising out of or relating to this Agreement or the breach, termination or invalidity thereof, shall be settled through following mechanism :-

- a. Firstly, the aggrieved party shall write a letter to the other party detailing its grievances and calling upon the other party to amicably resolve the dispute by convening a joint meeting. Accordingly, the parties as per their convenience shall jointly convene the said meeting(s), wherein minutes of the said meeting(s) shall be prepared and countersigned by all the parties. It is mandatory to prepare minutes of meeting(s) and to be countersigned by all the parties, irrespective of the outcome of the said meeting(s).
- b. In the event the parties are unable to reach on any settlement in the said meeting(s), then the aggrieved party shall mandatory resort to pre-litigation mediation mechanism with Delhi High Court Mediation Cell, New Delhi.
- c. It is only upon failure of the pre-litigation mediation mechanism with Delhi High Court Mediation Cell, then the aggrieved party shall resort to resolution of disputes through arbitration of a Sole Arbitrator. The appointing authority of Sole Arbitrator is CMD, WAPCOS Limited, to which neither of the parties have any objection nor they shall ever objected.
- d. Subject to the parties agreeing otherwise, the Arbitration proceedings shall be conducted in accordance with the provisions of the Indian Arbitration and Conciliation Act, 1996 (amended as on date).
- e. It is also acknowledged and accepted that WAPCOS is only working as Intermediary between the Associate/Sub-Consultant/ Sub-Contractor and the Client, thus in the event, any dispute arises under the present agreement and referred to Arbitration for adjudication, then subject to corresponding clause in the Contract/ Agreement/ Work Order/ Arrangement between Client & WAPCOS, Client shall also be made party to the said Arbitration proceedings. Also, the award including costs if any passed against WAPCOS and costs incurred in the proceedings shall be the sole responsibility of Principle Employer/ Client. The said clause if found inapplicable, even then the other terms of the Arbitration Clause shall survive and shall be acted upon.
- f. The place/seat of arbitration shall be Delhi and award whether interim or final, shall be made, and shall be deemed for all purpose between the parties to be made, in Delhi. The arbitral procedure shall be conducted in English language and any award or awards shall be rendered in English. The procedural law of the arbitration shall be Indian Law. The award of the arbitrator shall be final and conclusive and binding upon the Parties.
- g. The contract and any dispute or claim arising out of or in connection with it or its subject matter of formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the laws of India and the Parties submit to sole & exclusive jurisdiction of courts at Delhi.

17.0 Incomplete tenders, conditional tenders, tenders received after the stipulated time shall be

summarily rejected.

18.0 Employer reserves the right to reject any or all bids without assigning any reason.

(a) The 'works or work' shall unless there be something either in the subject or context repugnant to such construction shall be construed and taken to mean the works by, or by virtue of the contract, contracted to be executed whether temporary or permanent and whether original, altered, substituted or additional. (b) The 'site' shall mean the land and/or other places on, into or through which work is to be executed under the contract, or any adjacent land path or street through which work is to be executed under the contract or any adjacent land path or street which may be allotted or used for the purpose of carrying out the contract. (c) The 'contractor' shall mean the individual or firm or company whether incorporated or not undertaking the works and shall include the legal personal representatives of such individual or the persons composing such firm or company or the successors of such firm or company and the permitted assign of such individual or firm or company. (d) The 'Governor' shall mean the Governor of Uttarakhand, his successor or assigns. (e) The Engineer-in-Charge shall mean the Executive Engineer the Assistant Engineer, as the case may be, who shall supervise and be in-charge of the work. (f) The 'Government' shall mean the Government of Uttarakhand. (g) The 'Chief Engineer' shall means Chief Engineer Level-II Public Works Department Uttarakhand (h) The 'Estimated Cost' shall means the cost of the work or works as estimated, on the basis of Approved rates by the competent authority . (i) The Department shall mean the Public Works Department, Uttarakhand. (j) Words importing the singular number include plural numbers and vice-versa.

Conditions to withheld the amount in case of non- achievement of milestone:-

(4.1) If the work is not started by the end of the time given for the first milestone, the agreement shall be immediately finalized and the performance security shall be forfeited.

(4.2) If the work is started just before the lapse of the first milestone, but not completed by the time given for the grace period, 2.50% of the contract value shall be withheld and it shall only be refundable incase of compensating the target of the first milestone along with the second milestone within the scheduled time of second milestone.

(4.3) In the event of non achieving the necessary progress as per the second milestone additional 3.50% of the contract value shall be withheld and the total 6.0% withheld money shall only be refundable if the required progress upto second milestone is achieved alongwith the third milestone within the scheduled time of third milestone.

The time allowed for execution of the work as specified in the Schedule "A" or the extended time in accordance with these conditions shall be an essence of the Contract. The execution of work shall commence from such time period as mentioned in the contract agreement. If the Contractor commits default in commencing the execution of the work as aforesaid, government shall without prejudice to any other right or remedy available in law ,be at liberty to forfeit the amount as mentioned above.

❖ As soon as possible after the contract is concluded, the Contractor shall submit a time and progress chart for each mile stone and get it approved by the Department. The chart shall be prepared in direct relation to the time stated in the Schedule 'A' above for completion of item of the works. It shall indicate the forecast of the dates of commencement and completion of various trades of sections of the work and may be amended as necessary by agreement between the Engineer-in-charge and Contractor within the limitation of time imposed in the contract documents .

	to the officer accepting the contract on behalf of the Government and shall request the Engineer-in-Charge to give him a certificate of completion but no such certificate shall be given nor shall the work be considered to be complete until the contractor shall have removed from the site, on which the work shall be executed all scaffolding, surplus materials and rubbish and cleared off the dirt from all wood work doors, windows, walls, floors, or other parts of any building in, upon or about which the work is to be executed or of which he may have had possession for the purpose of execution thereof, and he has filled up the pits. If the Contractor fails to comply with the requirements of this clause as to removal of scaffolding surplus materials and rubbish and cleaning of dirt and filling of pits on or before the date fixed for completion of the work, the Engineer-in-Charge may at the expense of the Contractor remove such scaffolding, surplus materials and rubbish and disposal of the same as he think fit and clean off such dirt and fill the pits as aforesaid, and the Contractor shall forth with pay the amount of all expenses so incurred and shall have no claim in respect of any scaffolding or surplus materials as aforesaid except for any sum actually realized by the sale thereof. On completion, the work shall be measured by the Engineer-in-Charge himself or through his subordinate, whose measurements shall be binding and conclusive against the contractor, provided that, in subsequent to the measurements taken by the subordinates as aforesaid the Engineer-in-Charge had reason to believe that the measurements by his subordinates are not correct, Engineer-in-charge shall have the power to cancel the measurements already taken by his subordinates and acknowledged by the Contractors and to take measurements again after giving notice to the contractor and remeasurements shall be binding on the contractors . Within fifteen days of the receipt of the notice, the Engineer-in-Charge shall inspect the work and if there is no visible defect on the face of the work, shall give the contractor a certificate of completion. If the Engineer-in-Charge finds that the work has been fully completed, it shall be mentioned in the certificate to be granted. On the other hand, if it is found that there are certain visible defects to be removed, the certificate to be granted by Engineer-in-charge shall specifically mention the details of the visible defects along with the estimate of the cost for removing these defects. The final certificate of completion of work shall be given after the visible defects pointed out as above have been removed.
Clause No.9	<u>Intermediate Payments :-</u> No Running payments shall be made for work estimated to cost less than Fifty thousand till after the work shall have been completed and a certificate of completion given. But in the case of works estimated to cost more than Rupees Fifty thousand, the contractor shall, on submitting the bill, thereof be entitled to receive a payment passed by the Engineer-in-charge whose certificate of such approval and passing of the sum so payable shall be final and conclusive against the contractor. The maximum amount of intermediate payment shall be limited upto 75 percent of the contract amount. All such intermediate payments shall be regarded as payments for works actually done and completed and shall not preclude bad, unsound and imperfect or unskilled work to be removed and take away and re-constructed or re-corrected, or it shall not be considered as an admission of the due performance of the contractor or any part thereof in any

	respect of the acquiring of any claim nor shall it conclude, determine or affect in any way the powers of the Engineer-in-Charge under these conditions or any of them as to the final settlement and adjustment of the accounts and otherwise or in any other way vary or affect the contract. The final bill shall be submitted by the contractor within one month of the date fixed for completion of the work or of the date of the certificate of completion furnished by the Engineer-in-Charge and payments shall be made within 3 months of submission of such bill. If there shall be any dispute about any items of the work then the undisputed item or items only shall be paid within the said period. The contractor shall submit a list of the disputed items within 30 days from the disallowances thereof and if he fails to do so his claim shall be deemed to have been fully waived and absolutely extinguished.
Clause No.10	<u>Contractors to be given a week to file objection to the measurement recorded by the department:-</u> Before taking any measurement of any work as has been referred to in clause 8,9 thereof, the Engineer-in-Charge or subordinate deputed by him shall give reasonable notice to the contractor. If the contractor fails to attend at the time of measurement after such notice or fails to countersign or to record the difference within a week from the date of measurement in the manner required by the Engineer-in-charge then in any such event the measurements taken by the Engineer-in-Charge or by the subordinate deputed by him as the case may be, shall be final and binding on the contractor and the contractor shall have no right to dispute the same.
Clause No.11	<u>Stores supplied by the Government:-</u> If the specification or schedule of the items provides for the use of any special description of material to be supplied from the Engineer-in-charge's store or if it is required that the contractor shall use certain stores to be provided by the Engineer-in-charge (such materials and stores and the prices to be charged thereof as here-in-after mentioned being so far as practicable for convenience of the contractor, but not so as in any way to control the meaning or effect of this contract, specified in the Schedule or memorandum here to annexed) the contractor shall be supplied with such materials and stores as are required from time to time to be used by him for the purpose of the contract only and the value of the full quantity of materials and stores so supplied at the Rates specified in the said scheduled or memorandum may be set off or deducted from any sums then due, or there after to become due to the contractor under the contract or otherwise or against or from the security deposit, or the proceeds of sale thereof, if the same is held in Government securities, the same or a sufficient portion thereof being in the case sold for the purpose. It shall be the responsibility of the contractor to ascertain from time to time, from the Engineer-in-Charge about the position of availability of the materials as afore mentioned and any delay on the part of the Engineer-in-charge to arrange supplies of the same shall not entitle the contractor to any compensation but in the event of all such delays the contractors shall be granted reasonable extension of time. All materials supplied to the contractor are the property of the contractor, but shall not on any account be removed from the site of the work, except with written permission of the Engineer-in-Charge or

	under his orders and shall at all times be open to inspection by the Engineer-in-charge. Any such materials unused and in-perfectly good condition at the time of completion or determination of the Contract may, by special arrangement be taken over by the Government at the prevailing market rates, if required for use on other works in progress provided that the price allowed shall not exceed the amount charged to the Contractor.
Clause No.12	<u>Works to be executed in accordance with specification, drawing etc:-</u> The contractor shall execute the whole and every part of the work in the most substantial and work-man like manner and both as regards materials and otherwise in every respect in strict accordance with the specification. The contractor shall also confirm exactly, fully and faithfully to the designs, drawings and instructions in writing relating to the work signed by the Engineer-in-Charge and lodged in his office, and to which the contractor shall be entitled to have access to such office, for the purpose of inspecting during office hours and the contractor shall be furnished free of charge one copy of the specification and of all such designs, drawings, and instructions not included in the detailed specifications for buildings and roads enforced from time to time or any other printed publications on general specifications referred to elsewhere in the contract.
Clause No.13	<u>Alteration in specification and design do not invalidate contract:-</u> The Engineer-in-charge shall have the authourity to make any alteration or omission from, additions to or substitution for the original specification, drawings, designs, and instructions that may appear to him to be necessary during the progress of the work and the contractor shall carry out the work in accordance with any instructions that may be given to him in writing singed by the Engineer-in-charge and such alterations, omission, addition, or substitutions shall not, invalidate the Contract any altered additions, or substituted work which the contractor may be directed to do in the manner as above specified as part of the work shall be carried out by the Contractor on the same conditions in all respect on which he agreed to do the main work. The time for the completion of the work shall be extended in the proportion that the altered, additional or substituted work bears to the original contract work and the certificate of the Engineer-in-charge shall be conclusive as to such proportion. The rates for such additional, altered or substituted work under this clauses shall be worked out in accordance with the following provisions in their respective order:- 13.1 If the Rate for the additional, altered, or substituted work are specified in the contract for the work, the Contractor is bound to carry out the additional, altered or substituted work at the same rates as are specified in the contract of the work. 13.2 If the rates for the additional, altered or substituted work include any work for which no rates are specified in the contract for the work or can not be derived from the similar class of work in the contract then such work shall be carried out at the rates entered in the Schedule of rates minus/plus percentage

	which the total tendered amount bears to the estimated cost of the entire work put to tender. 13.3 If the rates for the additional, altered or substituted work are not specifically provided in the contract for the work, the rate will be arrived from the rates for similar class of work, as are specified in the contract for the work. 13.4 If the rates for the additional, altered or substituted work can not be determined in the manner specified in sub clauses 13.1 to 13.3 above, the rates for such work shall be worked out on the basis of the Schedule of Rate minus/plus the percentage which the total tendered amount bears to the estimated cost of the entire work put to tender, provided always that if the rates for a particular part or parts of the item is not in the Schedule of rate, rate for such part or parts will be determined by the officer accepting the contract and approved by next higher to the officer accepting the contract on behalf of the Government on the basis of the prevailing market rates when the work was done. 13.5 If the rates of the additional, altered or substituted work can not be determined in the manner specified in sub clause 13.1 to 13.4 above, then the contractor shall within 7 days of the date of receipt of the order to carry out the work inform the officer accepting the contract on behalf of the Government of the rate which it is his intension to charge for such class of work, supported by analysis of the rates claimed and the Superintending Engineer shall determine the rate or rates on the basis of the prevailing market rates and pay the contractor accordingly. However the officer accepting, the contract on behalf of the Government by notice, in writing will be at liberty to cancel his order to carry out such class of the work and arrange to carry it out in such manner as he may consider advisable. But under no circumstances, the contractor, shall suspend the work on the plea of non settlement of rates of items, falling under this clauses:- The quantities for the additional, altered or substituted work and the rates thereof under sub-clause (1) to (3) shall be worked out by the officer accepting the contract on behalf of the Government and shall be approved by the officer next higher to the officer accepting the contract.
Clause No.14	<u>No compensation for alteration in or restriction of the work to be carried out:-</u> If at any time after the commencement of the work the Government of Uttarakhand or the Chief Engineer shall for reason whatsoever not require the whole work thereof as specified in the tender to be carried out, the Engineer-in-charge shall give notice in writing of the fact to the contractor who shall have no claim to any payment or compensation whatsoever on account of any profit or advantage, which he might have derived from the execution of the work in full, but which he did not derive in consequence of the full amount of the work not having been carried out, neither shall have any claim for compensation by reason of any alteration having been made in the original specifications, drawings, designs, and instructions which shall involve any curtailment of the

In the event of this option not being exercised, the contractor may submit to the Engineer-in-charge within one month of the date of the order closing down the work a detailed statement of the loss that estimate he will sustain by removing, selling or otherwise disposing of the materials. The estimate will be forwarded to the Chief Engineer who will decide what sum, if any, should as a matter of grace be paid to the contractor to compensate him for the loss suffered by him and the decision of Chief Engineer shall be final and binding on the contractor.
Clause No.15	<u>Action and compensation payable in case of bad work:-</u> If it shall appear to the Engineer-in-charge or his subordinate-in-charge of the work, that any work has been executed with unsound, imperfect, unskillful workmanship or with materials of any inferior description or that any materials or articles provided by him for the execution of the work are unsound or of a quality inferior to that contracted for or otherwise not in accordance with the contract, the contractor shall, on demand in writing from the Engineer-in-charge specifying the work material or articles complained of not- with- standing that the same may have been in advertantly passed, certified and paid for forth-with rectify or remove and reconstruct the work so specified in whole or in part as the case may require or as the case may be, remove the materials and articles so specified and provide other proper and suitable articles at his own proper charge and cost, and in the event of his failing to do so within a period to be specified by Engineer-in-charge in his demand aforesaid the Engineer-in-charge may rectify or remove and re-executed the work or remove and replace with others, the materials or articles complained of as the case may be at the risk and expenses of the contractor in all respects of the contract.
Clause No.16	<u>Work to be open to inspection:-</u> All work under or in the course of execution or executed in pursuance of the contract shall at all times be open to the inspection and supervision of the Engineer-in-charge and his subordinates, and the contractor shall at all times during the usual working hours and at all other time, at which reasonable notice of the Engineer-in-charge or his subordinate to visit the works shall have been given to the contractor, either himself be present to receive orders and instructions, or have a responsible agent duly authorized in writing to be present for that purpose. Orders given to the contractor's agent shall be considered to have the same force as if they had been given to the contractor himself.
Clause No.17	<u>Notice to be given before work is covered up:-</u> The contractor shall give not less than seven days notice in writing to the Engineer-in-charge or his subordinate in charge of the work before covering up or otherwise placing beyond the reach of measurement any work such as Earthwork, Base Concrete, Reinforcement in R.C.C work, or other hidden work etc in order that the same may be measured and correct dimension thereof be

Clause No.18	<u>Contractor liable for damage done and for imperfection during the defect liability period :-</u> If the contractor or his work people or servants shall break, deface injure or destroy any part of a building in which they may be working, or any building, road, fence, enclosure, grass land or cultivated ground contiguous to the premises on which the work or any part of it being executed, or if any damage shall happen to the work while in progress from any cause whatever, or any defect shrinkage or other faults appears in it within the defect liability period starting after a certificate final or otherwise of its completion shall have been given by the Engineer-in-Charge as aforesaid, the contractor shall make the same good at his own expense, or in default, the Engineer-in-Charge may cause the same to be made good by other workmen and deduct the expenses (of which the certificate of the Engineer-in-Charge shall be final) from any sum that may then or at any time thereafter, becomes due to the contractor or from his performance guarantee, security deposit or the proceeds of the sale thereof or a sufficient portion thereof or in any other manner, legally permissible. Clause No.19	<u>Contractors Supply, plant, ladders, scaffoldings etc:-</u> The contractor shall supply at his own cost all materials (except such special materials, if any as may in accordance with the contract, be supplied from the Engineer-in-charge's stores) plant, tools, appliances, implements, ladders, cordage, tackle, scaffolding and temporary works requisite or proper for the proper execution of the work whether original, altered or substituted and whether included in the specifications or other document forming part of the contract or referred to in these conditions or not, which may be necessary for the purpose of satisfying or complying with the requirements of the Engineer-in-charge as to any matter as to which under these conditions he is entitled to be satisfied or which he is entitled to require together with carriage there after to and from the work. The contractor shall also supply without charge the requisite number of persons with the means and materials necessary for the purpose of setting out work and counting weighting and assisting in the measurement or examination at any time and from time to time, of the work or material, Failing his so doing the same may be provided by the Engineer-in-charge at the expenses of the contractor and the expenses may be deducted from any money due to the contractor under the contract or from his security deposit or the proceeds of sale thereof, or of a sufficient portion thereof. The contractor shall also provide all

If any equipment is issued departmentally rent will be recovered from the contractor's bills at current rates fixed by the Chief Engineer the terms of such issue to be ascertained by the contractor from the Engineer-in-charge in writing in advance.
Clause No.20	<u>Subletting Contract:-</u> The contractor shall not assign or sublet without written approval of the officer accepting the contract on behalf of the Government in two bid system of tendering. The contractor may assign or sublet up to 50% of the contract value to the person and firm already registered in the department or to the person or firm having the same technical competency as per the respective class of registered contractor with prior approval, from the officer accepting the contract on behalf of the Government. Five thousand as the Engineer-in-charge may fix and recover such sum by deduction from any sums which may be due, or may at any time thereafter becomes due to the contractor. Except for such protest or objections, as are made on record in the manner here in specified and within the time limit stated the record, ruling instructions or decisions of the appellate officer as above shall be final and conclusive. Instructions and/ or decisions of the appellate officer contained in letters transmitting drawings to the contractor shall be considered as written instructions or decision subject to protest objections as wherein provided.
