

"If the work is awarded to me, I/We shall obtain GST registration

certificate of the state in which work is to be taken up within one month from the date of receipt of award letter or before release of any payment by WAPCOS Ltd., whichever is earlier, falling which I/We shall be responsible for delay in payment which will be due towards me /us on account of work executed and/or for any action taken by WAPCOS or GST Department in this regard.

- 1.2.2 Any tenderer, (proprietorship firms, partnerships firms, companies, corporations) registered with Government Organizations are eligible to participate in the tender. A self-attested scan copy in respect of valid registration/enlistment with the respective authorities is to be submitted. To judge their qualification, all bidders should be asked to include the following information and documents with their bids:
  - i) Copies of original Registration certificate documents defining the constitution or legalstatus, place of registration, and principal place of business; written power of attorney of the signatory of the Bid to commit the Bidder. Appropriate business licences/registrations:
    - a) Service Tax registration certificate
    - b) PAN number
    - c) Copies of EPF, ESI, Labour license
    - d) Copy of valid license under the Private Security Agencies (Regulation) Act, 2005 or the similar Act/ Rules promulgated by State in which the service is performed (in case of Security Service)
  - ii) Total monetary value of Services performed for each of the last five years;
  - iii) Proposals for subcontracting components of the Services amounting to more than 10(ten) percent of the Contract Price.
- 1.2.3 The work completion certificate should mention the details of work executed and the date of completion of the work in the last Seven years and in hand should be certified by an officer not below the rank of First class officers or equivalent. The work completion certificate should be as per standard format. The bidder must provide valid official email ID and contact number of issuing authority of completion certificate on his letter head. The confirmation of work certificate will be taken at the time of evaluation and the receivings through personal ids/ domains containing yahoo, rediff, gmail etc. not be accepted.
- 1.2.4 Bidders are permitted to form JV/ Consortium. The clauses as given below shall be applicable for consortium.
  - (i) In case of a JV/ consortium, certified copy of the agreement between various partners shall be submitted with the tender.
  - (ii) The JV/ consortium will identify a lead partner who will be authorised to execute the contract with the department. All financial transactions and liabilities shall rest with the lead partner.
  - (iii) In the case of a JV or Consortium, all members of the group shall be jointly and severally liable for the performance of whole contract.
  - (iv) A tenderer shall submit only one bid in the same tendering process, either individually as a tenderer or as a partner of JV/Consortia.

- (v) The consortium /Joint Venture shall nominate a Representative who shall havethe authority to conduct all business for and on behalf of any and all the membersof the JV during the bidding process and, in the event the JV is awarded theContract, during contract execution.
- (vi) Number of the members/firms in a joint venture shall not be more than two including the lead partner
- (vii) The lead partner of the Joint Venture/Consortium shall have experience in drilling where construction of groundwater well as component of scope of work and other party shall be manufacturer of DWLRs.
- (viii) JV members are jointly and severally responsible and liable for the contract. For pre- qualification, the JV should fulfil the criteria specified in the pre-qualification document. The attributes to be evaluated will be the same as for individual contractors; however, certain parameters up to the specified limits have to be essentially met by them collectively, some by the lead partner, and some by the other partner, as briefly described below:

#### I. Qualifying factors for lead partner:

- (A) Not less than of 50 (fifty) percent of the respective limits of above criteria prescribed in case of individual contractors may be accepted;
- **II.** Qualifying factors for other partner: Same as for lead partner except that for the factors specified in (II) above, a lower limit of 25 (twenty-five) per cent.
- ix. A tenderer shall submit only one bid in the same tendering process, either individually as a tenderer or as a partner of a consortium /Joint Venture.
- x. Number of the members/firms in a joint venture shall not be more than Two including the lead partner
- 1.2.5 Average annual turnover of bidder from similar work should be at least 50% of the estimated cost of work during the immediate last 3 (Three) consecutive financial years ending 31<sup>st</sup> March, 2024 and duly certified by Chartered Accountant. Any such certificate must carry the UDIN (Unique Document Identification Number). Year in which no turnover is shown would also be considered for working out the average. Calculated by applying anappropriate multiplier to the projected annual construction expenditure on the subjectcontract.
- 1.2.6 The bidder must have experience of having successfully completed similar works during last seven (7)years ending last day of month previous to the one in whichapplications are invited should be either of the following:
  - (a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost each.

or,

(b) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost each.

or,

(c) One similar completed work costing not less than the amount equal to 80% of the estimated cost each.

The value of the executed work shall be brought to the current costing level by enhancing the actual value of works at simple rate of 7% per annum, calculated from the date of completion to the date of Bid opening.

"Certificate for 'substantial completion' of project/work/asset should contain two parts.Part -I shall contain 'financial value of work done' and part-II shall contain 'certificate offunctional completion of project/work/asset'."

#### **Equipment and Managerial Capability:**

- a) Ownership/ proposals for the timely acquisition (own, lease, hire, etc.) of theessential equipment listed in the BDS;
- b) A Contract Manager with five years' experience in Services of an equivalentnature and volume, including no less than three years as Manager;

Similar Nature of Work: "Drilling, Construction of Monitoring/Piezometer Wellsfor Groundwater Monitoring and DWLR Installations, executed for any CentralGovt. / State Govt./ PSUs/ Other Govt. Departments".

- 1.2.7 The bidder should not have incurred any loss (profit after tax should be positive) in more than two year during available last five consecutive balance sheets, duly certified and audited by the chartered accountant. Yearly Turnover and audited balance sheet for last 5 years ending the financial year 2023-24 duly certified by chartered accountant should be submitted. Any such ceritificate must carry the UDIN (Unique document identification number).
- 1.2.9 The bidder shall have sufficient construction equipments and manpower to carry out the works and shall submit details of such machinery, which he propose to deploy as per format enclosed.

The bidder must ensure to deploy required equipment as proposed in the format within the mobilization period till the completion of the project, otherwise WAPCOS shall be free to terminate the work due to non-mobilization of equipment as committed in the tender without any notice. In case bidder submit details of machinery hired or taken on lease, then bidder shall obtain affidavits on stamp paper verified by notary from owner of the machinery and shall submit the same along with the bid. Ownership record of the machinery such as copy of registration certificate, purchase memo etc. shall also be submitted.

(Note: Minimum Man power and Machinery as stated above should be arranged by the bidder separately and bidder can deploy manpower and machineries as per site requirement) The bidder must submit details of equipments as per **Form B** along with documentary proof. If bidder failed to deploy equipments/machineries within mobilisation period as mentioned in the tender documents, WAPCOS is free to cancel the project & forfeit the Bank Guarantee and blacklist the bidder.

Bidder has to submit an undertaking to deploy the above machineries for which he participated in the bidding process.

- 1.2.10 Bidder must not be black listed or debarred by any Government organization. Bidder should disclose their litigation history, if any. Both documents should besupported with an affidavit duly certified by notary.
- 1.2.11 A Bidder shall not have a conflict of interest. Any Bidder found to have a conflict of interestshall be disqualified. A Bidder may be considered to have a conflict of interest for the purpose of this bidding process, if the Bidder:
  - i. directly or indirectly controls, is controlled by or is under common control withanother Bidder; or
  - ii. receives or has received any direct or indirect subsidy from any other Bidder; or
  - iii. has the same legal representative as another Bidder; or
  - iv. has a relationship with another Bidder, directly or through common third parties, that puts it in a position to influence the bid of another Bidder, or influence the decisions of the Purchaser regarding this bidding process; or
  - v. participates in more than one bid in this bidding process. Participation by a Bidderin more than one Bid will result in the disqualification of all Bids in which suchBidder is involved. However, this does not limit the inclusion of the samesubcontractor in more than one bid

#### 1.2.12 Specific Construction Experience in Soft/Alluvial/Hard Formation/DWLR:

Must have previously drilled groundwater-monitoring/piezometer wells up to aminimum depth of 75m. Number of wells should not be less than 10% of proposednumber of monitoring wells to be constructed under this contract. The bidder must have supplied, installed & commissioned Digital Water Level Recorders in the constructed monitoring/piezometer wells.

- 1.2.13 The bidder must submit an undertaking for carrying out chemical analysis of water samples from any NABL accredited lab/labs. The Lab/labs shall have combined capacity of analyzing at least 300 water samples in a month.
- 1.2.14 For componet of supply, installation and commissioning of Digital Water Level Recorder, Bidder may associate with original manufacturer or authorized agent of original manufacturer. In case of authorized agent, an authorization letter from original manufacturer shall be submitted along with bid.
- 1.2.15 The so associated original manufacturer or authorized agent should have minimum 03 years overall experience for supply, installation, commissioning, and maintenance of Digital Water Level Recorder. Experience certificate certified an officer not below the 1<sup>st</sup> class officer or equivalent shall be submitted with the bid.
- 1.2.16 The bidder should possess the bidding capacity as calculated by the specified formula. The formula generally used is:



- d) Riot, commotion or disorder unless solely restricted to employees of the Contractor and arising from the conduct of the Works.
- e) Any operation of the forces of nature against which an experienced Contractor could not reasonably have been expected to take precautions.

All other accidents of the Works involving injuries to persons or damage to property other than that of the Contractor shall be promptly reported to the Engineer-in-Charge and other statutory bodies of the Government stating clearly and in sufficient details of the facts and circumstances of the accidents and the action taken. In all cases the Contractor shall indemnify WAPCOS against all loss or damage resulting directly or indirectly from the Contractor's failure to report in the manner aforesaid. This includes penalties or fines, if any, payable by WAPCOS as a consequence of failure to give notice or failure to conform to the provisions of any Act in regard to such accidents.

## iii) Insurance against Accident, etc., to Workmen

The Contractor shall insure against such liability with an insurer approved by WAPCOS, which approval shall not be unreasonably withheld, and shall continue such insurance during the whole of the time that any persons are employed by him on the Works and shall, when required, produce to the Engineer-in-Charge or the Engineerin-Charge's Representative such policy of insurance and the receipt for payment of the current premium. Provided always that, in respect of any persons employed by any sub-Contractor, the Contractor's obligation to insure as aforesaid under this sub-clause shall be satisfied if the sub-Contractor shall have insured against the liability in respect of such persons in such manner that WAPCOS is indemnified under the policy, but the Contractor shall require such sub-Contractor to produce to the Engineer-in-Charge or the Engineer-in-Charge's Representative, when required, such policy of insurance and the receipt for the payment of the current premium.

## Clause - 27

#### **Patent Rights and Royalties**

The Contractor shall save harmless and indemnify WAPCOS from and against all claims and proceedings for or on account of infringement of any patent rights, designs, trademark or name or other protected rights in respect of any machine, work, or material used for or in connection with the Works or any of them and from and against all claims, proceedings, damages, costs, charges and expenses whatsoever in respect thereof or in relation thereto. Except where otherwise specified, the Contractor shall pay all tonnage and other royalties, rent and other payments or compensation, if any, for getting stone, sand, gravel, clay, timber or other construction materials required from the Project.

	ii) In the event of any claims made under or action brought against WAPCOS in respect of any such matters as aforesaid, the Contractor shall be immediately, notified thereof and the Contractor shall be at liberty, at his own expense, to settle any disputes or to conduct any litigation that may arise there from. ## (iii) Alcoholic Liquor & Drugs.

The Contractor shall not, otherwise than in accordance with the Statutes, Ordinances and Government Regulations or orders for the time being in force, import, sell, give, barter or otherwise dispose of any alcoholic liquor, or drugs, or permit or suffer any such importation, sale, gift, barter or disposal by his sub-Contractors, agents or employees.

### (iv) Disorderly Conduct, etc.

The Contractor shall, at all times, take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct by or amongst his employees and for the preservation of peace and protection, of persons and property in the neighbourhood of the Works against the same.

## (v) Contractor to Follow Labour Laws and wage laws of INDIA

The Contractor shall, in respect of labour employed by him, comply with the provision of the various labour laws, Minimum Wages issued by Government of India and shall indemnify WAPCOS in respect of all claims that may be made against WAPCOS for non-compliance thereof by the Contractor,

Notwithstanding anything contained herein, the Engineer-in-Charge may take such actions as may be necessary for compliance of the various labour laws and recover the costs thereof from the Contractor.

## (vi) Observance by Sub-Contractors

The Contractor shall be responsible for observance by his sub-Contractors of the foregoing provisions.

### **MATERIALS AND WORKMANSHIP**

Clause – 33

## Material and Workmanship

Material and Workmanship

- a) The Contractor shall be responsible for arranging all the materials (except the materials to be supplied by WAPCOS) required for the construction of the Works from the source(s) acceptable to WAPCOS. He shall also be responsible for proper transportation and storage of these materials to the satisfaction of the Engineer-in-Charge and shall bear all related costs.
- b) The Engineer-in-Charge shall be entitled at any reasonable time, to inspect or examine all such materials. The Contractor shall provide reasonable assistance for such inspection or examination as may be required.
- c) The contractor shall initiate timely action to procure the materials well in advance so as to ensure that the progress of works does not suffer for want of materials at site at least seven days before these are intended to be used on works. Any setback to the progress of the works and consequent delay in completion of the works on account of non availability of materials at site shall be the sole responsibility of the contractor.
- d) Any assistance that the Engineer-in-Charge can give to the Contractor for arranging the materials shall be provided on a "no responsibility basis".
- (ii) Quality of materials and Workmanship and Tests
  - (a) The Contractor shall, provide the materials of the quality, kind and specifications as provided in the Contract. The Contractor shall produce to the Engineer-in- Charge, certified quality test reports in respect of the materials procured by him.
  - (b) In case the materials procured by the Contractor are not to the satisfaction of the Engineer-in-Charge and do not conform to the specifications laid in the Contract, such materials shall be rejected by the Engineer-in-Charge and the cost incurred on such procurement shall be the responsibility of the Contractor.
  - (c) The workmanship shall be of the kind described in the Contract and in accordance with the Engineer-in-Charge's instructions.
  - (d) All the materials and the workmanship shall be subjected, from time to time, to such tests as the Engineer-in-Charge may require at the place of manufacture, fabrication or preparations, or on the Site or at such other or places as may be specified in the Contract, or at all or any of such places. The Contractor shall provide such assistance, instruments, machines, labour and materials as are required for examining, measuring and testing any material and shall supply samples of materials, before incorporation in the Works, for testing, as

	may be selected and required by the Engineer-in-Charge.

	(iii) Cost of Samples All samples shall be supplied by the Contractor at his own cost.

#### **MAINTENANCE AND DEFECTS**

#### Clause - 46

#### **Maintenance and Defects**

i) Period of Maintenance:

### a) In respect of Drilling of Piezometer Component:

In these conditions, the expression "Period of Maintenance" shall mean a period of **12months** after commissioning of last well and issue of completion certificate whichever is later.

## b) In respect of Supply, Installation & Commissioning of Digital Water Leverl Recorder Component:

In these conditions, the expression "Period of Maintenance" shall mean a period of **five (5) years** after Supply, Installation & Commissioning of last Digital Water Leverl Recorder and issue of completion certificate whichever is later.

## ii) Execution of Work of Repair etc.

To the intent that the Works shall, at or as soon as practicable after the expiration of the Period of Maintenance be delivered to WAPCOS in the condition required by the Contract, fair, wear and tear excepted, to the satisfaction of the Engineer-in-Charge, the Contractor shall complete the Work, if any, outstanding on the date of completion, as certified under Clause-48 hereof, as soon as practicable after such date and shall execute all such work of repair, amendment, rectification and making good defects, imperfections, other faults as may be required of the Contractor in writing by the Engineer-in-Charge during period of Maintenance or within seven days after its expiration, as a result of an inspection made by or on behalf of the Engineer-in-Charge prior to its expiration.

## iii) Cost of Execution of works of Repair, etc.

All repair works shall be carried out by the Contractor at his own expense if the necessity thereof shall, in the opinion of the Engineer-in-Charge be due to the use of materials or workmanship not in accordance with the Contract, or due to neglect or failure on the part of the Contractor to comply with any obligation, expressed or implied, on the Contractor's part under the Contract. If, in the opinion of the Engineer-in-Charge such necessity shall be due to any other cause, the value of such work shall be ascertained and paid for as if it were additional work.

## iv) Remedy on Contractor's Failure to carry out Work Required

If the Contractor shall fail to do any such work as aforesaid required by the Engineer-in-Charge, WAPCOS shall be entitled to employ and pay other persons to carry out the same and if such work is the work which, in the opinion of the Engineer-in-Charge, the Contractor was liable to do at his own expense under the Contract, then all expenses consequent there-on or incidental thereto shall be recoverable from the Contractor by the Engineer-in-Charge from any money due or which may become due to the Contractor.

#### Clause-47

## **Contractor to Search cause of any defect**

The Contractor shall, if required by the Engineer-in-Charge in writing, search under the directions of the Engineer-in-Charge for the cause of any defect, imperfection or fault appearing during the progress of the Works and during the period of maintenance. Unless such defect, imperfection or fault is one for which the Contractor is liable under the Contract, the cost of work carried out by the Contractor in searching as aforesaid shall be borne by WAPCOS. If such defect, imperfection or fault shall be one for which the Contractor is liable as aforesaid, the cost of the work carried out in searching as aforesaid shall be borne by the Contractor and he shall in such case repair, rectify and make good such defect, imperfection or fault at his own expense.

## **ALTERNATIONS, ADDTIIONS, OMISSIONS AND EXTRA ITEMS**

## Clause - 48

## **Variations**

- i) The Engineer-in-Charge shall make any variation in the form, quality or quantity of the Works or any part thereof or substitution for original specifications, design, drawings and instructions that may, in his opinion be necessary and for that purpose, or if for any other reason it shall, in his opinion be appropriate, he shall have power to order the Contractor to do and the Contractor shall do any or all of the following:
  - a) increase or decrease the quantity of any work included in the Contract,
  - b) omit or substitute any such work,
  - c) change the character or quality or kind of any such work
  - d) execute additional work of any kind necessary for the completion of the Works, and
  - e) change any specified sequence or timing of construction or any part of the Works.

No such variations shall in any way vitiate or invalidate the Contract, but the effect if any, of all such variations shall be valued on which he agreed to do the Work hereof. Provided that where the issue of an instruction to vary the Works is necessitated by some default of or breach of Contract by the Contractor or for which he is responsible, any additional Cost attributable to such default shall be borne by the Contractor. Any altered, additional or substituted work which the Contractor may be directed to do in the manner above specified as part of the work, shall be carried out by the Contractor on the same conditions in all respects on which he agreed to do the main Work.

ii) The Unit Rates entered in the Bill of Quantities for the individual items shall apply for the quantities of Work as per actual execution of each item. However if quantities are deviated from the quantities specified in tender documents, prior written approval of the competent authority shall be taken before executing the deviated work. In case of deviated work, payment shall only be made for the work for which prior written approval of competent authority has been obtained.

#### Extra Items

The rates of extra items or deviated items shall be decided based on mutual

consent by the Contractor and Engineer-in-Charge. Contractor has to submit his rate analysis as per prevailing market rates in writing within 7 days of the instruction of Engineer-in-Charge to execute the new items. The rate will be reviewed by WAPCOS and acceptable rate will be intimated to the Contractor for acceptance of the same. Under no circumstances, the Contractor shall at any stage suspend the work on account of non-settlement of rates of such varied Work. PLANT, EQUIPMENT, TEMPORARY WORKS AND MATERIALS Clause - 50 **Equipment, Temporary Works and Materials** i) Contractor to Provide Equipment The Contractor shall provide at his own expense all plant, Temporary Work and Equipment, materials and Camps specified under para 1.1 of Chapter I of this document required for the execution of the Works. He shall furnish alongwith the bid a list of items of all machinery which he shall be deploying on the particular job. He shall also make necessary arrangements for supplementing them at his own expense, if required to do so by the Engineer-in-Charge at the time of acceptance of the Contract, or later on as the Work progresses. He shall also indicate whether he owns the machinery or he proposes to purchase or hire the same and shall furnish proof that he shall be able to arrange this machinery whether from his own resources or on hire. Within fifteen (15) days after the issue of the Letter of Acceptance, the Contractor shall mobilize of all the machines conforming with the list submitted with his bid. ii) Plant etc., Exclusive Use for the Works All Equipment, Temporary Works and materials provided by the Contractor shall, when brought on to the Site, be deemed to be exclusively intended for the execution of the Work and the Contractor shall not remove the same or any part thereof, except for the purpose of moving it from one part of the Site to another, without the consent, in writing, of the Engineer-in-Charge. iii) Removal of equipment & plant etc. Upon completion of the Works, the Contractor shall remove from the Site all the said equipment and Temporary works remaining thereon and any unused materials provided by the Contractor. Clause-51 Approval of Materials etc. not implied The operation of Clause-50 hereof shall not be deemed to imply any approval by the Engineer-in- Charge of the materials or other matters referred to there-in nor shall it prevent the rejection of any such materials at any time by the Engineer-in-Charge. **MEASUREMENT**

	He shall, when he requires any part or parts of the Works to be measured, give notice to the Contractor's authorised agent or representative, who shall forthwith attend or send a qualified agent to assist the Engineer-in-Charge in making such measurement, and shall furnish all particulars required by either of them. Should the Contractor not attend, or neglect or omit to send such agent, then the measurement made by the Engineer-in-Charge or approved by him shall be taken to be the correct measurement of the work. For the purpose of measuring such permanent work as it to be measured by records and drawings. The Engineer-in-Charge's representative shall prepare records and drawings month by month of such work and the Contractor, as and when called upon to do so in writing, shall, within fourteen days, attend to examine and agree such records and drawings with the Engineer-in-Charge's Representative and shall sign the same when so agreed. If the Contractor does not so attend to examine and agree such records and drawings, they shall be taken to be correct. If, after examination of such records and drawings, the contractor does not agree with the same or does not sign the same as agreed, they shall nevertheless be taken to be correct, unless the Contractor shall, within five (5) days of such examination, lodge with the Engineer-in-Charge's representative for decision by the Engineer-in-Charge, notice in writing of the respects in which such records and drawings are claimed by him to be incorrect.

The Site Manager shall on receiving reasonable notice from the Engineer present himself to the Engineer and / or at the site of work, as required, to take instructions.

- c. In case the Site Manager of the contractor does not discharge his duties satisfactorily, the Engineer shall have full powers to suspend the work and contractor shall be held responsible for the delay so caused to the work.
- d. The contractor shall provide and employ on the site only such technical persons as are skilled and experienced in their respective fields and such supervisory staff as are competent to give proper supervision. The contractor shall provide and employ semiskilled/unskilled labour as is necessary for proper and timely execution of the work.

## **CERTIFICATES AND PAYMENTS**

## PAYMENT TERMS FOR DRILLING & CONSTRUCTION OF PIEZOMETERS

#### A. Advances:

Mobilization advance not exceeding 10% of the piezometers work component value in tendered may be given, if requested by contractor in writing. Such advance shall be in two instalments of 05% each. The first instalment of such advance shall be released to the contractor on a request made by contractor to Engineer-In-Charge. The second instalment shall be released only after the contractor furnishes a proof of satisfactory utilization of the earlier instalment.

Advance for execution of the works, if required by the Contractor, will be granted in the following cases provided that the advances given or taken for particular work are spent only for that work.

- I. Advance for Mobilization;
- a) Advance to the extent of 10% (Ten percent)in two installments of 05% each of the Contract Price of piezometers can be granted for the following preliminary:
- i) Construction of site camps, stores and workshops etc. including camps labor sheds and stores etc.
- ii) Mobilization of Men & Machinery.
- iii) Transportation of Contractor's equipment (in good working condition) to the site including procurement of spare parts.
- b) The release of this advance shall be regulated and governed by the following conditions:
- i) The advance shall bear simple interest @10% per annum and shall be calculated from date of payment to the date of recovery, both days inclusive, on the outstanding amount of advance.
- ii) The advance will be disbursed on production of irrevocable bank

- guarantee amount equal to 110% of amount of advance and valid for the period till recovery of advance, on the Proforma at **Annex-V** from the any schedule Indian bank payable at Delhi. This bank guarantee shall be kept renewed from time to time to cover the balance amount.
- iii) Recovery of advance shall be made by the deduction from the contractors bills commencing after first ten per cent of the gross value of the work is executed and paid, on pro-rata percentage basis to the gross value of the work billed beyond 10% in such a way that the entire advance is recovered by the time eighty per cent of the gross value of the contract is executed and paid together with interest due on the entire outstanding amount up to the date of recovery of installment.

## **B. Payment on Account:**

For Payment on account, bill shall be prepared on the basis of actual work executed, measured and acceptance of work executed. Any payment shall be released on back to back basis after receipt of payment from GMDA, Haryana.

## An ESCROW account shall be opened for time to time payments between GMDA, WAPCOS and selected Contractor

The Nominated Contractor (Executing Agency) acknowledges that under thepresent Contract, WAPCOS is only workingas intermediary between GMDA, Haryana being Principal Employer/Client andContractor. Thus the Contractor unconditionally acknowledges that the payments underthe present Contract shall be madeproportionately by WAPCOS only on back to back basis i.e., after 21 days subject to receipt of payment from GMDA, Haryana being Principal Employer/Client. TheContractor also unconditionally agree that in theevent the payment or part thereof, under the present Contract is not received from GMDA, Haryana (PrincipalEmployer/Client), then WAPCOS &/or any of its Employee/Officer shall not beresponsible to pay any amount to Contractor. Thesaid condition shall supersede any and all other conditions ofContract between the parties."

### C. Final Account:

- a. The final bill shall be submitted within two month of physicalcompletion of the work or within two month of the date of thefinal certificate of completion furnished by the Engineerin-Charge whichever is later.
- b. The contractor shall make no further claims after submission of the final bill and these shall be deemed to have been waived and extinguished.

## D. Security Deposit (Retention Money)

Deduction towards Retention Money/Security Deposit @ 05% (Five Percent) of each bill (running/final) shall be made as under:

- a) In respect of drilling of Piezometer component, security deposit @05% of each running bill and final bill shall be deducted, which shall be refunded after expiry of maintenance period prescribed for drilling work component.
- b) In respect of supply installation and commissioning of Digital Water Level Recorder Component, security deposit @05% of each running bill and final bill shall be deducted, which shall be refunded after expiry of maintenance period prescribed for supply installation and commissioning of Digital Water Level Recorder Component.

## E. Income Tax;

Deduction towards income tax shall be made from every interim payment certified by Engineer-in-Charge in terms of Income Tax rules as in force from time to time as per Government of India.

#### F. Deduction towards TCS on GST

Deduction towards GST (TDS) shall be made from every interim payment certified/final bill by Engineer-in-Charge in terms of GST rules as in force from time to time as per Government of India. GST will be reimbursed after submission of documentary proof. The GST as applicable shall be charged as per prevailing norms of the Government of India.

G.Labour Cess: Contractor is required to pay the Cess @ 1 % of the cost of construction work as per Government Norms. Labour cess @ 1% shall be deducted on the bills, payable to the contractor for the consruction works covered under this contract.

# PAYMENT TERMS FOR SUPPLY, INTALLATION, COMMISIONING & MAINTENANACE OF DWLR

Payment shall be made in Indian Rupees in the following manner:

## Same ESCROW account shall be used for time to time payments between GMDA, WAPCOS and selected Contractor.

The Supplier shall be paid 40% (as per clause i) of the Contract Price excluding cost of Item Sr. no. 05 and excluding GST as per Price and Completion Schedule- Related Services , and the balance 60% (as per clause ii) of the Contract Price excluding cost of Item Sr. no. 05 and excluding GST as per Price and Completion Schedule- Related Services , for O&M and data communication over the next five years @ 12% per year which include 5 year period of onsite warranty as mentioned below

### i) Disbursement of Payment shall be as under:-

 Advance Payment: Ten (10) % of the Digital Water Level Recorder Component of contract price excluding GST shall be paid within thirty (30) days of signing of Contract and upon submission of bank guarantee for the equivalent amount, in the form, provided in the contract.

- 20% of Contract price excluding cost of Item Sr. no. 1.05 and excluding GST, against Supply of Goods shall be released on pro-rata basis after 30 days of the successful Delivery and installation of all the instruments/ Equipment as per Schedule of Requirements and its final acceptance.
- 20% of Contract Price excluding cost of Item Sr. no. 1.05 and excluding GST will be paid on pro-rata basis after 30 days of testing, commissioning and final acceptance. Advance payment of 10% paid against Bank Guarantee will be adjusted in this 20% payment paid on testing, commissioning and final acceptance as stated above.
- Payment against item under Sr. no. 1.05 of PRICE and Completion Schedule - Related Services, charged in invoice excluding GST, shall be released on pro-rata basis subject to satisfactory completion of this item as per technical specification.
- ii) 60% of the Contract Price excluding cost for item Sr. No. 5 and excluding GST Price and Completion Schedule - Related Services but including replacement of parts if any and seamless data communication, here onwards referred as maintenance charges over the balance 05(five) years (5 years of warranty period) shall be paid as per follows;
  - 12% per Year to be paid on Half Yearly basis (6% at every six month) inclusive of GST payable on Supply of related services. The Conditions (applicable for this payment) shall be governed by Annexure I: Service Level Conditions.
- iii) Payment of GST will be against valid Invoice as per GST Act & Rules and submission of GST Registration Certificate along with declaration that GST Registration is valid and all liabilities towards GST have been discharged by the vendor. GST amount will be reimbursed after 30 days of submission of valid Invoice and all required documents and declaration by vendor.
- (iv) For all the payments to be made, against Bank guarantees, the bank guarantee shall be issued by a Scheduled Indian Bank or a foreign bank located in India. The guarantees issued by other banks should be confirmed by a Scheduled Indian Bank or a foreign bank operating in India.
- v) Bank guarantee for advance payment shall be released not later than 30 days after the adjustment of advance amount against payment due after testing, commissioning and final acceptance. The bank guarantee should be valid for a period of 180 days or till the date of final testing, commissioning and final acceptance whichever is later, from the date of issue of bank guarantee including claim period.
- vi) For all the payments to be made, against Bank guarantees, the bank

guarantee shall be issued by a Scheduled Indian Bank or a foreign bank located in India in the formatenclosed at Section X. The guarantees issued by other banks should be confirmed by a Scheduled Indian Bank or a foreign bank operating in India.

The bidder shall indicate in the Price Schedules specifying all items prices shown therein including the unit prices and total prices of the goods and related services along with GST or any duties and taxes applicable against the schedule of requirements. GST if leviable shall be paid applicable. Any statutory variation shall be paid on submission of documentary evidence. Bidders shall be required to quote HSN code and applicable tax rates.

"GST" means all four Acts CGST, SGST, UTGST, IGST and any other regulations by Government in relation to GST and rules thereto The Associate/Sub-consultant/Sub-Contractor acknowledges that under the present Contract/ Agreement/Work Order/Arrangement, WAPCOS is only working as intermediary between FMDA being Principal Employer/Client and Associate/Sub-consultant/Sub-Contractor. Thus the Associate/Sub-consultant/Sub-Contractor unconditionally acknowledges that the payments under the present Contract/Agreement/Work Order/ Arrangement shall be made proportionately by WAPCOS only on back to back basis i.e. after 21 days subject to receipt of payment from FMDA being Principal Employer/Client. The Associate/Sub-consultant/Sub-Contractor also unconditionally agree that in the event the payment or part thereof, under the present Contract/Agreement/ Work Order/Arrangement not received from **FMDA** (Principal is Employer/Client), then WAPCOS &/or any of its Employee/Officer shall not be responsible to pay any amount to Associate/Sub-consultant/Sub-Contractor. The said condition shall supersede any and all other conditions of Contract/Agreement/Work Order/Arrangement between the parties.

## Clause-57

### **Security Deposit**

Security deposit shall be released after expiry of maintenance period as prescribed below from the date of issuance of completion certificate.

- a) In respect of Drilling of Piezometer Component:
  - In these conditions, the expression "Period of Maintenance" shall mean a period of 12 months after commissioning of last well and issue of completion certificate whichever is later.
- b) In respect of Supply, Installation & Commissioning of Digital Water Leverl Recorder Component:

In these conditions, the expression "Period of Maintenance" shall mean a period of five years after Supply, Installation & Commissioning of last Digital Water Level Recorder and issue of completion certificate whichever is later.

#### Clause-58

## **Approval only by Maintenance Certificate**

No certificate other than the Maintenance Certificate referred to in Clause-59 hereof shall be deemed to constitute approval of the works.

## Clause-59

## **Maintenance Certificate**

- The Contract shall not be considered as completed until a Maintenance Certificate shall have been signed by the Engineer-in-Charge stating that the Works have been completed and maintained to his satisfaction. The Maintenance Certificate shall be given by the Engineer-in-Charge within 28 (twenty eight) days after the expiration of the Period of Contract, or, if different periods of maintenance shall become applicable to different sections or parts of the Works, the expiration of the latest such period, or as soon thereafter as any works ordered during such period, pursuant to Clause-46 and 47 hereof, shall have been completed to the satisfaction of the Engineer-in-Charge and full effect shall be given to this Clause, notwithstanding any previous entry on the Works or the taking possession, working or using thereof or any part thereof by WAPCOS. Provided always that the issue of the Maintenance Certificate shall not be a condition precedent to payment to the Contractor of the retention money in accordance with the conditions set out in Clause-60 hereof.
- ii) Cessation or WAPCOS's Liability'

WAPCOS shall not be liable to the Contractor for any matter or thing arising out of or in connection with Contract or execution of the Works unless the Contractor shall have made a claim in writing in respect thereof before the giving of the Maintenance Certificate under this Clause.

#### iii) Unfulfilled Obligations

Notwithstanding the issue of Maintenance Certificate, the Contractor and, subject to sub Clause (ii) of this Clause, WAPCOS shall remain liable for the fulfillment of any obligation incurred under the provisions of the Contract prior to the issue of the Maintenance Certificate which remains unperformed at the time such Certificate is issued and, for the purposes of determining the nature and extent of any such obligation, the Contract shall be deemed to remain in force between the parties hereto.

## **REMEDIES AND POWERS**

#### Clause -60

#### **Remedies and Powers**

### i) Default of Contractor

If the Contractor shall become bankrupt, or have a receiving order made against him, or shall present his petition in bankruptcy, or shall make an arrangement with or assignment in favor of his creditors, or shall agree to carry out the Contract under a committee of inspection of his creditors or, being a corporation, shall go into liquidation (other than a voluntary liquidation for the purposes of amalgamation or reconstruction), or if the Contractor shall assign the Contract, without the consent in writing of WAPCOS first obtained, or shall have an execution levied on his goods, or if the Engineer-in-Charge shall certify in writing that, in his opinion, the Contractor;

- a) has abandoned the Contract, or
- without reasonable excuse has failed to commence the Works or has suspended the progress of the Works for fifteen days after receiving, from the Engineer-in-Charge, written notice to proceed or
- c) has failed to remove materials from the site or to pull down and replace work for twenty eight days after receiving from the Engineer-in-Charge's written notice that the said materials or work had been condemned and rejected by the Engineer-in-Charge under these conditions, or
- d) despite previous warnings by the Engineer-in-Charge in writing, is not executing the Works in accordance with the Contract, or is persistently or flagrantly neglecting to carry out his obligations under the Contract, or
- e) has, to the detriment of good workmanship, or in defiance of the Engineer -in- Charge's instruction to the contrary, sub-let any part of the Contract;

then the Engineer-in-Charge may, after giving seven day's notice in writing to the Contractor, enter upon the Site Works and expel the Contractor, from the entire Works or part thereof, without thereby voiding the Contract or releasing the Contractor from any of his obligations or liabilities under the Contract, or affecting the rights and powers conferred on WAPCOS or the Engineer-in-Charge by the Contract, and may itself complete the entire Work or part thereof as the case may be or may employ any other Contractor to complete the Works. WAPCOS or such other Contractor may use for such completion so much of the Constructional Plant, Temporary works and materials, which have been deemed to be reserved exclusively for the execution of the works, under the provisions of the Contract, as he or they may think proper, and WAPCOS may, at any time, sell any of the said Equipment, Temporary works and unused materials and apply the proceeds of sales in or towards the satisfaction of any sums due or which may become due to him from the Contractor under the Contract.

#### ii) Valuation at Date of Forfeiture

The Engineer-in-Charge shall, as soon as may be practicable after any such entry and expulsion by WAPCOS, fix and determine ex-party, or by or after reference to the parties or after such investigation or enquiries as he may think fit to make or institute, and shall certify what amount, if any, had at the time of such entry and expulsion been reasonably earned by or would reasonably accrue to the Contractor in respect of work actually done by him under the Contract and the value of any of

the said unused or partially used materials, any Equipment and any Temporary Works.

### iii) Payment after Forfeiture

If WAPCOS shall enter and expel the Contractor under this Clause, it shall not be liable to pay to the Contractor any money on account of the Contract until the expiration of the Period of Maintenance and thereafter until the costs of execution and maintenance, damages for delay in completion, if any, and all other expenses incurred by WAPCOS have been ascertained and the amount thereof certified by the Engineer-in-Charge. The Contractor shall then be entitled to receive only such sum or sums, if any, as the Engineer-in-Charge may certify would have been payable to him upon due completion by him after deducting the said amount. If such amount shall exceed the sum which would have been payable to the Contractor on due completion by him, then the Contractor shall, upon demand, pay to WAPCOS the amount of such excess and it shall be deemed a debt due by the Contractor to WAPCOS and shall be recoverable accordingly.

In the event of the above course being adopted by the Engineer-in-Charge, the Contractor shall have no claim to compensation for any loss sustained by him by reason of having purchased or procured any equipment, material or entered into an agreements or made any advances on account or with a view to the execution of the Works or the performance of the Contract.

### Clause -61

#### **Urgent Repairs**

If, by reasons of any accident, or failure, or other event occurring to in or in connection with the Works or any part thereof, either during the execution of the Works or during the Period of Maintenance, any remedial or other work or repair shall, in the opinion of the Engineer-in-Charge or the Engineer-in-Charge's Representative, be urgently necessary for the safety of the Works and the Contractor is unable or unwilling at once to do such Work or repair, WAPCOS may employ and pay other persons to carry out such work or repair as the Engineer-in-Charge or the Engineer-in-Charge's Representative may consider necessary. If the work or repair so done by WAPCOS is work which, in the opinion of the Engineer-in-Charge, the Contractor was liable to do at his own expense under the Contract, all expenses properly incurred by WAPCOS in so doing shall be recoverable from the Contractor by WAPCOS, or may be deducted by WAPCOS from any money due or which may become due to the Contractor. Provided always that Engineer-in-Charge or the Engineer-in-Charge's Representative, as the case may be, shall, as soon after the occurrence of any such emergency as may be reasonably practicable notify the Contractor thereof in writing.

## **SPECIAL RISKS/TERMINATION**

#### Clause-62

## **Special Risks/Termination of Contract**

i) Special Risks

The special risks are war, hostilities (whether war be declared or not), invasion, act of foreign enemies, the nuclear risks. ii) Termination of the Contract If, during the currency of the Contract any of the Special Risks mentioned herein above which, whether financially or otherwise, materially affects the execution of the Works, the Contractor shall unless and until the Contract is terminated under the provisions of this Clause, continue to use his best endeavours to complete the execution of the Works. Provided always that WAPCOS shall be entitled at any time after occurrence of such Special Risks to terminate the Contract by giving written notice to the Contractor and, upon such notice being given, this Contract shall, except as to the rights of the parties under this Clause and to the operation of Clause-67 hereof, terminate, but without prejudice to the rights of either party in respect of any antecedent breach thereof. iii) Removal of Equipment on Termination If the Contract shall be terminated under the provisions of the last preceding sub-clause, the Contractor shall, with all reasonable dispatch, remove from the Site all equipment and shall give similar facilities to his sub-Contractors to do so. Provided always that against any payments due from WAPCOS under this sub clause, WAPCOS shall be entitled to be credited with any outstanding balances due from the Contractor for advances in respect of equipment and materials and any other sums which at the date of termination were recoverable by WAPCOS from the Contractor under the terms of the Contract. **FRUSTRATION** Clause -63 **Payment in Event of Frustration** If a war, or other circumstances outside the control of both parties, arises after the Contract is made so that either party is prevented from fulfilling its Contractual obligations, or under the law governing the Contract, the parties are released from further performance, then the sum payable by WAPCOS to the Contractor in respect of the work executed shall be the same as that which would have been payable under Clause-62 hereof if the Contract had been terminated under the provisions of Clause-62 hereof. Clause – 64 **Solvency Certificate** Bidder should have a solvency equal to 40% of estimated cost. The bidder must submitted original Solvency certificate to WAPCOS office before due date. Bidder must provide the name, designation, power of attorney with valid official email id and contact number of issuing Bank Authority of solvency certificate. Solvency Certificate must have been issued after the date of publication of NIT & be addressed to the tendering authority quoting the name of the work. The Solvency Certificate should not be dated beyond the last date of submission of the bids.

#### **Notices**

i) Service of Notices on Contractor.

All certificates, notices or written orders to be given by the Engineer-in-Charge to the Contractor under the terms of the Contract shall be served either by sending by post or delivering the same to the Contractor's office on Site or his principal place of business, or such other address as the Contractor shall nominate for this purpose.

## **Default of WAPCOS**



## **CHAPTER -IV**

## **TECHNICAL SPECIFICATIONS**

# A. Drilling, construction & pumping test of Piezometers / Wells

#### 1.0 Dimension of borehole and wells:

**Piezometers Wells:** The dia of borehole/ pilot hole for particular type of wells shall be of specific measurement. The depth wise specific dia of each type of well is mentioned in Bill of Quantity.

## 2.0 Well depth:

The depth of wells upto60-130 mbgl

## 3.0 Thickness of overburden (For Hard Rock):

The overburden (surface soil) depends on the type of local geology present at the site. The average overburden thickness will be about 50 m which shall be drilled with suitable size of bit (Roller/ drag/button) with suitable MS casing 6" dia pipe (dia and thickness as per BOQ) shall be installed by the contractor uptothe recommended depth during drilling operation.

## 4.0 Pipes for Well Assembly:

The pipes shall be as per IS code mentioned in BOQ. The length of pipes (Plain and Screen) will be decided by WAPCOS Site-in-Charge and which shall be as per technical requirement at site.

## 5.0 Drilling & Geophysical Logging Operation:

- a) It shall be preferable to use DTH-cum-Direct-rotary rig/Rotary rig for the drilling operation for hard/soft rocks. However, contractor can use any other suitable (eg.Odex or Combination) type of rig for completing the work successfully. The capacity of the drilling rig should be in conformity to the general specification.
  - All the equipment, plant, tools for carrying out drilling operation for Exploratory and Observation wells construction shall be in good working conditions.
- b) Representative geological formation samples at regular interval of 3m shall be collected during drilling and stored in sample box duly labeled. Based on this, litho-log will be prepared by the geologist from contractor side and handed over in Barrier bags/reusable retail plastic bags/Biodegradable bags to Engineer-in-Charge/GMDA, HARYANA before finalizing the well assembly. Sample box should be of solid wood or metal frame material. Numbers of Sample Box should be equivalent to the numbers of Rigs and one in addition. (eg. For 3 Drilling Rigs, number of Sample Box should be 3+1=4).
- c) The drilling time log shall be maintained by the Contractor and given to Engineer-in-Charge as per given format.
- d) The choice of drilling shall be based on type of drilling mentioned in the BOQ.Contractor shall deploy the type of rig of sufficient capacity.

e) The Digital Geophysical Logging at selected boreholes shall be carried out by the Contractor and provide the data to Engineer-in-Charge/ Site-in-Charge for the finalization of Well Assembly. The Log with required information of prominent potential zones & tentative well assembly shall be provided by the Contractor to Engineer-in-Charge/ Site-in-Charge.

## 6.0 Preparation of Well assembly, Lowering, Gravel Packing & Clay Packing:

- i) Electrical logging or gamma-ray Logging or any type of recommended logging will be conducted by the experience geophysicist from contractor side for confirming accurate depth and thickness of various lithological units at each well site under supervision of WAPCOS Site-in-Charge. The zone tests (if required) will be conducted using packer technique to detect chemical quality, where it is required. The drilling time log will be maintained by the Contractor and given to WAPCOS Site-in-Charge.
- ii) A recommended length of casing pipe should be left above ground level using clamps. A pair of clamps made of 75cm x 15cm MS plate of 9 mm thick should be provided and fixed around the casing with proper nuts and bolts which is finally reinforced in the cement concrete. The well should be provided with well cap and protection box with locks (as per BOQ).
- iii) Jointing of casing pipes: The ERW MS plain to plain pipe should be first jointed by welding around the circumference and then three stripes of 38 mm wide 125 mm long and 7.1 mm thickness be equally spaced around the jointand welded, for U-Pvs pipe should be join with proper sutaible strip.
- iv) The entire well assembly consisting of casing pipe should be lowered at same time by suitable method as per recommended by Engineer-in-Charge.
- v) The welding rods of make Modi/Adore or standard make may be used.
- vi) The reducer of recommended dia and thickness will be arranged and added by welding at the end of bottom of housing pipe and to the top of the assembly pipe by the contractor.
- vii) Bail plug should be kept at the bottom of the assembly and length will be mentioned in the assembly recommendation from WAPCOS.
- viii) The entire well assembly consisting of housing pipe and screen/plain pipe will be lowered at same time by suitable method.
- ix) The pipes should be of beveled end.
- x) **Gravel Packing:** Gravel packing shall be carried through out the recommended depth range as per proper method recommended by Engineer-in-Charge/ Site-in-Charge.
  - The annular space between well assembly and drilled bore hole will be properly shrouded with suitable pea-gravel size by adoption of reverse fluid circulation method to the depth. If necessary, the proper packing of gravel may be ensured by running air compressor for about ½ to 1 hour. The quantity of pea-gravel may vary depending on the depth of borehole. In case of thick mud available in borehole, it should be thinned by flowing fresh water after lowering well assembly and before gravel shrouding. The materials for gravel packing in the wells should have the following characteristics:
  - i) It should be cleaned properly.
  - ii) Use of weathered gravel material should be avoided and not allowed.
  - iii) The grains of gravel should be smooth, round to sub-rounded and uniform in size.
  - iv) Flat particles should be avoided and not allowed.
  - v) It should be hard (hardness), insoluble and particles of shale, anhydrite and gypsum will not be used.
  - vi) The size of pea-gravel should be as per Bill of Quantity.
  - vii) The well assembly should be washed with clean water immediately after gravel packing to remove excess of drilling mud present.

**Note:** It should be ensure that the gravel is completely packed in the annular space as per the assembly recommendation.

- xi) Clay packing shall be carried through out the recommended depth range as per proper method recommended by Engineer-in-Charge/ Site-in-Charge.
- xii) Alignment and verticality of Well:Well should be vertical and straight. The alignment and verticality of well will be checked by plummet which is suspended through a thin wire from tripod with winch. The verticality test needs to be carried out in presence of site Engineer-in-Charge by the drilling unit. To ensure verticality of tube well the guides may be used with assembly pipe at the time of well assembly lowering.

## 7.0 Well Development:

The well should be developed by air compressor and over pumping unit to ensure sand free discharge and optimal yield.

## a) Development by Air Compressor

During, development by air compressor, the operation shall be carried out as under:

- 1) Development by compressor need to be carried out by using suitable air pressure as per site requirement.
- 2) Suitable size Eduction pipe need to be used as discharge pipe and suitable air line should be used for air supply.
- 3) The development should commence from the top of aquifer tapped and should be carried out towards bottom and the development operation should be repeated again from top to bottom.
- 4) The development with Air compressor for exploratory well as well as observation well should be carried out till the water becomes mud/sand free in Exploratory Wells/ Observation Wells. Any changes during the development recommended by WAPCOS Site-in-Charge should be considered immediately by the Contractor.

#### b) Development by Over-pumping Unit (Pre-Pumping)

Suitable submersible pump of required discharge range with suitable lift-up capacity need to be lowered for development of Exploratory bore holes to ensure sand free discharge. The recommendation for discharge will be shared with contractor after development of well. Alternatively, turbine pump of suitable capacity can also be used for development by Pumping test unit. The Development of Exploratory well by over pumping will be carried out as per Bill of Quantity till the water becomes clear free from sand/ Silt and clay etc.

All the equipment including POL &Labour required for carrying out tests but not limited to the following shall be arranged by the Contractor at his own cost:

- i) A suitable pump and prime mover (since power is not available at the well site).
- ii) Measuring devices for time, discharge and V-Notch orifice method water level recorder (Digital water meter recorder /steel tape engraved).
- iii) 25 mm airline needed to be lowered in the test well as well as observation well up to required depth.

## 10.0 Collection and Analysis of Water Samples:

The contractor will collect water samples as per Bill of Quantities for further chemical analysis. The numbers of samples should be as per mentioned in the BOQ for both type of wells. The sample should be collected in the Laboratory approved sample bottles (as mentioned in BOQ).

Collected water samples should be gone through NABL approved labs only for Basic, Heavy etc. analysis. The type of analysis is given in Bill of Quantities.

## 11.0 Well Completion:

#### **Cement Concrete Platform:**

A cement concrete platform (As mentioned in the figure) will be constructed around the casing at the ground surface. A MS cap (As shown in figure) is to be welded as cap on the top of the Exploratory Wells.

## **Protecting Box and Display Board:**

After the completion of well in respects described above, the contractor shall install Display Board and Protection Box as described in the Drawings given in Figure.

**Restoration of Drilling Site:** Contractor shall restore site, remove the cutting materials, level the undulations and clear it as it was before.

## 12.0 Measurement Book (Computerized):

Measurement books of each site is to be prepared and submitted by Contractor site officials. This should be done before the corresponding billis submitted to the Division Office for payment. The contractor shall submit two sparecopies of such computerized MB's for the purpose of reference and records. The contractor shall also submit to the WAPCOS separately his computerized Abstract of Cost and the bill based on these measurements, duly bound, and its pages machinenumbered along with two spare copies of the "bill. Thereafter, this bill will be processed by the Division Office and allotted a number as per the computerized record in the sameway as done for the measurement book meant for measurements. The contractor shall, without extra charge, provide all assistance with every appliance,

labour and other things necessary for checking of measurements/levels bythe Engineer-in- Charge or his representative.

#### Note:

- 1. All cutting jobs of pipes etc. will be carried by gas cutter and not by electric current at site.
- 2. M.S. Electric welding rod of standard quality of suitable size should be used for welding for perfect homogenous joint.
- The Sounding of top of packed gravel and cement sealing depth position must be ascertained by measuring correctly with 4mm dia. Sounding steel wire rope wound on a properly made rotating stand.
- 4. Well diagrams to follow the construction works are given below.

**13.0 Basic Data Report:** The contractor is required to prepare the basic data report (BDR) for all the wells as per the format provided in the tender and instructions given in the Bill of Quantity. The BDR for each of the well shall be submitted to WAPCOS in soft as well as hard copy (two Copies). Site wise and Well wise Photographs and Videos of all activities in soft copy should be submitted to WAPCOS Head Office in a 1 TB Hard Disk.

# B. Supply, Commissioning and Installation of DWLR

The supplier shall be required to provide all of the following material / services for implementation of Real time ground water level data monitoring System to be installed in the Piezometers of Ground Water Department in the State of Haryana. The scope of the work would essentially involve

- 1. Complete Supply, Installation and Commissioning of Digital Water Level Recorders (DWLR) and telemetry system in the identified piezometers including arrangements for Protection box of prescribed size, fencing and security arrangements including associated civil works, sensors, data logger, software, hardware and ancillaries' equipment, etc.
- 2. Technical design, supply, installation, testing, commissioning of the Digital Water Level Recorder (DWLR) for the real time ground water level data collection network and establish data communications using GSM & GPRS telemetry between the remote DWLR stations and State NHP Data Centre at GMDA, HR through Cloud server maintained by supplier with API interface and later through the e-SWIS/ e- GEMS/NHP Software. This includes, but is not limited to acquiring service, and maintaining all aspects of the service during the warranty period as well as the Comprehensive maintenance period.
- 3. Testing the data acquisition and data communication system using GSM/GPRS between the Cloud server and the data center / central facility at NHP HR. The SIM card shall be supplied by the bidder and the availability of Cloud services shall be the responsibility of the supplier. Data transmission charges would be borne by bidder during O&M period.
- 4. Establish a GSM & GPRS receiving system along with all required arrangement at Cloud server (maintained by supplier) to collect GSM & GPRS data from DWLR station network. This shall include a High Speed uninterrupted internet connection, Static IP, FTP Server with adequate firewall & antivirus protection that will support the seamless transfer of DWLR data stream. And required all acquiring hardware and software, software licenses, installation, configuration. No data processing software has to be provided by the bidder at state data center.
- 5. Establish communication between remote DWLR stations with GSM & GPRS receiving system along with all required arrangement at Cloud server to collect GSM & GPRS data from DWLR station network. Bidder shall make necessary arrangement for configuration of Cloud Server with adequate firewall & antivirus protection that will support the seamless transfer of DWLR data from Cloud server to State NHP Data Centre through API interface. And required all acquiring hardware and software, software licenses, installation, configuration. Data processing software has to be provided by the bidder at state datacentre.GW Data thus obtained should also be available on cloud. Cloud server should be located in India and should be as per GUI guideline. All Data transmission charges during O&M period will be borne by the bidder.
- 6. Perform on-site assembly, start-up of the supplied goods.

- 7. Complete commissioning integration, testing & organization of the whole system.
- 8. Provide operation &maintenance services during five (5) years comprehensive warranty period which shall include all components at the remote stations as well as all newly acquired equipment's in the data center.
- 9. Provide installation and maintenance reports as required by the Purchaser and any delay is not acceptable in time schedule provided by supplier.
- 10. Supply detailed operation and maintenance manual for each component in the system and compile Knowledge and working supply type Manual for training purpose (including multimedia training kits).
- 11. Provide classroom and field training to the sufficient number of GMDA Haryana. Personnel on the DWLR data acquisition system. This includes operation and maintenance procedures. Training will also occur at selected field locations as selected by the Purchaser.
- 12. A guarantee by the manufacturer that all equipment being provided will be supported for a minimum of ten years after the commissioning of the Digital Water Level Recorder (DWLR)system.
- 13. Calibration and validation of the installed system shall continue during the entire Warranty period on half yearly basis.
- 14. The remote stations shall store the data for at least one year.
- 15. The data would be measured four times a day with an interval of 6 hours and would be transmitted once in a day.
- 16. Security of the equipment's installed at remote locations shall be responsibility of the bidder during the entire project period (5 years).
- 17. Supply a detailed operation and maintenance manual for each appropriate unit of supplied Goods.
- 18. Although all accessories and fixtures required for installation of the equipment & their specifications have been specified in technical specifications however, bidder shall ensure the satisfactory performance & functioning of DWLR system complete, for this if any accessory or item s are required that shall be provided by bidder, the cost towards that is deemed to be included in the cost tendered by the bidder, no extra cost shall be paid to the bidder on thisaccount.
- 19. Also bidder will be responsible to provide protection like canopy etc. to DWLR instrument al all Existing observation bore wells. The cost of Installation, Testing and Commissioning of DWLR station shall to be inclusive these protection measures cost.
- 20. The typical schematic civil work drawing for installation of Digital Water Level Recorder (DWLRs) is attached for reference. However bidder has to provide the detailed civil work/fabrication drawing for installation arrangement as per the site condition and for which approval of Purchaser is required.
- 21. The supplier will be responsible for all Civil Works involved in the execution of the contract. Security of installed equipment's including theft and vandalism will be the responsibility of the Bidder during the entire project period (5 years).

- 22. Ensure that all software licenses and maintenance agreements are in the name of Purchaser and should seek full support and updates for such software for the duration of the warranty period and Annual Maintenance Services Period. All the software original licenses should be valid for the design life of the system, that is 10 years from date of commissioning.
- 23. Blue tooth Facility for Data Downloading from DWLR station, and Provide Mobile App is in bidder scope.
- 24. If deemed necessary, the bidders will have to give presentation of the proposed DWLRs including the field demonstration, as per request and location decided by the employer.
- 25. If Bore Well Dried out, reinstallation is charged free of cost by the bidder.
- 26. Every 6 months Re-calibration of Instrument done by bidder and report submit to Representative Officer.
- 27. Recurring and non recurring expenditure (for 5 years) in Bidder Scope
- 28. O&M period for 5 years will be start after commissioning of all DWLR instruments.
- 29. Agency will deploy one Project Engineer 24\*7 along with laptop at GMDA office for entire project Period.
- 30. GMDA will assist WAPCOS and Contractor to provide pre-existing wells in proper favourable conditions for the installation of DWLRs.

#### C. TRAINING ANDDOCUMENTATION

- 1. The Bidder is required to provide an extensive training programme for the system. The training set forth in the following paragraphs is a minimum requirement and the bidder should
- 2. propose any additional training that he considers critical for long term success of the system operations.
- 3. The Bidder is expected to provide an outline or table indicating the contents of each of the required courses. The table shall describe the specific topics to be covered for each day of the training period.
- 4. The Bidder is responsible for the salaries of the training instructors and all training materials. The costs of travel, transportation and per diem for the trainees shall be borne by the Purchaser.
- 5. Training shall be provided by the bidder in several phases. The training shall include both classroom and field trainings and will be continued during all five years. The bidder is required to have DWLR equipment specialists.



#### 5. INSPECTIONS AND TESTS

The following inspections and tests shall be performed:

#### General:

- 1. After manufacture, the supplier shall get each equipment/item of Goods inspected in manufacturer/s works as per approved datasheets and QAP and forward to the Purchaser along with his letter seeking inspect the equipment/item of Goods conform to contract specifications.
- 2. Upon readiness of the material and receipt of test certificate and calibration certificates, all the equipment shall be jointly inspected and checked by Third Party Inspection Govt. Agency alongwith Purchaser's representative (GMDA Department) and end user representative at manufacture place to carry out quality checks. The Contractor shall inform the Engineer in advance for the factory inspection for material and its fabrication. The inspection and test categories shall be applied prior to delivery of the each equipments,. The production routine test as per relevant IS shall be carried out as a part of acceptance tes.
- 3. However, the inspection and dispatch clearance by the Purchaser or the waiver thereof shall not prejudice the right of the Purchaser or its consignee to test the equipment/goods on receipt at destination. Upon receipt of the goods at final destination, the Purchaser shall have the right to inspect and/or test the equipment/Goods to confirm their conformity to contractspecifications.
- 4. If the equipment fails to meet the contract specifications during inspection, whether pre dispatch or upon receipt of at final destination, the supplier shall take immediate steps to remedy the deficiency or replace the defective equipment to ensure that all supplies meet with the specifications specified in the contract

## Inspection and tests prior to shipment of Goods and at final acceptance are as follows:

- 1. The inspection of the Goods shall be carried out to check whether the Goods are in conformity with the approved technical specifications attached to the contract and shall be in line with the inspection/test procedures laid down in the Technical Specifications and the General Conditions of contract. Following broad test procedure will generally be followed for inspection and testing of instruments. The supplier will dispatch the goods to the ultimate consignee after internal inspection testing along with the supplier's inspection report and manufacturer's warranty certificate. The purchaser will test the equipment after completion of the installation and commissioning at the site of the installation.
  - a Site Preparation and Installation: The Purchaser will designate the installation sites before the scheduled installation date to allow the Supplier to perform a site inspection before the installation of the DWLRs and associated telemetry system. In case there is a delay in handing over the site by the purchaser, appropriate extension of time shall be granted without imposition of liquidated damages in accordance with the provisions of contract. However, if the extension in time is granted in any circumstances due to any reason by purchaser, the supplier shall not claim such as escalation, price index inflation, any interest amount or any other kind ofclaim.
  - b. For site preparation, the supplier should furnish all details and drawings to the purchaser sufficiently in advance so as to get the works completed before receipt of theequipment.
- 2 Complete hardware and software as specified in 'List of Goods and Delivery Schedule' Under the

- Schedule of Requirement should be supplied, installed and commissioned properly by the supplier prior to commencement of performancetests.
- 3. The acceptance test will be conducted by the purchaser/their consultant or any other person nominated by the purchaser, at its option. The acceptance will involve trouble-free operation for seven consecutive days. There shall not be any additional charges for carrying out acceptance tests. No malfunction, partial or complete failure of any part of hardware attached to printers, drivers etc. or bugs in the software should occur. All the software should be complete and no missing modules/sections will be allowed. The supplier shall maintain necessary log in respect of the results of the tests to establish to the entire satisfaction of the purchaser, the successful completion of the test specified. An average uptake efficiency of 90% for the duration of test period shall be considered as satisfactory.
- 4. In the event of the hardware and software failing to pass the acceptance test, a period not exceeding two weeks will be given to rectify the defects and clear the acceptance test, failing which the purchaser reserves the rights to get the equipment replaced by the supplier at no extra cost to the purchaser.
- 5. DWLRs procured would be subject to the Acceptance Protocol givenbelow.

#### ACCEPTANCE PROTOCOL

#### 1. General

- a The delivery of goods/equipment and software should be in accordance with the contract agreement and the process of delivery will adhere to the following 'Acceptance Protocol'. The Acceptance Protocol shall serve as a formal guidance during delivery of the DWLRs. Its primary goals aretwofold.
  - i. Ascertain the delivery and completeness of all ordered products and related documents.
  - ii. Check the functioning of the equipment and software in a formal way against the specifications by application of Acceptance Tests. The tests also verify the accuracy and stability of the equipment.
- **b.** The Acceptance Protocol shall be executed in close co-operation between the Supplier and theClient.
- **c.** Products shall be accepted only if they meet the requirements and are functioning in compliance with the technical specifications, and the related documents are complete and correct. Defective products and any other discrepancies shall have to be replaced/ resolved, within a pre-defined timeframe.

#### 2. Documents

- **a.** The following documents shall accompany the delivery of the instruments and software:
  - i. Administrative and Quality Assurance (QA)documents
  - ii. Test and calibration documents
  - iii. Manuals and Guidelines

All documents shall have identification and references to subject or instrument, date, time, location and officer in charge.

- **b.** The Acceptance Report lays down the findings and observations during the execution of the Acceptance Protocol and is a formal document to record the acceptance or rejection of any item as covered in the Bid document. Any flaws or findings are to be reported. The forms and checklists filled out during the execution of the Acceptance Protocol are to be enclosed with the Acceptance Report. The Supplier receives a signed copy of the Acceptance Report, which the Supplier can use as proof that the items listed in the report wereaccepted.
- **c.** The content of the various documents shall be asfollows:

#### **Administrative and QA documents:** These QA documents shallinclude:

- i) Production documents associated with theinstruments.
- **ii)** Type codes, serial numbers and other identification data on, possibly externally procured, sensors and major assemblies, to clearly demarcate the sensors/major assemblies associated with eachDWLR.
- **iii)** Shipping documents indicating instrument/product type, serial number, measuring range, cable length and other similardata.

#### Test and calibrationdocuments:

- i) A comprehensive Method Statement on the applied calibration and in-factory test procedures shall accompany the bid. The Method Statement should define the test and calibration methods applied on the instruments and the components thereof. The Method Statement shall also include, for each calibrated product, an audit trail to national standards on all instruments and facilities used for testing and calibration. The Audit Trail Report shall associate the calibration of the reference instruments and test equipment to the national calibration standards.
- ii) If the Supplier or Manufacturer is not in a position to deliver an Audit Trail Report to the national standards, the Manufacturer shall explain what the quality standards are and how they are maintained andmonitored.
- **iii)** Conditions during calibration, such as room and/or instrument temperature, equipment and facilities used, shall be included in the calibration and test documents.
- **iv)** The test and calibration documents shall contain the data generated during calibration and testing,including:

- Calibration data supplied by the Manufacturer of pressure sensor
- · Calibration and test data of the data-loggerelectronics
- Calibration data on overall DWLR calibration, i.e. comprising both pressure sensor and electronics. A
  table listing applied reference pressures/ measured reference depth versus instrument readings is to be
  delivered for each sensor and instrument. Furthermore, that table shall also show the test conditions
  during calibration
- Data on hysteresis test, temperature tests, zero stability/ reading stability test, scale stabilitytest
- Humidity test, in particular for vented gauge pressuresensors
- · Temperature cycling of sensor and electronics
- Spray test on enclosure(s), connectors andcables

#### **Manuals and Guidelines**

The manuals shall meet the requirements on style and clarity, completeness, preciseness, detail and accessibility. This includes:

- · Systemmanual,
- Operation, Maintenance and Servicemanuals,
- · Observation guideline, and
- Traininghandouts.

## **Acceptance Tests**

## 1. General

- i) Qualified engineers under responsibility of a test manager shall execute the Acceptance Tests. The progress of the Acceptance Tests would be monitored and supervised by the Client and/or his authorised representative. The Client may have any tests redone or additional tests executed as deem required based on the results of previous tests conducted. The Client's and/or his authorised representative shall have the right of access to any instrument and may request any data or information at any time. The Supplier has the obligation to deliver requested information without delay; i.e. collected test data and documents must be available at the testsite.
- ii) It is important that all activities (what, when, where, who, which instrument, etc.) are annotated and uniquely linked to the individualinstruments.
- iii) The Acceptance Tests mainly comprise three levelsviz.:
- <u>Functional Tests</u>: TheFunctional Tests shall verify the proper functioning of the instruments and the
  associated software. Primary goal is to verify that the instrument performs its
  functions according to the bidspecifications.

- <u>Accuracy Tests</u>: The Accuracy Tests shall verify that each individual instrument is functional and
  operates according to the bid specifications. A number of relatively simple
  accuracy tests are routinely exercised on theinstruments.
- Overall Test: The main purpose of the Overall Test is to verify the common features that are
  identical to all the instruments in a series. Typical components of the OverallTest
  are:- in-built software functions, materials of the instrument, cables, connectors,
  etc. Further tests include battery and memory autonomy, details of sensor
  specifications like temperature effects, hysteresis, long term stabilityetc.
- The above tests can be executed at any one of the following locations:-Premises of the Manufacturer/Supplier; Premises of the Client; Independent organisation; at Site of installation
- **iv)** The charges for testing shall be borne by the Manufacturer/Supplier. The Client and/or his authorised representative may at his cost opt to be present during the performances of thetests.
- v) If the tests are executed at the Client's premises, the charge for testing shall be borne by the Client and the Supplier shall be responsible for conducting the tests. The bidder in his bid shall indicate the name of independent organisation and the charges for testing. The Client reserves the right to accept the independent organisation and its charges or get the tests done by any other agencies. However, the Supplier would be permitted to be present at these tests.
  - (Explanatory Note: Test report from manufacturer would be acceptable. In case purchaser desires to test the system from independent agency (ies), testing charges would be borne by purchaser.)
- vi) The details of these tests are as follows.

**Functional Tests:** The Functional Tests include: visual inspection, and usertests.

**Visual Inspection:** Visual inspection includes the following activities.

- i) All items are visually checked for damage, e.g. on cables, sensor andhousing.
- ii) Availability of non-removable identification codes and specifications are verified, e.g. serial number, type identification, manufacturer and measuring range.
- iii) Cables have to be marked: each cable is to have an identification code and name.
- iv) Cable connectors shall have their ends marked suitably to indicate the device to which it is to be connected, e.g. PC, HHT, Power Supply etc. Suitable precaution shall be taken so that the connectors are not connected to wrong terminals, i.e. it shall be impossible to connect a power cable to a communication bulkheadsocket.

#### 2 Usertests

i) All instruments have to be identical except for measuring range, cable length, identification code and similar aspects. Consequently, there is no need to check the functionality of all systems. It is assumed that the functional compliance with the specifications is tested under the Overall Tests. The objective of the user test is to detect any malfunction and/or defect. From practical point of view, the user tests can be coupled with other test, e.g. the stabilitytests.

## ii) Basic functions to be testedare:

- Pre-deployment preparation, e.g. setting of clock, erasing of memory, setting data logging parameters, entry of identification data
- Facilities for execution of on-site functionalchecks
- Data retrieval and data transfer to PC
- Battery status andvoltage
- Conversion of retrieved data into ASCII table for application by user'ssoftware
- Simple output test by observing pressure reading while the sensor is immersed in a bucket filled with water (For pressure type) or Simple output test by observing sensor mounted on a pipe of length 2meter.

## Accuracy Tests: The Accuracy testsinclude:

- accuracy tests on clock, and
- accuracy tests on pressure sensormeasurement.

## 3 Accuracy tests onclock

- i) The clock of the data logger shall be carefully checked against national time, e.g. taking the radio broadcast time beeps as a reference. The data logger clock is set precisely and checked at the start of the individual tests and upon instrument and/or data retrieval. In between, the clock should not bereadjusted.
- ii) The clock test shall cover at least 3 days to get sufficient time resolution. The reference clock, e.g. a watch, must be carefully tuned against national time prior to and during the tests. The clock drift, converted to seconds per month (31 days) shall comply with the defined specifications. This test method makes use of the specified time resolution of 1s.

## 4 Accuracy tests on pressure measurement

- ) For pressure- The accuracy test on the pressure sensor is an overall accuracy test covering both the pressure and electronics systems. The pressure tests are to be executed against accurately known reference pressure(s). Pressure can be generated from compressed air (gas) or by submerging the sensor to known depths inwater.
- i) For Pressure Reference pressure may be created via a precision pressure reduction valve from a source of compressed air. A high precision sensor like a Digi Quartz pressure sensor or a Dead Weight Tester can be implemented to quantify the applied pressure. Pressure should be measured in kPa (ormbar).
- ii) When applying the immersion method it is much more difficult to check the instruments because water density affects the reading. Moreover, it is not simple to establish the exact depth of sensor immersion. And especially in narrow wells, while immersing a pressure sensor on its cable into a well, the water level will rise due to the additional volume of the immersed pressure sensor and cable. The water level will gradually fall again, when the well level adjusts again to equilibrium with the ground water level. In order to achieve a high accuracy these effects have to beassessed.

#### M) The pressure sensor testsinclude:

- Zero stability test (for pressure)
- Scaletest
- Scale stabilitytest

v) The pressure sensor tests shall focus on temperature effects on zero, scale and cable length, and in addition to that establish quantitative data on drift of zero, scale and creep of cable length.

## (a) Zero stability test

- i) During the zero-test the instruments are in logging mode, say at an interval of 30 minutes, and shall be kept in a separate room where they will not be touched for at least 3 days. The instruments must be dry, i.e. not in a bucket of water, to exclude any water effect on the sensor, and hence, the instrument reading is expected to be0.0.
- ii) Under this test, each instrument will record its short term zero drift and inherently the effectiveness of the air-pressure compensation method. During the zero-test, the instruments shall be in the same and constant position, vertical or horizontal. The room temperature shall vary over 5 °C or more, e.g. due to daily temperature fluctuation, this to assess temperature effects on the instrument reading. This requirement may affect the choice of venue for the zero-tests. To avoid any adverse temperature strain, no direct sunlight shall fall on the instruments. At the end of the test, the collected data are offloaded from the data logger memory and analysed for zero stability. As the instruments are kept in air and are not touched, the reading shall be stable and not change over time that is not beyond permissiblelimits.
- iii) Room temperature is to be logged against time, preferably by digital method. In case the DWLR has a built-in temperature sensor, that sensor may be used for temperature logging. The pressure sensors shall not be tested in an air- conditioned room for several reasons. First, temperature fluctuations may be so rapid that the sensor temperature compensation scheme may not be able to cope with it. Moreover, rapid air-pressure fluctuations may not be handled properly by the air-vent system and/or the pressure measurement method. This is to be understood from the perspective that the instruments are designed to operate in wells where changes occur but not rapidly. One or more fans may be operated continuously to minimise temperature gradient across the test room.
- iv) To test the creep and elongation of the electrical cum suspension cable some vertical open space is required, e.g. a stairwell can be used for this purpose. However, it is important that the cable is protected against touch to avoid interference with the measurements. The cable is loaded with some weight to emulate the weight of cable and sensor. The length of cable under tests shall be as long as possible, i.e. 10 m or more, to get the best accuracy of the tests. The lowest point is suspended to about 0.15 m above the floor. The gap between lowest point and floor is monitored against time. Initially readings are taken every 30 minutes for 12 hours, subsequently the reading interval may be increased to 6 hours. The cable test shall be executed during 7 days. Resolution of measurement should be 1 mm or better. The result is to be presented in mm length change per meter suspended cable length. Only one cable is to betested.

# (b) Reading stability test

- i. The test is carried out on a standard calibrated 2m test setup. During the reading stability test the instrument are in logging mode say at an interval of 30 minutes and shall be kept in separate room where they will not be touched for at least 3 days. The instrument and the setup must be dry to exclude water effect on thesensor.
- ii. During the reading stability -test, the instruments shall be in the same and constant position, vertical or horizontal. The room temperature shall varyover 5 °C or more, e.g. due to daily temperature fluctuation, this to assess temperature effects on the instrument reading. This requirement may affect the choice of venue for the zero-tests. To avoid any adverse temperature strain, no direct sunlight shall fall on the instruments. At the end of the test, the

collected data are offloaded from the data logger memory and analysed for reading stability. As the instruments are kept in air and are not touched, the reading shall be stable and not change over time that is not beyond permissible limits

iii. Room temperature is to be logged against time, preferably by digital method. In case the DWLR has a built-in temperature sensor, that sensor may be used for temperature logging. First, temperature fluctuations may be so rapid that the sensor temperature compensation scheme may not be able to cope with it. Moreover, rapid air-pressure fluctuations may not be handled properly by the air-vent system measurement method. This is to be understood from the perspective that the instruments are designed to operate in wells where changes occur but not rapidly. One or more fans may be operated continuously to minimise temperature gradient across the testroom.

**Scale test:** A precisely known pressure is applied on the instrument and theinstrumentreadingistaken. Theinstrumentreadingis converted into levelor pressure whatever is applicable. The calculated value is compared with the applied value; the difference is regarded as the FS error. In case the specifications of the applied pressure sensor may give reason to doubt the instrument's linearity, then a mid-scale test is to be executed as well.

**Scale stability test:** Scale stability is tested by subjecting the instrument to the full-scale pressure for at least 24 hours. During the test, the applied pressure/level is to be accurately monitored by taking reference readings either by a reference logger of high accuracy or by manual readings. The accuracy and resolution of the reference measurement must be 1 mm water column or 0.01 k Pa (0.1 mbar).

Overall Test: Part of the Overall Test is also covered under the Functional Tests and Accuracy Tests. The Overall Test comprises testson:

- autonomy
- fitness forenvironment
- functionality
- calibration
- stability
- · reproducibility, and
- main powerfailure

Details of the various tests are as follows.

**Autonomy:** Two autonomy tests shall beconducted:

- battery capacity versus the power consumption per measurement, and
- memorycapacity
- i) <u>Battery autonomy test</u>: To execute the test, the instrument is set to a fast data collection interval and the capacity, i.e. the number of samples, is established by a continuous process of data collection until the batteries are depleted. The test shall be executed on new batteries. In this context, the batteries are deemed depleted when the instrument stops functioning because the battery voltage watch-dog function detects a too low battery voltage or the normal operation of the instrumentstops.
- ii) Memory capacity verification: The memory is filled at the highest data- recording rate and the volume of collected data is verified against the bid specification. This test could be combined with the battery autonomy test and the samples are taken at a high rate to minimize the testduration.

#### Fitness forenvironment:

- iii) Connectors, cable glands, cables and housing must be suitable for the environment of operation, be it submersed, in a well or above the ground. Water ingress can be assessed by visual inspection and / or by insulation measurement. Visual inspection may only reveal ingress of a significant amount ofwater.
- iv) The insulation measurement is more sensitive, especially for cables, connectors and encapsulated electronics, but requires specialised equipment.
- v) The above-surface components have to be compatible with IP65 standard and shall be tested accordingly by exposing them to a heavy shower for 3 minutes. Subsequently the ingress of water is assessed by opening of the instrument and connectors.
- vi) The submersible components must comply with IP68 standards. To verify this, the instrument shall be suspended in a well for at least one week, to a maximum depth, without affecting the calibration of the pressure sensor and not exceeding 2 times the rated measuring range. Although most pressure sensors can withstand considerably more than 2 times the rated measuring range, there is no need to exceed this. Prior to this test, the zero and scale of the sensor have to be established and verified again upon recovery.

#### **Functionality**

- vii) Functionality has to be verified for all requirements for operation of the DWLR and DRSwith reference to the bid specifications and the instrument specifications as given by the Manufacturer. Missing functionality shall be reported.
- viii) All (software) functions as stated in the instrument manual(s) and theinstrument specifications are tested for correct functioning. Any detected flaws are reported which shall be repaired/rectified by the Manufacturer/Supplier within seven days.

### Calibration

- ix) The instrument calibration is checked for compliance with the bid specifications. In particular accuracy, stability, linearity, hysteresis and reproducibility areverified.
- x) For pressure- The scale or sensitivity of the complete instrument, including sensor and electronics, is to be checked for at least 11 pressures, equally distributed over the full measuring range. Furthermore, the calibration data as delivered with the instrument are verified for accuracy and consistency with data obtained from the calibration tests. The calibration may be executed by application of accurately known air-pressure or by immersion in a well. The temperature effects on the calibration should also be verified at low, mid and maximum rangetemperatures.
- Note: Prior to execution of immersion tests, the effective position of the sensormembranerelativetothesensorhousingistobeassessedandmeasured, e.g. by execution of a bucket experiment. In this experiment, the sensor is partly immersed in a water filled bucket to a depth where the related reading has changed by several centimetres, relative to the 'in-air' reading. During the test, the position of the water surface on the sensor's body shall be observed and marked accordingly. The 'effective-sensor-zero' lies below the water surface during the test. The position of the effective-sensor-zero is below the above mentioned water-surface mark by the equivalent of the sensor reading expressed in centimetres. The effective-sensor-zero may be close to the sensor membrane but not necessarily coincides with it.

**Stability:** Stability related to the DWLR is defined as a variation over time of the instrument specifications, whereas the circumstances (and pressure for pressure type) do not vary. Parameters to be checkedare:

- zero: offset stability/ readingstability.
- · scale: full scalestability
- cable: length (extension/contraction) and creep stability

The methods to assess these stability factors are explained under the section on Accuracy Tests.

#### Reproducibility:

**Pressure type-** The sensor reading in air is annotated, subsequently the sensor is immersed to the rated measuring depth, and a stable reading is collected. Then the sensor is recovered to the surface and again a stable reading is taken. This process is repeated 5 times and results are duly annotated. It is important that during the complete test the instrument is kept in the same, vertical position.

#### Main powerfailure:

- xi) Some instruments operate on replaceable batteries or even external power and have a built-in back-up facility, usually based on a Lithium battery. It is quite possible that on some instruments the external power supply or the replaceable batteries fail because of total depletion, disconnection, defect on the cable or connector etc. In such an event, the instrument must retain its clock, its program setting and most importantly all the collecteddata.
- xii) The Functional Tests are executed in conjunction with the stability test. Upon finalising these tests and after successful retrieval of all test data the power is disconnected by removing the main power batteries and/or disconnecting the power cable. The instrument is to be left in that state for at least 24 hours. Then the power shall be connected again and clock, program settings and recorded data are checked for availability and correctness.
- xiii) Instruments with entirely built-in factory replaceable batteries cannot be tested in this way. In such case, the Manufacturer shall provide a technical description of the method applied to avoid loss of clock, program and collected data.
- **5.** Test Execution: Two test programmes are to be executed:
  - a. All Units Test Programme
  - b. Single Unit Test Programme

Prior to execution of the tests, a detailed test script has to be drafted and agreed upon. The test script shall define:

- · Testsequence.
- the test conditions and requirements for each test.
- place of thetest.
- person(s) responsible for conducting thetests.
- Reportingrequirements.
- handling failures andproblems.

All Units Test Programme: The All Units Test Programme aims to identify the malfunctioning instruments and those not compliant with the bid specifications. The Functional Tests, the Clock Accuracy Test and the Zero Stability Test/ Reading stability test, must be executed on each instrument. The design of the tests shall be selective and practical and enable execution with simple means, preferably at the Client'spremises.

#### Single Unit TestProgramme

- i) A full system shall be tested, that is: pressure sensor electronics, cable, power supply, DRS, software and manuals. The Single Unit Test Programme is a combination of the Functional Tests, the Accuracy Tests and the Overall Test. The Client shall randomly select an instrument for testing from the instruments delivered. The Single Unit Test Programme can only be started after verification that all documents related to the order/delivery, including manuals, calibration data, QA data etc., are delivered to the Client. Any other unit, for which doubts arise on its compliance with the bid specifications, shall also be tested on the client'srequest.
- ii) Failing to pass the Single Unit Test Programme results in rejection of the entire delivery until the defective units have been repaired to meet the technical specifications, and such to the satisfaction of the Client.

#### 6. Evaluation of testresults:

The test results have to be evaluated and results and conclusion shall be reported. Instruments that do not meet the bid specifications shall be replaced by properly functioning and satisfactorily tested instruments.

### 7. Post acceptance performancemonitoring

- i) After installation and field deployment the instrument performance shall be continuously monitored by taking manual observations, initially at a relatively high rate, e.g. every 3 hours, gradually migrating towards the normal monitoring interval. The level comparisons are required for reference and validation purposes. Manual observations and automatic readings shall be taken at short intervals after each other, in practice the time difference shall be kept to less than 15 minutes. The primary criterion though, is that the manual reading shall be taken before the water level changes more than 1mm.
- ii) Other checks are on functioning of the internal clock, data recording and retrieval, battery discharge, siltation of the sensor, moisture ingress and any development of corrosion.
- iii) The tape used for taking the reference readings shall be of high accuracy, considerably better than the accuracy of the DWLR, only then the performance of the high accuracy instruments can be monitored. However, an accuracy of 1 mm over the full measuring range is enough. Only best quality tapes, e.g. the electric types, come close to this requirement. The tapes shall be checked for accuracy against a precise reference, e.g. over 10 or 20 m on a single stretch. Verification by a standard ruler will not reveal to overall accuracy of a tape. The 'tape verification reference' could be prepared using high accuracy geodetic equipment. A long, straight corridor, or a quiet stretch of road, could accommodate the length reference marks, the accuracy should be 1 mm relative to the reference point (0.000m).

### 8. Instrument HistoryFile

For each instrument, an individual History File shall be opened and maintained (The Instrument history file shall be suppliers' scope.). In the History File the full instrument history and all documents generated shall be stored. This also includes any changes, adaptations, repairs etc. made to the instruments. The products and results of the execution of the Acceptance Protocol shall be included in the Instrument History File. Some document types and entries are listedbelow:

### 9. Instrument identification: The instrument identification uniquely defines the instrument particulars.

- Make, vendor, service provider, date of manufacturing, date ofdelivery
- Instrument make, model and serialnumber
- Instrumentconfiguration
- Measuringrange
- Cable type,length

- Manualversion
- Instrument status: e.g. working, under calibration, underrepair
- **10. Functional, Accuracy and Over-all tests:** For each of the three test categories, a separate and unambiguous record shall be maintained. The test conditions and results shall be duly recorded. Obviously any failures or irregularities shall be annotated accurately and comprehensively, as well as the actions taken and their results. At least the following data shall be recorded:
  - Administrative data: what, when, where, who, which instrument and configuration
  - List oftests
  - Specifications for eachtest
  - · Results of eachtest
  - Failures, actions, conclusions
- 11. Piezometer well definition: The piezometer well definition is required in order to link the instrument readings to MSL and the hydro-geological properties of the well. The piezometer identification shall have sufficient detail to link it with the hydro-geological data recorded in the project database. The reference point on the piezometer well, as used for the level measurements, shall be unambiguously depicted and its height above MSL defined. The particulars of the local benchmark (name, location, and co-ordinates, height above MSL, etc.) shall be recorded for reference purposes. Following entries are indicative and notconclusive.
  - Piezometer: District, name, location, co-ordinates, identification
  - Photo
  - Elevation relative toMSL
  - Description of reference point particulars
  - Identification of reference spot on piezometerwell
  - Local benchmark: district, location, identification, co-ordinates, height above MSL

**Deployment:** Another part of the history file covers the deployment: installation, servicing, maintenance, data retrieval etc. All facts shall be recorded, (what, when, where, who, which instrument and configuration). The suspended depth of the instrument relative to the reference point shall be annotated. Further, manual water level observations (when, who, level, reference) shall be taken regularly and verified with the instrument records. To allow for an accurate comparison, the time and other particulars of the manual observation shall be recorded. The manual observations shall coincide with the programmed automaticinstrument readings. This shall be regularly repeated. Photos showing the mode of installation are very useful.

- i) Some of the required particularsare:
  - Suspension depth relative to the reference point on the piezometerwell
  - Recordinginterval
  - Photos of the deployed instrument and piezometer well Following two shall berepeated regularly
  - Manual observations, taken concurrently with the automaticmeasurements
  - · Observer, date and time of manualreading
- ii)The following entries are associated with any changes made to the instruments. Again, the 'what, when, where, who, which instrument and configuration' shall be recorded, for eachevent:

- Repairs: minor and major repairs and including change of silt filter or battery etc.
- Adaptations: e.g. replacement of EPROM, RTC clock speedadjustment
- Settings: these are the common operational settings such as recording interval, suspension depth and the like.
- Calibration: most likely calibration is executed in a special workshop. Obviously, calibration is a major event and has to be recorded and documented accurately and comprehensively. This implies also the method of calibration, reference instruments used (and including a paper trail to national standards or other proof of calibration cum accuracy), conditions during calibration, officers in charge etc.

### 12. Acceptance Certificates:

On successful completion of acceptability test, receipt of deliverables etc., and after the purchaser is satisfied with the working of the <u>DWLR</u> system, the acceptance certificate signed by the supplier and the representative of the purchaser will be issued. The date on which such certificate is signed shall be deemed to be the date of successful commissioning of thesystems.

AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as "Integrity Pact" or "Pact"), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.			

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnessesas under:

## Article 1: Commitment of the Purchaser/Owner

- 1) The Purchaser/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:
  - (a) No employee of the Purchaser/Owner, personally or through any of his/her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
  - (b) The Purchaser/Owner will, during the Tender process, treat all Bidder(s) with equity and reason. The Purchaser/Owner will, in particular, before and during the Tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential / additional information through which the Bidder(s) could obtain an advantage in relation to the Tender process or the Contract execution.
  - (c) The Purchaser/Owner shall endeavour to exclude from the Tender process any person, whose conduct in the past has been of biased nature.
- 2) If the Purchaser/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Purchaser/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

#### Article 2: Commitment of the Bidder(s)/Contractor(s)

- 1) It is required that each Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of fraud or corruption or Coercion or Collusion of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2) The Bidder(s)/Contractor(s) commits himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:
  - a) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Purchaser/Owner's employees involved in the Tender process or execution of the Contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the Tender process or during the execution of the Contract.
  - b) The Bidder(s)/Contractor(s) will not enter with other Bidder(s) into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to cartelize in the bidding process.
  - c) The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s)/Contract(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the

Purchaser/Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.

- d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the names and addresses of agents/representatives in India, if any. Similarly Bidder(s)/Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.
- e) The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.

- 5) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/ her reputation or property to influence their participation in the tendering process).

## **Article 3: Consequences of Breach**

- 1) If the Bidder(s)/Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Purchaser/Owner after giving 14 days notice to the contractor shall have powers to disqualify the Bidder(s)/Contractor(s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Purchaser/Owner. Such exclusion may be forever or for a limited period as decided by the Purchaser/Owner.
- 2) Forfeiture of EMD/Performance Guarantee/Security Deposit: If the Purchaser/Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated/determined the Contract or has accrued the right to terminate/determine the

Contract according to Article 3(1), the Purchaser/Owner apart from exercising any legal rights that may have accrued to the Purchaser/Owner, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder/Contractor.

3) Criminal Liability: If the Purchaser/Owner obtains knowledge of conduct of a Bidder or Contractor, or of an employee or a representative or an associate of a Bidder or Contractor which constitutes corruption within the meaning of IPC Act, or if the Purchaser/Owner has substantive suspicion in this regard, the Purchaser/Owner will inform the same to law enforcing agencies for further investigation.

- (i) In case of a JV/ consortium, certified copy of the agreement between various partners shall be submitted with the tender.
- (ii) The JV/ consortium will identify a lead partner who will be authorised to execute the contract with the department. All financial transactions and liabilities shall rest with the lead partner.
- (iii) In the case of a JV or Consortium, all members of the group shall be jointly and severally liable for the performance of whole contract.
- (iv) A tenderer shall submit only one bid in the same tendering process, either individually as a tenderer or as a partner of JV/Consortia.
- (v) The consortium /Joint Venture shall nominate a Representative who shall have the authority to conduct all business for and on behalf of any and all the members of the JV during the bidding process and, in the event the JV is awarded the Contract, during contract execution.
- (vi) Number of the members/firms in a joint venture shall not be more than two including the lead partner
- (vii) The lead partner of the Joint Venture/Consortium shall have experience in drilling where construction of groundwater well as component of scope of work and other party shall be manufacturer of DWLRs.
- (viii) JV members are jointly and severally responsible and liable for the contract. For pre- qualification, the JV should fulfil the criteria specified in the pre-qualification document. The attributes to be evaluated will be the same as for individual contractors; however, certain parameters up to the specified limits have to be essentially met by them collectively, some by the lead partner, and some by the other partner, as briefly described below:
- I. Qualifying factors for lead partner:
- (A) Not less than of 50 (fifty) percent of the respective limits of above criteria prescribed in case of individual contractors may be accepted;
- II. Qualifying factors for other partner: Same as for lead partner except that for the factors specified in (II) above, a lower limit of 25 (twenty-five) per cent.
- (ix) A tenderer shall submit only one bid in the same tendering process, either individually as a tenderer or as a partner of a consortium /Joint Venture.
- (x) Number of the members/firms in a joint venture shall not be more than Two including the lead partner

- 1.2.5 Average annual turnover of bidder from similar work should be at least 50% of the estimated cost of work during the immediate last 3 (Three) consecutive financial years ending 31st March, 2024 and duly certified by Chartered Accountant. Any such certificate must carry the UDIN (Unique Document Identification Number). Year in which no turnover is shown would also be considered for working out the average. Calculated by applying an appropriate multiplier to the projected annual construction expenditure on the subject contract.
- 1.2.6 The bidder must have experience of having successfully completed similar works during last seven (7) years ending last day of month previous to the one in which applications are invited should be either of the following:
- (a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost each.

or.

(b) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost each.

or,

(c) One similar completed work costing not less than the amount equal to 80% of the estimated cost each.

The value of the executed work shall be brought to the current costing level by enhancing the actual value of works at simple rate of 7% per annum, calculated from the date of completion to the date of Bid opening.

"Certificate for 'substantial completion' of project/work/asset should contain two parts. Part -I shall contain 'financial value of work done' and part-II shall contain 'certificate of functional completion of project/work/asset'."

Equipment and Managerial Capability:

- a) Ownership/ proposals for the timely acquisition (own, lease, hire, etc.) of the essential equipment listed in the BDS;
- a Contract Manager with five years' experience in Services of an equivalent nature and volume, including no less than three years as Manager;

Similar Nature of Work: "Drilling, Construction of Monitoring/Piezometer Wells for Groundwater Monitoring and DWLR Installations, executed for any Central Govt. / State Govt. / PSUs / Other Govt. Departments".

- 1.2.7 The bidder should not have incurred any loss (profit after tax should be positive) in more than two year during available last five consecutive balance sheets, duly certified and audited by the chartered accountant. Yearly Turnover and audited balance sheet for last 5 years ending the financial year 2023-24 duly certified by chartered accountant should be submitted. Any such ceritificate must carry the UDIN (Unique document identification number).
- 1.2.9 The bidder shall have sufficient construction equipments and manpower to carry out the works and shall submit details of such

machinery, which he propose to deploy as per format enclosed.

The bidder must ensure to deploy required equipment as proposed in the format within the mobilization period till the completion of the project, otherwise WAPCOS shall be free to terminate the work due to non-mobilization of equipment as committed in the tender without any notice. In case bidder submit details of machinery hired or taken on lease, then bidder shall obtain affidavits on stamp paper verified by notary from owner of the machinery and shall submit the same along with the bid. Ownership record of the machinery such as copy of registration certificate, purchase memo etc. shall also be submitted.

(Note: Minimum Man power and Machinery as stated above should be arranged by the bidder separately and bidder can deploy manpower and machineries as per site requirement)

The bidder must submit details of equipments as per Form B along with documentary proof. If bidder failed to deploy equipments/machineries within mobilisation period as mentioned in the tender documents, WAPCOS is free to cancel the project & forfeit the Bank Guarantee and blacklist the bidder.

Bidder has to submit an undertaking to deploy the above machineries for which he participated in the bidding process.

1.2.10 Bidder must not be black listed or debarred by any Government organization.

Bidder should disclose their litigation history, if any. Both documents should be supported with an affidavit duly certified by notary.

- 1.2.11 A Bidder shall not have a conflict of interest. Any Bidder found to have a conflict of interest shall be disqualified. A Bidder may be considered to have a conflict of interest for the purpose of this bidding process, if the Bidder:
  - i. directly or indirectly controls, is controlled by or is under common control with another Bidder; or
  - ii. receives or has received any direct or indirect subsidy from any other Bidder; or
  - iii. has the same legal representative as another Bidder; or
  - iv. has a relationship with another Bidder, directly or through common third parties, that puts it in a position to influence the bid of another Bidder, or influence the decisions of the Purchaser regarding this bidding process; or
  - v. participates in more than one bid in this bidding process. Participation by a Bidder in more than one Bid will result in the disqualification of all Bids in which such Bidder is involved. However, this does not limit the inclusion of the same subcontractor in more than one bid

- 1.2.12 Specific Construction Experience in Soft/Alluvial/Hard Formation/DWLR:
  - Must have previously drilled groundwater-monitoring/piezometer wells up to a minimum depth of 75m. Number of wells should not be less than 10% of proposed number of monitoring wells to be constructed under this contract. The bidder must have supplied, installed & commissioned Digital Water Level Recorders in the constructed monitoring/piezometer wells.
- 1.2.13 The bidder must submit an undertaking for carrying out chemical analysis of water samples from any NABL accredited lab/labs. The Lab/labs shall have combined capacity of analyzing at least 300 water samples in a month.
- 1.2.14 For componet of supply, installation and commissioning of Digital Water Level Recorder, Bidder may associate with original manufacturer or authorized agent of original manufacturer. In case of authorized agent, an authorization letter from original manufacturer shall be submitted along with bid.
- 1.2.15 The so associated original manufacturer or authorized agent should have minimum 03 years overall experience for supply, installation, commissioning, and maintenance of Digital Water Level Recorder. Experience certificate certified an officer not below the 1st class officer or equivalent shall be submitted with the bid.
- 1.2.16 The bidder should possess the bidding capacity as calculated by the specified formula. The formula generally used is:

Available bid capacity =  $A \times M \times N - B$ , where

- A = Maximum value of engineering (relevant to similar work being procured) works executed in any one year during the last five years (updated at the current price level), taking into account the completed as well as works in progress.
- M = Multiplier Factor (usually 1.5)
- N = Number of years prescribed for completion of the work in question.
- B = Value (updated at the current price level) of the existing commitments and ongoing works to be completed in the next 'N' years.
- 1.2.17 Bidder should have a solvency equal to 40% of estimated cost. The bidder must submitted original Solvency certificate to WAPCOS office before due date. Bidder must provide the name, designation, power of attorney with valid official email id and contact number of issuing Bank Authority of solvency certificate. Solvency Certificate must have been issued after the date of publication of NIT & be addressed to the tendering authority quoting the name of the work. The Solvency Certificate should not be dated beyond the last date of submission of the bids.
