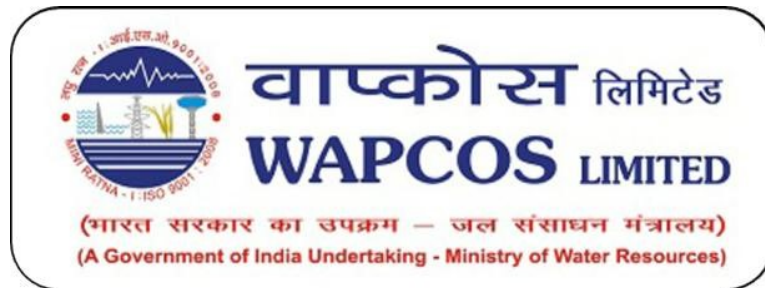

1. मार्ग खोलने हेतु जे0सी0बी0 द्वारा किए गए कार्य की मात्राएं मानसून पर निर्भर है जिस का पूर्वानुमान नहीं लगाया जा सकता इन मात्राओं में कितनी भी भिन्नता हो सकती है। मात्रा कम होने पर कार्य पूर्ण नहीं माना जाएगा। विभिन्नता हेतु ठेकेदार का किसी भी प्रकार का कोई भी दावा मान्य नहीं होगा।

SECTION-1: INSTRUCTIONS TO BIDDERS

1.0 Online Quotations are hereby invited by Executive Director (Civil Design), WAPCOS Limited, Gurugram, Haryana on behalf of Uttarakhand Rural Road Development Agency (URRDA) (hereinafter referred to as “Employer”) from reputed and experienced firms/contractor registered in Class-D and above in PWD or equivalent department (hereinafter referred to as “Bidder”) for **Emergency Maintenance of Roads including Slip Clearance and Construction of Protection Works under PMGSY in Uttarakhand damaged during Monsoon Period (Jun-September) for Year 2024-25**” in Almora, Bageshwar, Mori and Tehri Districts as mentioned in the NIT. Any kind of JV / Consortium is not allowed for this work.

2.0 Bid Validity

The offer(s) shall be valid for a period of 45 (Forty five days) from the date of opening the tender. Conditional bids shall be rejected.

3.0 Scope of Work

The Scope of work includes clearance of Slip on road and Construction of Protection Works (Breast wall and Retaining Wall) as specified in the drawing and estimate and instructed by PIU In-charge suitable as per site conditions. Rates shall be quoted by the interested bidder in the prescribed format of BOQ only including all construction and labour charges for execution of the work at site. Quantities included in the BOQ are tentative and shall be executed as and when required in case of emergency only. Payment shall be made to the contractor only on the basis of actual execution/measurements of work at site. Running bill shall be made as per actual progress of work at site. All Payments shall be made to contractor on Back-to-Back basis only on availability of funds/Receiving from the client.

4.0 Essential Qualification Criteria

- a. Bidders must be registered in Class-D and above category with the PWD or equivalent department. Registration Certificate shall be provided by the bidder along with his Bid.
- b. Bidder must have the proof of ownership like RC etc. of the JCB Machine / Excavator (as per condition mentioned in NIT) to be engaged for the mentioned work. All relevant documents in support with shall be provided by the bidder in his Bid.
- c. Bidder must have experience of Construction of Protection Works with-in last 5Years. In proof, Work Order and Completion Certificate shall be submitted by the bidder in his bid.
- d. Bidder must have valid PAN and GST registration number.

5.0 Bid Document Fee and Earnest Money Deposit

The bidders are requested to submit **Earnest Money Deposit (EMD) in the form of FDR** and **Bid Fee in the form of DD** issued from any nationalized / commercial bank with his bid for the amount mentioned in the NIT against the road work in the name of **WAPCOS Limited**. EMD must be submitted by the bidder along with his bid, failing which his bid shall out rightly be rejected.

6.0 Submission of Bid

Bids shall be submitted online on PMGSY Tendering Portal <https://www.pmgsytendersuk.gov.in>. Technical and Financial Bids shall be submitted online up to the specified last date and time of bid submission.

The bidder shall submit the bid in two separate part online, Part-I, marked as Technical Bid and Part-II, marked as Financial Bid. All the documents provided with Technical Bid are required to be counter signed by the bidder.

Hard copy of the bid along with following documents shall be submitted to the PIU address mentioned in the list in the SHORT NOTICE INVITING TENDER (SNIT).

- Bid Validity on Rs. 100/- Non-Judicial Stamp Paper with Rs. 1/- revenue stamp
- Earnest Money Deposit (EMD) in the form of FDR only
- Bid fee in the form of DD (non-refundable)

Aforementioned documents are required to be submitted in original up to 1:00 PM of the specified last date of submission either by registered post/ courier service or by hand, failing which the bid will be declared as non- responsive. WAPCOS shall not be responsible for any postal delay on any account. In case date of submission happens to be holiday, then documents may be submitted on next working day up to 1:00 PM.

7.0 Technical Bid

The Technical Bid submission forms are enclosed as Schedule-A respectively.

7.1 Bidders shall submit the bid in the formats provided in the Bid Document. Bid shall includes:

1. Contractor's Registration Certificates with PWD and equivalent department in Class-D and above
2. Bidder must have valid PAN and GST Number. Copy of PAN Card copy and GST Registration shall be provided by the bidder.
3. Bid validity on Rs. 100/- non judicial stamp paper with Rs. 1.00 Revenue ticket.
4. Earnest Money Deposit (EMD) in the form of FDR and Bid Document Fee in form of DD
5. Proof of Ownership of JCB Machine / Excavator and other relevant documents (RC, Machine Insurance Paper, Driving License of Operator etc.). In case of lease, lease agreement copy shall also be provided. JCB machines shall be equipped with GPS tracking device.

6. Bidder must have experience of construction of Protection Works with-in last 5Years. In proof, Work Order and Completion Certificate shall be submitted by the bidder in his bid.
7. Counter Signed copy of this document as a token of acceptance of the Terms & Conditions
10. Any Technical Bid, if received with Financial Bid (Quoted Rates of Bidder), shall be rejected out rightly in the Technical Stage only.

7.2 WAPCOS reserves the right to verify all statements, information and documents, submitted by the Agency in the Bid. Any such verification or the lack of such verification by the WAPCOS to undertake such verification shall not relieve the Agency of its obligations or liabilities hereunder nor will it affect any rights of WAPCOS there under.

8.0 Financial Bid

8.1 The Agency should quote considering all the items as listed in the **Scope of Works**. The quoted amount shall be inclusive of all prevalent taxes in the country such as GST etc. Rates shall be quoted by the interested bidder in the prescribed format of Bill of Quantities in excel file only provided online on PMGSY Tendering Portal.

8.2 The quoted rates/amounts shall cover the costs of executing all activities defined in scope of work. The quoted rates/amounts shall cover costs of remuneration, accommodation, lodging, boarding, transportation, insurance, equipment, material, and other expenses related to the Agency's staff/manpower and the works to be executed. The Agency shall not require or demand any other reward or compensation, either in the form of currency or in other forms, from WAPCOS. All the taxes/statutory duties etc. except GST required in the place of work shall be borne by the Agency.

8.3 The quoted rates/amounts shall be deemed to be firm throughout the project till the completion of work and shall not be subject to any adjustment due to increase in price of materials, utilities, taxes, duties etc. or any other input for performance of work and the contract.

8.4 Clause removed as bid is being submitted online in PMGSY tendering portal.

9.0 Time of Completion

The time period for the work is 4 months from the Date of Start of the work. The work is type of emergency in nature. Payment shall be made on the basis of actual progress at site and after receiving the funds/approval from the client Uttarakhand Rural Roads Development Agency (URRDA).

10.0 Performance Security, Additional Performance Security & Security Deposit

Performance Security at the rate of 5% of the Contract Price shall be provided by the contractor to the employer at the time of signing of contract in the form of FDR/Performance Bank Guarantee from the nationalized or scheduled commercial banks acceptable to the employer. No Performance shall be deducted from the running bill.

Security Deposit shall remain at the rate of 5% of the Contract Price that shall be deducted from the running bill of the contractor, as per the applicable GCC GPW FORM-9 of PWD Uttarakhand. All other Terms and Conditions regarding release shall be followed as per GPW FORM-9.

Additional Performance Security as mentioned at Cl. 3.1.1.3 GCC pg. 2 GPW FORM-9 is not applicable as per WAPCOS Circular dated 10.12.2020.

11.0 Payment Terms

Payment to the contractor is totally based on the actual execution of the work at site. Payment shall be made to the contractor only after completion of work at site on back-to-back basis on receiving the same from the client Uttarakhand Rural Roads Development Agency (URRDA) depending on availability of funds and authorization thereof.

12.0 Price Escalation

No Price Escalation shall be allowed for the quoted rates of the bidder throughout the period of completion of the work.

13.0 Arbitration

13.1 Resolution of Disputes

Except where otherwise provided in the contract, all questions and disputes relating to the work or the execution or failure to execute the same whether arising during the progress of the work or after the cancellation, termination, completion or abandonment thereof shall be dealt with as mentioned hereinafter:

If the Selected Agency considers any work or any matter in connection with or arising out of the contract or carrying out of the work, to be unacceptable and is resulting in a dispute, it shall be referred to the Nodal Officer from WAPCOS who shall, within a period of thirty days after being requested by the Selected Agency to do so, give written decision to the Selected Agency. Upon receipt of the written decision of the Nodal Officer, the Selected Agency shall promptly proceed without delay to comply with such decision.

13.2 Adjudication of Disputes

Any dispute, controversy or claims arising out of or relating to this Agreement or the breach, termination or invalidity thereof, shall be settled through following mechanism :-

- a. Firstly, the aggrieved party shall write a letter to the other party detailing its grievances and calling upon the other party to amicably resolve the dispute by convening a joint meeting. Accordingly, the parties as per their convenience shall jointly convene the said meeting(s), wherein minutes of the said meeting(s) shall be prepared and countersigned by all the parties. It is mandatory to prepare minutes of meeting(s) and to be countersigned by all the parties, irrespective of the outcome of the said meeting(s).
- b. In the event the parties are unable to reach on any settlement in the said meeting(s), then the aggrieved party shall mandatory resort to pre-litigation mediation mechanism with Delhi High Court Mediation Cell, New Delhi.
- c. It is only upon failure of the pre-litigation mediation mechanism with Delhi High Court Mediation Cell, and then the aggrieved party shall resort to resolution of disputes through

arbitration of a Sole Arbitrator. The appointing authority of Sole Arbitrator is CMD, WAPCOS Limited, to which neither of the parties have any objection nor they shall ever objected.

- d. Subject to the parties agreeing otherwise, the Arbitration proceedings shall be conducted in accordance with the provisions of the Indian Arbitration and Conciliation Act, 1996 (amended as on date).
 - e. It is also acknowledged and accepted that WAPCOS is only working as Intermediary between the Associate/Sub-Consultant/ Sub-Contractor and the Client, thus in the event, any dispute arises under the present agreement and referred to Arbitration for adjudication, then subject to corresponding clause in the Contract/ Agreement/ Work Order/ Arrangement between Client & WAPCOS, Client shall also be made party to the said Arbitration proceedings. Also, the award including costs if any passed against WAPCOS and costs incurred in the proceedings shall be the sole responsibility of Principle Employer/ Client. The said clause if found inapplicable, even then the other terms of the Arbitration Clause shall survive and shall be acted upon.
 - f. The place/seat of arbitration shall be Delhi and award whether interim or final, shall be made, and shall be deemed for all purpose between the parties to be made, in Delhi. The arbitral procedure shall be conducted in English language and any award or awards shall be rendered in English. The procedural law of the arbitration shall be Indian Law. The award of the arbitrator shall be final and conclusive and binding upon the Parties.
 - g. The contract and any dispute or claim arising out of or in connection with it or its subject matter of formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the laws of India and the Parties submit to sole & exclusive jurisdiction of courts at Delhi.
- 14.0** Incomplete tenders, conditional tenders, tenders received after the stipulated time shall be summarily rejected.
- 15.0** Employer reserves the right to reject any or all bids without assigning any reason.

Conditions to withheld the amount in case of non- achievement of milestone:-

(4.1) If the work is not started by the end of the time given for the first milestone, the agreement shall be immediately finalized and the performance security shall be forfeited.

(4.2) If the work is started just before the lapse of the first milestone, but not completed by the time given for the grace period, 2.50% of the contract value shall be withheld and it shall only be refundable incase of compensating the target of the first milestone along with the second milestone within the scheduled time of second milestone.

(4.3) In the event of non achieving the necessary progress as per the second milestone additional 3.50% of the contract value shall be withheld and the total 6.0% withheld money shall only be refundable if the required progress upto second milestone is achieved alongwith the third milestone within the scheduled time of third milestone.

(4.4) In the event of non achieving the targeted progress upto the third milestone additional 4% of the contract value shall be withheld and total 10% withheld money shall only be refundable if the targeted progress upto third milestone is compensated & achieved alongwith the forth milestone i.e the whole work is completed within the bonded period.

(4.5) If the whole work upto the forth milestone is not completed within the scheduled or rescheduled time, all the withheld amount of 10% shall be recovered from the contractor from any money due to him by the Government under this contract or any other account what so ever. Otherwise the same will be recoverable as an arrear of land revenue through collector.

The time allowed for execution of the work as specified in the Schedule "A" or the extended time in accordance with these conditions shall be an essence of the Contract. The execution of work shall commence from such time period as mentioned in the contract agreement. If the Contractor commits default in commencing the execution of the work as aforesaid, government shall without prejudice to any other right or remedy available in law ,be at liberty to forfeit the amount as mentioned above.

❖ As soon as possible after the contract is concluded, the Contractor shall submit a time and progress chart for each mile stone and get it approved by the Department. The chart shall be prepared in direct relation to the time stated in the Schedule 'A' above for completion of item of the works. It shall indicate the forecast of the dates of commencement and completion of various trades of sections of the work and may be amended as necessary by agreement between the Engineer-in-charge and Contractor within the limitation of time imposed in the contract documents .

I. Force majeure , or

II. Abnormally bad weather, or
